- 2 "AN ACT TO REDUCE THE PERSONAL INCOME TAX RATE AND INCREASE THE
 3 STANDARD DEDUCTION FOR TAXPAYERS WHOSE ADJUSTED GROSS INCOME
 4 IS UP TO TWO HUNDRED THOUSAND DOLLARS (\$200,000); TO EXPAND AND
 5 INCREASE THE CHILD TAX DEDUCTION; AND TO ADOPT MARKET-BASED
 6 SOURCING FOR BUSINESS TAX APPORTIONMENT.";

8 And on page 1, line 12 through page 1, line 15:

9 "'(a) Tax. – A tax is imposed for each taxable year on the North Carolina taxable income 10 of every individual. The tax shall be levied, collected, and paid annually. The tax is five and 11 four hundred ninety-nine thousandths percent (5.499%) of the taxpayer's North Carolina 12 taxable income for taxpayers whose adjusted gross income is over two hundred thousand 13 dollars (\$200,000). The tax is five and thirty-five hundredths percent (5.35%) of the taxpayer's 14 North Carolina taxable income.income for taxpayers whose adjusted gross income is up to two 15 hundred thousand dollars (\$200,000).";

17 And on page 1, lines 23-31, by rewriting the lines to read:

18 "(1) Standard deduction amount. - The standard deduction amount is zero for a
19 person who is not eligible for a standard deduction under section 63 of the
20 Code. For all other taxpayers, the standard deduction amount is equal to the
21 amount listed in the table below based on the taxpayer's <u>adjusted gross</u>
