16 **"PART IV. IMPROVE RURAL HEALTH OUTCOMES BY EXPANDING MEDICAID**
17 **SECTION 6.(a)** Section 3 of S.L. 2013-5 is repealed.
18 **SECTION 6.(b)** Section 11H.1(b) of S.L. 2017-57 reads as rewritten:
19 **"SECTION 11H.1.(b)** For the following Medicaid eligibility classifications for which the
20 federal poverty guidelines are used as income limits for eligibility determinations, the income
21 limits will be updated each April 1 immediately following publication of federal poverty
22 guidelines. The Department of Health and Human Services, Division of Medical Assistance, shall
23 provide Medicaid coverage to the following:

24 ...
25 (6) All people who have incomes equal to or less than one hundred thirty-three
26 percent (133%) of the federal poverty guidelines, effective July 1, 2019.

27 The Department of Health and Human Services, Division of Medical Assistance, shall also
28 provide family planning services to men and women of childbearing age with family incomes
29 equal to or less than one hundred ninety-five percent (195%) of the federal poverty guidelines
30 and without regard to resources."
