(Public) Sponsors: Referred to: March 11, 2019 A BILL TO BE ENTITLED 1 2 AN ACT TO PROHIBIT LOCAL REGULATION OF THE SIZE OR HEIGHT OF CERTAIN 3 NONCOMMERCIAL SIGNS PLACED OUTSIDE OF THE RIGHT-OF-WAY ON 4 PRIVATE PROPERTY WITH THE PERMISSION OF THE PROPERTY OWNER. 5 The General Assembly of North Carolina enacts: 6 SECTION 1. Article 6 of Chapter 153A of the General Statutes is amended by 7 adding a new section to read: 8 "§ 153A-145.8. Limitation on regulation of political signs. Notwithstanding any provision of this Article or any other provision of law, no county shall 9 10 adopt or continue in effect an ordinance prohibiting or regulating the size or height of a 11 noncommercial sign, including a political sign as defined in G.S. 136-32(c), that does not exceed 12 64 square feet in size or 6 feet in height, and that is placed on private property with the permission 13 of the owner of the property and outside of any right-of-way of a State highway." 14 SECTION 2. Article 18 of Chapter 153A of the General Statutes is amended by 15 adding a new section to read: 16 "§ 153A-379. Limitation on regulation of political signs. Notwithstanding any provision of this Article or any other provision of law, no county shall 17 18 adopt or continue in effect an ordinance prohibiting or regulating the size or height of a noncommercial sign, including a political sign as defined in G.S. 136-32(c), that does not exceed 19 20 64 square feet in size or 6 feet in height, and that is placed on private property with the permission 21 of the owner of the property and outside of any right-of-way of a State highway." SECTION 3. Article 8 of Chapter 160A of the General Statutes is amended by 22 23 adding a new section to read: 24 "§ 160A-205.4. Limitation on regulation of political signs. Notwithstanding any provision of this Article or any other provision of law, no municipality 25 shall adopt or continue in effect an ordinance prohibiting or regulating the size or height of a 26 noncommercial sign, including a political sign as defined in G.S. 136-32(c), that does not exceed 27 64 square feet in size or 6 feet in height, and that is placed on private property with the permission 28 29 of the owner of the property and outside of any right-of-way of a State highway or municipal 30 street." 31 **SECTION 4.** Article 19 of Chapter 160A of the General Statutes is amended by 32 adding a new section to read: 33 "§ 160A-367. Limitation on regulation of political signs. Notwithstanding any provision of this Article or any other provision of law, no municipality 34 shall adopt or continue in effect an ordinance prohibiting or regulating the size or height of a 35 noncommercial sign, including a political sign as defined in G.S. 136-32(c), that does not exceed 36
