HOUSE BILL DRH30296-NB-142

Short Title: Physician Asst/Nurse Practit./STOP Act Clar. (Public)

2 AN ACT TO MAKE CLARIFICATIONS REGARDING THE CONDITIONS IN WHICH A
3 PHYSICIAN ASSISTANT OR NURSE PRACTITIONER MUST CONSULT WITH A
4 SUPERVISING PHYSICIAN PRIOR TO PRESCRIBING A TARGETED CONTROLLED
5 SUBSTANCE.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.(a)** G.S. 90-18.1 reads as rewritten:

8 "**§ 90-18.1. Limitations on physician assistants.**

9 ...

10 (b) Physician assistants are authorized to write prescriptions for drugs under the
11 following conditions:

12 (1) The North Carolina Medical Board has adopted regulations governing the
13 approval of individual physician assistants to write prescriptions with such
14 limitations as the Board may determine to be in the best interest of patient
15 health and safety.

16 (2) The physician assistant holds a current license issued by the Board.

17 ...

18 (4) The supervising physician has provided to the physician assistant written
19 instructions about indications and contraindications for prescribing drugs and
20 a written policy for periodic review by the physician of the drugs prescribed.

21 (5) A physician assistant shall personally consult with the supervising physician
22 prior to prescribing a targeted controlled substance as defined in Article 5 of
23 this Chapter when all of the following conditions apply:

24 a. The patient is being treated by a facility that primarily engages in the
25 treatment of pain by prescribing narcotic ~~medications or advertises in~~
26 ~~any medium for any type of pain management services.~~ medications.

27 b. The therapeutic use of the targeted controlled substance will or is
28 expected to exceed a period of 30 days.

30 **SECTION 1.(b)** G.S. 90-18.2 reads as rewritten:

31 "**§ 90-18.2. Limitations on nurse practitioners.**

32 ...

33 (b) Nurse practitioners are authorized to write prescriptions for drugs under all of the
34 following conditions:

35 (1) The North Carolina Medical Board and Board of Nursing have adopted
36 regulations developed by a joint subcommittee governing the approval of



- 1 individual nurse practitioners to write prescriptions with such limitations as
2 the boards may determine to be in the best interest of patient health and safety.
3 (2) The nurse practitioner has current approval from the boards.
4 ...
5 (4) The supervising physician has provided to the nurse practitioner written
6 instructions about indications and contraindications for prescribing drugs and
7 a written policy for periodic review by the physician of the drugs prescribed.
8 (5) A nurse practitioner shall personally consult with the supervising physician
9 prior to prescribing a targeted controlled substance as defined in Article 5 of
10 this Chapter when all of the following conditions apply:
11 a. The patient is being treated by a facility that primarily engages in the
12 treatment of pain by prescribing narcotic ~~medications or advertises in~~
13 ~~any medium for any type of pain management services.~~ medications.

15 **SECTION 2.** This act becomes effective October 1, 2021.
