1 A BILL TO BE ENTITLED  
2 AN ACT TO ALLOW REMOTE ELECTRONIC NOTARIZATION.  
3 The General Assembly of North Carolina enacts:

4 **SECTION 1.** Article 2 of Chapter 10B of the General Statutes is amended by adding  
5 a new Part to read:

6 "Part 4A. Remote Electronic Notarization.

7 "§ 10B-134. Reserved for future codification purposes.

8 "§ 10B-134.1. Definitions.

9 In addition to the definitions provided in this Article, the following definitions shall apply in  
10 this Part:

- 11 (1) Communication technology. – An electronic device, process, or system that  
12 allows a remote electronic notary and a remotely located principal to  
13 communicate with each other simultaneously by sight and sound using  
14 audiovisual technology and that makes reasonable accommodations for  
15 remotely located principals with vision, hearing, or speech impairments.  
16 (2) Communication technology recording. – The simultaneous, synchronous  
17 audio and visual recording of the notarial act.  
18 (3) Credential analysis. – A process or service through which a third-party vendor  
19 performs a remote analysis of the characteristics and security features of each  
20 identification of the remotely located principal pursuant to G.S. 10B-3(22)a.  
21 (4) Electronic journal. – A secure record of remote electronic notarial acts that  
22 contains the information required under G.S. 10B-134.15.  
23 (5) Identity proofing. – A process or service through which a third-party vendor  
24 affirms the identity of a remotely located principal through review of personal  
25 information from public or proprietary data sources.  
26 (6) Platform. – The online platform utilizing the communication technology to  
27 perform the remote electronic notarial act.  
28 (7) Remote electronic notarial certificate. – The portion of a notarized electronic  
29 document that is completed by the remote electronic notary and contains all  
30 of the following:  
31 a. The remote electronic notary's electronic signature and the remote  
32 electronic notary's electronic seal.

- 1                    b. The facts attested to by the remote electronic notary in a particular  
2                    notarization.
- 3                    c. A statement in the acknowledgement, jurat, or verification certificate  
4                    identifying where the remotely located principal was physically  
5                    located at the time of the remote electronic notarization.
- 6                    d. A statement that the notarization is a remote electronic notarization  
7                    performed using communication technology by a remote electronic  
8                    notary.
- 9                    (8) Remote electronic notarization or remote electronic notarial act. – A notarial  
10                   act performed by means of communication technology.
- 11                   (9) Remote electronic notary public or remote electronic notary. – A notary public  
12                   who is registered with the Secretary to perform remote electronic  
13                   notarizations.
- 14                   (10) Remotely located principal. – A principal who is not in the physical presence  
15                   of the remote electronic notary and who is located at the time of the remote  
16                   electronic notarial act in any of the following places:
- 17                   a. Inside the United States.
- 18                   b. Outside the United States and physically on the military installation or  
19                   vessel named in the military orders assigning the member to active  
20                   duty for more than 120 days, provided the remotely located principal  
21                   is a member, spouse of a member, or dependent of a member of the  
22                   Armed Forces of the United States.
- 23                   c. Outside the United States at any of the following locations:
- 24                   1. United States Embassy.
- 25                   2. United States Consulate.
- 26                   3. United States Diplomatic Mission.
- 27                   (11) Tamper-evident. – Any change, interference, or alteration to a record that is  
28                   patently plain and obvious.
- 29                   (12) Third-party vendor. – Any person providing credential analysis, identity  
30                   proofing, or custodial services to remote electronic notaries.
- 31                   **"§ 10B-134.2. Reserved for future codification purposes.**
- 32                   **"§ 10B-134.3. Types of remote electronic notarial acts; prohibitions.**
- 33                   (a) Upon registration with the Secretary under this Article, a remote electronic notary  
34                   may perform any of the notarial acts listed in G.S. 10B-115 by means of communication  
35                   technology in accordance with this Part. A remote electronic notary may perform any authorized  
36                   remote notarial act with respect to electronic documents.
- 37                   (b) A remote electronic notary shall not perform a remote electronic notarial act if any of  
38                   the following applies:
- 39                   (1) The remotely located principal's identity cannot be verified under  
40                   G.S. 10B-134.11.
- 41                   (2) Any reason set forth in G.S. 10B-20.
- 42                   (3) Any reason set forth in G.S. 10B-134.9.
- 43                   (c) Notwithstanding subsection (a) of this section, a remote electronic notary shall not  
44                   perform any remote electronic notarial act with regard to any of the following documents:
- 45                   (1) A self-proved will executed pursuant to Article 4A of Chapter 31 of the  
46                   General Statutes.
- 47                   (2) A revocable or irrevocable trust or any other document amending the same  
48                   except for a certification of trust or similar document.
- 49                   (3) A death beneficiary form that requires an acknowledgment.
- 50                   (4) A codicil to a will.

1           (5)    Any document related to the relinquishment of parental rights under Article 3  
2               of Chapter 48 of the General Statutes.

3           (6)    Mail-in absentee ballots issued under Article 20 of Chapter 163 of the General  
4               Statutes.

5           (d)    The prohibitions in subsection (c) of this section shall not apply when, at the time the  
6               remote electronic notarial act is performed, the remotely located principal meets the description  
7               in G.S. 10B-134.1(10)b.

8           (e)    No remotely notarized power of attorney may be used by the attorney-in-fact with  
9               any other remotely notarized document to convey title to, or transfer any interest in, a remotely  
10              located principal's real property. A power of attorney executed by a remotely located principal  
11              under this Part shall be recorded in at least one county register of deeds office in this State. This  
12              subsection does not apply to powers of attorney executed by a remotely located principal  
13              described in G.S. 10B-134.1(10)b.

14    "**§ 10B-134.4.** Reserved for future codification purposes.

15    "**§ 10B-134.5. Use of communication technology.**

16           (a)    The communication technology used by a remote electronic notary to perform remote  
17               electronic notarial acts for remotely located principals shall comply with all of the following  
18               requirements:

19               (1)    Host the meeting between the remote electronic notary and the remotely  
20                      located principal in real time.

21               (2)    Allow direct interaction between the remotely located principal seeking the  
22                      remote electronic notary's services and the remote electronic notary so that  
23                      each can communicate simultaneously by sight and sound through  
24                      communication technology.

25               (3)    Include audio with sound clear enough that each participant in the remote  
26                      electronic notarial act can hear and understand all other participants.

27               (4)    Have sufficient video quality to allow a clear and unobstructed visual  
28                      observation of the face of each participant and any identification provided by  
29                      the remotely located principal for a sufficient time to allow the remote  
30                      electronic notary to verify the remotely located principal's identity under  
31                      G.S. 10B-134.11. The remote electronic notary shall determine if the time is  
32                      sufficient.

33               (5)    Not include prerecorded video or audio or both.

34               (6)    Be capable of recording using the communication technology's recording and  
35                      storage services.

36               (7)    Be capable of geolocating the remotely located principal to corroborate the  
37                      location of the remotely located principal.

38           (b)    The remote electronic notary shall take reasonable steps to provide that the  
39               communication technology used in a remote electronic notarization is secure from unauthorized  
40               interception. A remote electronic notary shall select one or more tamper-evident technologies to  
41               perform remote electronic notarial acts with respect to electronic documents. In addition to any  
42               requirements of this Article or established by the Secretary, the communication technology shall  
43               provide automated backup of the communication technology recording.

44           (c)    No person may require a remote electronic notary to perform any remote electronic  
45               notarial act using communication technology that the remote electronic notary has not selected.

46    "**§ 10B-134.6.** Reserved for future codification purposes.

47    "**§ 10B-134.7. Authority to perform remote electronic notarial acts.**

48           (a)    A remote electronic notary may perform a remote electronic notarial act authorized  
49               under this Part only while the remote electronic notary is physically located in this State.

50           (b)    A remote electronic notarization performed by a remote electronic notary of this State  
51               under this Part is governed by the laws of this State.

1 "§ 10B-134.8. Reserved for future codification purposes.

2 "§ 10B-134.9. Requirements and procedures for remote electronic notarial acts.

3 (a) All of the following shall occur prior to the performance of a remote electronic  
4 notarial act:

5 (1) The remote electronic notary shall inform the participants that North Carolina  
6 law requires that a communication technology recording be made of the  
7 remote electronic notarization.

8 (2) The remote electronic notary shall require the remotely located principal to  
9 demonstrate, to the satisfaction of the remote electronic notary, that the  
10 remotely located principal is not under duress and is not otherwise being  
11 coerced to complete the transaction.

12 (3) The remote electronic notary shall verify the identity of the remotely located  
13 principal as provided in G.S. 10B-134.11.

14 (4) The remote electronic notary shall ask the remotely located principal if the  
15 remotely located principal would like an attorney to participate in the remote  
16 notarization, and allow for such if so requested.

17 (5) The remotely located principal shall verbally state what documents are being  
18 signed for the notarial record or describe the general nature of the transaction.

19 (6) The location of the remotely located principal shall be verified by geolocation  
20 via communication technology.

21 (b) In addition to the prohibitions contained in G.S. 10B-134.3 and G.S. 10B-20, a remote  
22 electronic notary shall refuse to perform a remote electronic notarial act if any of the following  
23 applies:

24 (1) The remote electronic notary has reasonable grounds to believe the remotely  
25 located principal is acting under duress or is being coerced into completing  
26 the transaction.

27 (2) The remote electronic notary becomes aware that the communication  
28 technology is not secure.

29 (3) The electronic signature of the remotely located principal cannot be attached  
30 to the electronic document for signature.

31 (4) Unless an oath is being administered, the remote electronic notary's electronic  
32 notarial certificate and seal cannot be attached to the electronic document  
33 using an electronic technology that renders any subsequent change or  
34 modification to the document evident.

35 (c) Except as provided in subsection (d) of this section, if the remote electronic notarial  
36 act is an oath or affirmation, the remote electronic notary shall administer the oath or affirmation  
37 to the remotely located principal utilizing a licensed platform.

38 (d) In judicial actions or proceedings, any notary public registered with the Secretary,  
39 whether or not registered as a remote electronic notary, may administer an oath or affirmation to  
40 a witness that does not require remote electronic notarization of a record or a notarial certificate  
41 and seal when done in person, provided all of the following apply:

42 (1) The notary is physically located in this State at the time the oath or affirmation  
43 is administered to the remotely located witness.

44 (2) Communication technology is utilized. The notary shall not be required to  
45 select the medium of communication technology or to retain a communication  
46 technology recording of the performance of each remote oral oath or  
47 affirmation.

48 (3) All requirements of this Article relating to the identity proofing of the witness  
49 are satisfied.

50 (e) Any non-material failure of the remote electronic notary to comply with the  
51 requirements of the remote electronic notarization does not invalidate the notarial act or the

1 electronic record that was remotely notarized. An aggrieved person is not prevented from using  
2 failures in the remote electronic notarization process, along with other grounds, to challenge the  
3 validity or enforceability of the remote electronic notarization based on fraud, forgery,  
4 impersonation, duress, incapacity, undue influence, minority, illegality, unconscionability, or  
5 another basis not related to the remote electronic notarial act or constructive notice provided by  
6 recording of the electronic record.

7 (f) Information gained from a remotely located principal in the course of performing a  
8 remote electronic notarization shall be treated as confidential by the remote electronic notary.

9 "§ 10B-134.10. Reserved for future codification purposes.

10 "§ 10B-134.11. Verification of identity; identity proofing; credential analysis.

11 (a) Prior to the remote electronic notarial act, the remote electronic notary shall verify  
12 each remotely located principal's identity through one of the following methods:

13 (1) The remotely located principal creating the electronic signature is personally  
14 known to the remote electronic notary.

15 (2) All of the following:

16 a. Credential analysis, by a third-party vendor approved by the Secretary,  
17 of a current document issued by a federal, state, or federal or  
18 state-recognized tribal government agency bearing the photographic  
19 image of the individual's face and either the signature or a physical  
20 description of the individual.

21 b. Identity proofing by a third-party vendor approved by the Secretary.

22 c. Comparison, by the remote electronic notary, of the current document  
23 issued by a federal, state, or federal or state-recognized tribal  
24 government agency bearing the photographic image of the individual's  
25 face and either the signature or a physical description of the individual  
26 presented by the remotely located principal during credential analysis  
27 and the image of the remotely located principal via the communication  
28 technology.

29 (b) Notwithstanding subsection (a) of this section, a remote electronic notary may require  
30 the remotely located principal to provide additional information or identification credentials  
31 necessary to confirm the identity of the remotely located principal.

32 "§ 10B-134.12. Reserved for future codification purposes.

33 "§ 10B-134.13. Electronic notarization and remote electronic notarization.

34 When conducting a remote electronic notarization, the remote electronic notary shall comply  
35 with the requirements of this Chapter. Each remote electronic notarization shall include a  
36 communication technology recording. There shall be no requirement that the communication  
37 technology recording further include any transactions other than the remote electronic notarial  
38 act unless the Secretary specifies a requirement to also record interactions of those particular  
39 transactions.

40 "§ 10B-134.14. Reserved for future codification purposes.

41 "§ 10B-134.15. Electronic journal of remote electronic notarial acts.

42 (a) A remote electronic notary who performs a remote electronic notarization shall enter  
43 information about the remote electronic notarization in an electronic journal. The electronic  
44 journal shall be the exclusive property of the remote electronic notary. The remote electronic  
45 notary shall not allow another person to make entries in the electronic journal.

46 (b) The Secretary shall adopt rules specifying the content and secure storage of the  
47 electronic journal. The rules adopted by the Secretary shall comply with all of the following:

48 (1) Allow for electronic and paper mediums of the electronic journal.

49 (2) Require retention for 10 years after the remote electronic notarization.

- 1           (3) Allow a party involved in a transaction that utilizes remote electronic  
2 notarization to require additional information regarding that transaction be  
3 included in the electronic journal.
- 4           (4) Authorize a third-party vendor, including a licensed platform, to act as a  
5 depository electronic journal.
- 6           (5) Specify to whom the electronic journal shall be delivered upon resignation,  
7 revocation, or expiration of a notary commission or death or adjudication of  
8 incompetency of a remote electronic notary.

9           (c) A remote electronic notary may surrender the electronic journal to the remote  
10 electronic notary's employer upon termination of employment, but the remote electronic notary  
11 shall also keep and maintain an accurate backup copy of the journal for 10 years after the last  
12 remote electronic notarization entered into the electronic journal.

13           (d) Except as provided in subsection (c) of this section, the notary shall not surrender or  
14 destroy the electronic journal or the communication technology recordings of remote electronic  
15 notarial acts except as required by a court order or as allowed under rules adopted by the  
16 Secretary.

17 **"§ 10B-134.16.** Reserved for future codification purposes.

18 **"§ 10B-134.17. Security measures by notary; surrender of journal; etc.**

19           (a) A remote electronic notary shall comply with all of the following security  
20 requirements:

- 21           (1) All records of journal entries and communication technology recordings shall  
22 be securely stored in a repository under the control of the remote electronic  
23 notary or with a steward duly appointed under the terms of this Part. If a  
24 steward is appointed, the steward shall be a third-party vendor approved by  
25 the Secretary.
- 26           (2) Take reasonable steps to ensure that the communication technology  
27 recordings are secure from unauthorized interception during transmission  
28 between participants involved in a remote electronic notarial act. The  
29 communication technology used by the remote electronic notary shall employ  
30 data protection safeguards consistent with generally accepted information  
31 security standards.

32           (b) Within 10 calendar days of discovering any permanent loss of data, unauthorized use,  
33 loss of use, or compromise of security of the electronic journal or the communication technology  
34 recordings of remote electronic notarial acts, the remote electronic notary shall do both of the  
35 following:

- 36           (1) Inform the appropriate law enforcement agency in the case of theft, tampering,  
37 or vandalism.
- 38           (2) Notify the register of deeds in the county of the remote electronic notary's  
39 commissioning under G.S. 10B-10 and the Secretary in writing and signed in  
40 the official name in which the remote electronic notary was commissioned.  
41 The notice shall indicate whether there was any permanent loss of data,  
42 unauthorized use, loss of use, or compromise of security of the electronic  
43 journal or the communication technology recordings of remote electronic  
44 notarial acts.

45           (c) The failure of a remote electronic notary to produce within 30 calendar days of the  
46 Secretary's request any record required by a rule adopted under this Part shall result in the  
47 suspension of the remote electronic notary's power to act as a notary under the provisions of this  
48 Chapter until the Secretary reinstates the notary's commission.

49 **"§ 10B-134.18.** Reserved for future codification purposes.

50 **"§ 10B-134.19. Platform licensure by Secretary.**

1       (a) A remote electronic notary shall use only a communication technology through a  
2 platform licensed by the Secretary.

3       (b) The Secretary shall review and issue platform licenses to qualified applicants. The  
4 applicant shall complete and submit an application on a form prescribed by the Secretary and pay  
5 a licensing fee of five thousand dollars (\$5,000).

6       (c) The application shall set forth at least all of the following:

7           (1) The name and address of the applicant and its registered agent.

8           (2) The names of all officers or directors directly involved in the operation,  
9 management, or control of the platform and all employees who exercise  
10 substantial influence or control over the platform.

11           (3) The proposed technology to address identity verification and geolocation  
12 requirements and explanations regarding security governance and the  
13 designation of a chief security officer or its equivalent.

14           (4) Any other information the Secretary may deem necessary.

15       (d) The Secretary shall conduct a background investigation on the applicant and persons  
16 described in subdivision (2) of subsection (c) of this section as deemed necessary by the  
17 Secretary. The background investigation shall include a criminal history record check, to which  
18 the applicant and person described in subdivision (2) of subsection (c) of this section must  
19 consent.

20       (e) The Secretary shall award a license only to applicants who are of good moral character  
21 and who provide a communication technology capable of all of the following:

22           (1) A manner of ensuring that the electronic record presented for remote  
23 electronic notarization is the same record electronically signed by the  
24 remotely located principal.

25           (2) Securely creating and storing, or transmitting securely to be securely stored,  
26 the communication technology recording, keeping confidential the questions  
27 asked as part of any identity proofing and the means and methods used to  
28 generate the credential analysis.

29           (3) A manner of ensuring that real-time communications are secure from  
30 unauthorized interception, access, or viewing.

31           (4) Reasonable security measures to prevent unauthorized access to all of the  
32 following:

33           a. The live transmission of the remote electronic notarial act.

34           b. Any communication technology recording of the remote electronic  
35 notarial act.

36           c. The verification methods and credentials used to verify the identity of  
37 the remotely located principal.

38           d. The electronic documents presented for remote electronic notarization.

39           (5) Geolocation of the remotely located principal.

40       (f) No platform license is assignable or transferable without the approval of the Secretary  
41 and shall be renewed annually in a manner set by the Secretary and upon payment of a fee of five  
42 thousand dollars (\$5,000).

43       (g) Each platform licensee shall collect a five dollar (\$5.00) per remote notarial act fee  
44 and remit fees collected at least monthly to the Secretary in a manner determined by the  
45 Secretary. All fees so remitted to the Secretary shall be placed in a nonreverting agency reserve  
46 account to be used by the Secretary in the implementation and enforcement of this Part.

47 **"§ 10B-134.20.** Reserved for future codification purposes.

48 **"§ 10B-134.21. Rules.**

49       (a) The Secretary shall adopt rules necessary to establish standards, procedures, practices,  
50 forms, and records relating to remote electronic notarial acts to implement this Part, including at  
51 least all of the following:

- 1           (1) Any additional educational requirements for remote electronic notaries.  
2           (2) The contents and security of the electronic journal.  
3           (3) The security standards, features, qualifications, measures, storage, and any  
4           other matter related to communication technology, credential analysis, and  
5           identity proofing.  
6           (4) The requirements of secure storage of all communication technology  
7           recordings, the electronic journal, and any other documentation under the  
8           control of the remote electronic notary regarding the remote electronic notarial  
9           act.  
10          (5) Any necessary actions upon notification of permanent loss of data,  
11          unauthorized use, loss of use, or compromise of security of the electronic  
12          journal or the communication technology recordings of remote electronic  
13          notarial acts.

14          (b) The Secretary may utilize emergency and temporary rulemaking as needed to  
15 implement this Part.

16 "§ 10B-134.22. Reserved for future codification purposes.

17 "§ 10B-134.23. Standards for services provided to remote notaries; enforcement.

18          (a) All licensees and third-party vendors shall meet all standards established by the  
19 Secretary under this Part for the provision of services to remote electronic notaries in this State.  
20 If the Secretary has not adopted rules establishing standards for a service, a licensee or third-party  
21 vendor may not furnish that service to a remote electronic notary public until the Secretary has  
22 determined that the provided service meets security standards generally accepted within the  
23 industry for that service.

24          (b) The Secretary may adopt rules establishing, supplementing, or amending third-party  
25 vendor guidelines for standards and processes for identity proofing and credential analysis  
26 services so that third-party vendors interacting with remote electronic notaries satisfy the security  
27 qualifications of establishing the identity of the remotely located principal.

28          (c) The Secretary, in the Secretary's discretion, may do any one or more of the following  
29 if a licensee or third-party vendor violates this Part or the rules adopted by the Secretary under  
30 this Part:

- 31           (1) Require a licensee or third-party vendor to provide a remote electronic notary  
32 with proof that an issue was caused in whole or in part by the licensee or  
33 third-party vendor's technology.  
34           (2) Issue a letter of warning, suspension, or revocation to the licensee or  
35 third-party vendor. The Secretary may require the licensee or third-party  
36 vendor to provide proof that it has come into compliance to reinstate any  
37 license or use of a third-party vendor's services.  
38           (3) Restrict use of a licensee or third-party vendor's technology by remote  
39 electronic notaries until it has come into compliance.  
40           (4) Assess a civil penalty of not more than one thousand dollars (\$1,000) per  
41 violation against any licensee or third-party vendor that violates a provision  
42 of this Part. In determining the amount of a penalty, the Secretary shall give  
43 due consideration to aggravating and mitigating factors presented to the  
44 Secretary by the licensee or third-party vendor and remote electronic notaries.  
45           (5) Any other appropriate remedy.

46          (d) A licensee or third-party vendor whose technology is restricted, suspended, or  
47 revoked shall work with remote electronic notaries using the services of that licensee or  
48 third-party vendor to ensure access and, if necessary, ease transition to a different licensee or  
49 third-party vendor and may not deny its remote electronic notary customers access.

50          (e) A licensee or third-party vendor is liable to any person who suffers damages from a  
51 remote electronic notarial act if both of the following apply:



- 1           (1) The damage is proximately caused by a service provided by the licensee or  
 2           third-party vendor that failed to meet any standard under this Part.  
 3           (2) The person damaged was a party to, or in privity with a party to, the remote  
 4           electronic notarial act proximately causing the damage.

5           (f) A remote electronic notary who exercised reasonable care in selecting and using a  
 6           licensee or third-party vendor in connection with a remote electronic notarial act shall not be  
 7           liable for any damages resulting from the licensee's or third-party vendor's failure to comply with  
 8           the requirements of this Part. Any provision in a contract between the remote electronic notary  
 9           and a licensee or third-party vendor that attempts to waive the immunity conferred by this  
 10           subsection shall be null, void, and of no effect.

11 "§ 10B-134.24. Reserved for future codification purposes.

12 "§ 10B-134.25. Real estate transactions.

13           (a) Nothing in this Part shall be construed to alter or supersede the law as set forth in  
 14           Chapter 84 of the General Statutes, G.S. 10B-20(i) through (k), G.S. 75-1.1, or any opinion or  
 15           ruling by a North Carolina court of competent jurisdiction or the North Carolina State Bar ruling  
 16           pertaining to the unauthorized practice of law in this State, including the requirements that a  
 17           licensed North Carolina attorney shall supervise a residential real estate closing under Authorized  
 18           Practice Advisory Opinion 2002-1 issued by the North Carolina State Bar and perform all  
 19           services defined as the practice of law for real property located in this State.

20           (b) A remote electronic notary who is not a licensed North Carolina attorney is prohibited  
 21           from rendering services or advice that constitutes the practice of law in this State.

22 "§ 10B-134.26. Reserved for future codification purposes."

23 **SECTION 2.(a)** G.S. 10B-2(6) reads as rewritten:

- 24           "(6) To integrate procedures for ~~traditional paper and electronic notarial acts.~~all of  
 25           the following notarial acts:  
 26           a. Traditional paper.

14 be considered confidential information and shall not be subject to disclosure under Chapter 132

16 (e) The electronic registration form for an electronic notary or remote electronic notary  
17 shall be transmitted electronically to the Secretary and shall include any decrypting instructions,  
18 codes, keys, or software that allow the registration to be read.

19 (f) Within 10 business days after the change of any registration information required of  
20 an electronic ~~notary, notary or remote electronic notary~~, the notary shall electronically transmit  
21 to the Secretary a notice of the change of information signed with the notary's official electronic  
22 signature."

18 **SECTION 3.(c)** G.S. 10B-200(b) reads as rewritten:

19 "(b) This Article expires ~~December 31, 2021.~~ June 30, 2023."

20 **SECTION 3.(d)** Any emergency video notarization completed after December 31,  
21 2021, and before the effective date of this act shall be deemed valid and cured if such act was  
22 performed in conformity with G.S. 10B-200 as it existed on December 31, 2021.

23 **SECTION 3.(e)** G.S. 10B-31 reads as rewritten:

24 "**§ 10B-31. Fees for notarial acts.**

25 The maximum fees that may be charged by a notary for notarial acts are as follows:

40 a paper copy of an electronic document as defined in G.S. 47-16.2(3) that is otherwise eligible  
41 under State law to be recorded in the real property records if all of the following conditions have  
42 been met:

- 43 (1) One of the following applies to the county register of deeds:
  - 44 a. The register has no electronic recording system.
  - 45 b. The register's recording system does not accept the type of document  
46 being submitted.
  - 47 c. The register's electronic recording system is not operational in the

25 (5) Except as otherwise provided in this subsection, the document conforms to all  
 26 other applicable laws and rules that prescribe recordation."

28 **SECTION 5.** G.S. 20-30(6) reads as rewritten:

29 "(6) To make a color photocopy or otherwise make a color reproduction of a  
 30 drivers license, learner's permit, or special identification card, unless such  
 31 color photocopy or other color reproduction was authorized by the  
 32 Commissioner or is made to comply with G.S. 163-230.2. It shall be lawful to  
 33 make a black and white photocopy of a drivers license, learner's permit, or  
 34 special identification card or otherwise make a black and white reproduction  
 35 of a drivers license, learner's permit, or special identification card. This  
 36 subdivision does not apply to: (i) a to any of the following:

37 a. A lender that is licensed or otherwise authorized to engage in the  
 38 lending business in this State; (ii) a State.

47 d. Performance of a remote notarization act under Part 4A of Article 2 of  
 48 Chapter 10B of the General Statutes."

49 **SECTION 6.** Subpart D of Part 4 of Article 13 of Chapter 143B of the General  
 50 Statutes is amended by adding a new section to read:

51 **"§ 143B-976. Criminal record check for platform licensees.**

1       (a) The Department of Public Safety may provide to the Secretary of State a criminal  
2 history from the State and National Repositories of Criminal Histories for any applicant seeking  
3 a platform license. The Secretary shall provide to the Department of Public Safety, along with  
4 the request, the fingerprints of the applicant and its key persons; a form signed by the individual  
5 consenting to the criminal record check and use of fingerprints and other identifying information  
6 required by the State and National Repositories; and any additional information required by the  
7 Department of Public Safety. The fingerprints of the individual shall be forwarded to the State  
8 Bureau of Investigation for a search of the State's criminal history record file, and the State  
9 Bureau of Investigation shall forward a set of fingerprints to the Federal Bureau of Investigation  
10 for a national criminal history record check.

11       (b) The criminal history report shall be provided to the Secretary of State, who shall keep  
12 all information obtained pursuant to this section confidential to the Secretary of State. A criminal  
13 history report obtained as provided in this section is not a public record under Chapter 132 of the  
14 General Statutes."

15       **SECTION 7.** G.S. 10B-60(g) is amended by adding a new subdivision to read:

16       "(3) The Secretary may refer such evidence as is available pertaining to violations  
17 of this Chapter or other criminal acts involving a notarization under this  
18 Chapter to the proper district attorney, who may, with or without such a  
19 referral, institute the appropriate criminal proceedings. Upon receipt of a  
20 referral, the district attorney may request that a duly employed attorney of the  
21 Secretary prosecute or assist in the prosecution of the criminal proceedings on  
22 behalf of the State. Upon approval of the Secretary, the employee may be  
23 appointed as a special prosecutor for the district attorney to prosecute or assist  
24 in the prosecution of the criminal proceedings without receiving  
25 compensation from the district attorney. Such a special prosecutor shall have  
26 all the powers and duties prescribed by law for district attorneys and such  
27 other powers and duties as are lawfully delegated to the special prosecutor by  
28 the district attorney for the prosecution for which appointed."

29       **SECTION 8.(a)** The receipts established by Part 4A of Article 2 of Chapter 10B of  
30 the General Statutes, as enacted by this act, shall be appropriated to the Secretary of State for the  
31 purpose of establishing four new positions: one attorney, one information technology specialist,  
32 and two law enforcement positions. Of the funds appropriated in the fiscal year 2022-2023 to the  
33 Secretary of State, the Secretary may utilize up to five hundred thousand dollars (\$500,000) to  
34 fill the four new positions. Of the funds appropriated in the fiscal year 2023-2024 to the Secretary  
35 of State, the Secretary may utilize up to three hundred fifty thousand dollars (\$350,000) to  
36 implement Part 4A of Article 2 of Chapter 10B of the General Statutes, as enacted by this act.

37       **SECTION 8.(b)** This section is effective when it becomes law.

38       **SECTION 9.** Except as otherwise provided, this act becomes effective July 1, 2023.  
39 In order to implement remote notarization on the effective date of this act, the Secretary of State  
40 shall begin rulemaking to implement Part 4A of Article 2 of Chapter 10B of the General Statutes,  
41 as enacted by this act, prior to July 1, 2023, but no temporary or permanent rule shall become  
42 effective prior to July 1, 2023.
