1 A BILL TO BE ENTITLED  
2 AN ACT TO REDUCE UNNECESSARY REGULATORY CONSTRAINTS FOR APPLIED  
3 BEHAVIOR ANALYSIS.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.(a)** Chapter 90 of the General Statutes is amended by adding a new  
6 Article to read:

7 "Article 43.

8 "Behavior Analyst Licensure.

9 **"§ 90-726.1. Declaration of purpose.**

10 The practice of behavior analysis in North Carolina affects the public health, safety, and  
11 welfare of citizens of North Carolina and shall be subject to regulation to protect the public from  
12 (i) the practice of behavior analysis by unqualified individuals and (ii) unprofessional, unethical,  
13 or harmful conduct by individuals licensed to practice behavior analysis.

14 **"§ 90-726.2. Definitions.**

15 The following definitions apply in this Article:

- 16 (1) Behavior analysis. – The design, implementation, and evaluation of  
17 systematic instructional and environmental modifications to produce  
18 significant personal or interpersonal improvements in human behavior.
- 19 (2) Behavior technician. – A paraprofessional who delivers applied behavior  
20 analysis services and who practices under the close, ongoing supervision of a  
21 licensed behavior analyst, licensed assistant behavior analyst, or other  
22 professional licensed under this Chapter or Chapter 90B of the General  
23 Statutes, so long as the services of the licensed professional are within the  
24 scope of practice of the license possessed by that licensed professional, and  
25 the services performed are commensurate with the licensed professional's  
26 education, training, and experience. The behavior technician does not design  
27 assessment or intervention plans or procedures but delivers services as  
28 assigned by a supervisor who is responsible for the behavior technician's  
29 work.
- 30 (3) Board. – The North Carolina Behavior Analyst Board.
- 31 (4) Certifying entity. – The nationally accredited Behavior Analyst Certification  
32 Board, Inc., or its successor.
- 33 (5) Institution of higher education. – A university, college, professional school,  
34 or other institution accredited in the United States, Canada, or other country.  
35 For the purposes of this subdivision, accreditation shall be granted by the

1 Commission on Recognition of Postsecondary Accreditation or comparable  
2 official organization having accreditation authority.

3 (6) Licensed assistant behavior analyst. – An individual who is certified by the  
4 certifying entity as a Board Certified Assistant Behavior Analyst and has been  
5 issued a license under this Article that (i) is active, (ii) is not suspended or  
6 revoked, and (iii) permits the individual to engage in the practice of behavior  
7 analysis under the supervision of a licensed behavior analyst.

8 (7) Licensed behavior analyst. – An individual who is certified by the certifying  
9 entity as a Board Certified Behavior Analyst and has been issued a license  
10 under this Article that is active and not suspended or revoked.

11 (8) Practice of behavior analysis. – The practice of behavior analysis includes the  
12 empirical identification of functional relations between behavior and  
13 environmental factors known as functional assessment and analysis. Behavior  
14 analysis interventions are based on scientific research and the direct  
15 observation and measurement of behavior and the environment. In the practice  
16 of behavior analysis, behavior analysts utilize contextual factors, motivating  
17 operations, antecedent stimuli, positive reinforcement, and other  
18 consequences to help people develop new behaviors, increase or decrease  
19 existing behaviors, and emit behaviors under specific environmental  
20 conditions. The practice of behavior analysis expressly excludes  
21 psychological testing, cognitive therapy, sex therapy, psychoanalysis,  
22 hypnotherapy, and long-term counseling as treatment modalities.

23 **§ 90-726.3. North Carolina Behavior Analysis Board.**

24 (a) Establishment. – The North Carolina Behavior Analysis Board is created. The Board  
25 shall consist of five members who shall serve staggered terms. The initial Board shall be selected  
26 as follows:

27 (1) The General Assembly, upon the recommendation of the Speaker of the House  
28 of Representatives, shall appoint one behavior analyst, who is certified by the  
29 certifying entity as a Board Certified Behavior Analyst, to serve a three-year  
30 term.

31 (2) The General Assembly, upon the recommendation of the President Pro  
32 Tempore of the Senate, shall appoint one behavior analyst, who is certified by  
33 the certifying entity as a Board Certified Behavior Analyst, to serve a two-year  
34 term.

35 (3) The Governor shall appoint the following three members:

36 a. One behavior analyst, who is certified by the certifying entity as a  
37 Board Certified Behavior Analyst, to serve a three-year term.

38 b. One assistant behavior analyst, who is certified by the certifying entity  
39 as a Board Certified Assistant Behavior Analyst, to serve a two-year  
40 term.

41 c. One public member to serve a one-year term.

42 Upon the expiration of the terms of the initial Board members, each member shall be  
43 appointed by the appointing authorities designated in subdivisions (1) through (3) of this  
44 subsection for a three-year term and shall serve until a successor is appointed and qualified. All  
45 members appointed to the Board, except for the public member appointed by the Governor under  
46 subdivision (3) of this subsection, shall be required to be licensed under this Article and shall  
47 seek licensure in this State as soon as the first application period begins. No member may serve  
48 more than two consecutive full terms.

49 (b) Vacancies. – If a member of the Board cannot complete a term of office, the vacancy  
50 shall be filled in the same manner as the original appointment for the remainder of the unexpired

1 term. No Board member shall participate in any matter before the Board in which the member  
2 has a pecuniary interest or similar conflict of interest.

3 (c) Qualifications of Board members; removal of Board members. –

4 (1) Each licensed behavior analyst or licensed assistant behavior analyst member  
5 of the Board shall have all of the following qualifications:

6 a. Shall be a resident of this State and a citizen of the United States.

7 b. Shall be free of conflict of interest or the appearance of a conflict of  
8 interest in performing the duties of the Board.

9 (2) Each public member of the Board shall have all of the following  
10 qualifications:

11 a. Shall be a resident of this State and a citizen of the United States.

12 b. Shall be free of conflict of interest or the appearance of a conflict of  
13 interest in performing the duties of the Board.

14 c. Shall not be a licensed behavior analyst or licensed assistant behavior  
15 analyst, an applicant or former applicant for licensure as a behavior  
16 analyst or assistant behavior analyst, or a member of a household that  
17 includes a licensed behavior analyst or licensed assistant behavior  
18 analyst.

19 (3) A Board member shall be automatically removed from the Board for any of  
20 the following:

21 a. Ceases to meet the qualifications specified in this subsection.

22 b. Fails to attend three successive Board meetings without just cause as  
23 determined by the remainder of the Board.

24 c. Is found by the remainder of the Board to be in violation of the  
25 provisions of this Article or to have engaged in immoral, dishonorable,  
26 unprofessional, or unethical conduct, and the conduct is deemed to  
27 compromise the integrity of the Board.

28 d. Is found guilty of a felony or an unlawful act involving moral turpitude  
29 by a court of competent jurisdiction or is found to have entered a plea  
30 of nolo contendere to a felony or an unlawful act involving moral  
31 turpitude.

32 e. Is found guilty of malfeasance, misfeasance, or nonfeasance regarding  
33 Board duties by a court of competent jurisdiction.

34 f. Is incapacitated and without reasonable likelihood of resuming Board  
35 duties, as determined by the Board.

36 (d) Meetings. – The Board shall elect annually a chair and other officers as it deems  
37 necessary to carry out the purposes of this Article. The Board may hold additional meetings upon  
38 the call of the chair or any two board members. A majority of the Board shall constitute a quorum.

39 (e) Compensation of Members; Expenses; Employees. – Members of the Board shall  
40 receive no compensation for their services but shall receive per diem and necessary travel and  
41 subsistence expenses as provided in G.S. 138-5 and G.S. 138-6. The Board may employ  
42 necessary personnel for the performance of its functions and fix the compensation. The Board  
43 shall not employ any of its members to perform inspectional or similar ministerial tasks for the  
44 Board. In no event shall the State of North Carolina be liable for expenses incurred by the Board  
45 in excess of the income derived from this Article.

46 **"§ 90-726.4. Powers and duties of Board.**

47 (a) The Board shall have the following powers and duties:

48 (1) Administer, coordinate, and enforce the provisions of this Article.

49 (2) Adopt, amend, or repeal rules to administer and enforce this Article.

50 (3) Establish and determine qualification and fitness of applicants for licensure  
51 under this Article.

- 1           (4) Issue, renew, deny, suspend, revoke, or refuse to issue or renew any license  
2           under this Article.
- 3           (5) Establish fees for applications, initial and renewal licenses, and other services  
4           provided by the Board.
- 5           (6) Discipline individuals licensed under this Article.

6           (b) The Board may empower any member to conduct any proceeding or investigation  
7 necessary to its purposes and may empower its agent or counsel to conduct any investigation  
8 necessary to its purposes, but any final action requires a quorum of the Board. The Board shall  
9 adopt an official seal, which shall be affixed to all licenses issued by it.

10 **"§ 90-726.5. Annual report.**

11           On June 30 of each year, the Board shall submit a report to the Governor of the Board's  
12 activities since the preceding July 1, including (i) the names of all licensed behavior analysts and  
13 licensed assistant behavior analysts to whom licenses have been granted under this Article, (ii)  
14 any cases heard and decisions rendered in matters before the Board, (iii) the recommendations  
15 of the Board as to future actions and policies, and (iv) a financial report. Each member of the  
16 Board shall review and sign the report before its submission to the Governor. Any Board member  
17 shall have the right to record a dissenting view.

18 **"§ 90-726.6. License application.**

19           (a) Each individual desiring to obtain a license under this Article shall apply to the Board  
20 in accordance with the procedure and rules prescribed by the Board. Each applicant shall furnish  
21 evidence satisfactory to the Board that the applicant meets all of the following criteria:

- 22           (1) The individual is of good moral character and conducts all professional  
23 activities in accordance with accepted professional and ethical standards.
- 24           (2) The individual has not engaged in any practice at any time that would be a  
25 ground for denial, revocation, or suspension of a license under  
26 G.S. 90-726.12.
- 27           (3) The individual has submitted the required criminal history record, as required  
28 by G.S. 90-726.14.
- 29           (4) The individual is qualified for licensure under the requirements of this Article.

30           (b) A license obtained through fraud or by any false representation is void.

31 **"§ 90-726.7. Requirements for licensure as a behavior analyst.**

32           Each applicant shall be issued a license by the Board to engage in the practice of behavior  
33 analysis as a licensed behavior analyst if the applicant meets the qualifications set forth by the  
34 Board in accordance with G.S. 90-726.4(a) and provides satisfactory evidence to the Board of all  
35 the following criteria:

- 36           (1) The applicant is at least 18 years of age.
- 37           (2) The applicant has passed the certifying entity's Board Certified Behavior  
38 Analyst examination.
- 39           (3) The applicant has an active status with the certifying entity as a Board  
40 Certified Behavior Analyst.

41 **"§ 90-726.8. Requirement of licensure as an assistant behavior analyst.**

42           Each applicant shall be issued a license by the Board to engage in the practice of behavior  
43 analysis as a licensed assistant behavior analyst if the applicant meets the qualifications set forth  
44 in G.S. 90-726.4(a) and provides satisfactory evidence to the Board of all the following criteria:

- 45           (1) The applicant is at least 18 years of age.
- 46           (2) The applicant has passed the certifying entity's Board Certified Assistant  
47 Behavior Analyst examination.
- 48           (3) The applicant has an active status with the certifying entity as a Board  
49 Certified Assistant Behavior Analyst.

- 1           (4) The applicant has an ongoing arrangement for supervision by a licensed  
2           behavior analyst in a manner consistent with the certifying entity's  
3           requirements for supervision of Board Certified Assistant Behavior Analysts.

4 **"§ 90-726.9. Renewal of license.**

5           (a) A license shall be granted under this Article for the period of two years.

6           (b) The Board shall renew a license granted under this Article upon completion of the  
7 following:

- 8           (1) Proof of completion of any continuing education required by the certifying  
9           entity.  
10          (2) Payment of the renewal fee.  
11          (3) Evidence of active certification by the certifying entity.  
12          (4) For licensed assistant behavior analysts, evidence of the ongoing arrangement  
13          for supervision by a licensed behavior analyst, as required by G.S. 90-726.8.

14 **"§ 90-726.10. Temporary licensure.**

15          (a) An actively licensed or certified behavior analyst who resides and practices behavior  
16 analysis in another state may apply to the Board for a temporary license to practice behavior  
17 analysis in this State.

18          (b) A temporary license is available only if the behavior analysis services are to be  
19 delivered during a limited and defined period of service approved by the Board.

20 **"§ 90-726.11. Reciprocity.**

21          (a) The Board shall issue a license to an individual who is actively licensed as a behavior  
22 analyst or assistant behavior analyst in another state that currently imposes comparable licensure  
23 requirements as those imposed by this Article and that offers reciprocity to individuals licensed  
24 under this Article.

25          (b) Applicants for licensure by reciprocity shall submit the following items:

- 26           (1) Proof of ethical compliance.  
27           (2) Proof of current licensure.  
28           (3) Proof of current certification by the certifying entity.  
29           (4) A criminal history record check as required by G.S. 90-726.14.  
30           (5) Any other eligibility requirement as deemed appropriate by the Board.

31 **"§ 90-726.12. Denial, suspension, or revocation of licenses and other disciplinary and**  
32 **remedial actions for violations of the Code of Conduct; relinquishing of license.**

33          (a) Any applicant for licensure and any individual licensed under this Article shall  
34 comply with the ethical and professional standards specified in this Code of Conduct and in the  
35 rules of the Board. The Board may deny, suspend, or revoke licensure and may discipline, place  
36 on probation, limit practice, and require examination, remediation, and rehabilitation of any  
37 applicant or licensee, as provided for in subsection (b) of this section, for any violation listed in  
38 this subsection. The following are considered violations of the Code of Conduct:

- 39           (1) Conviction of a felony or entry of a plea of guilty or nolo contendere to any  
40           felony charge.  
41           (2) Conviction of a felony or entry of a plea of guilty or nolo contendere to any  
42           misdemeanor involving moral turpitude, misrepresentation or fraud in dealing  
43           with the public, or conduct otherwise relevant to fitness to practice, or a  
44           misdemeanor charge reflecting the inability to practice behavior analysis  
45           relating to the health and safety of clients or patients.  
46           (3) Using fraud or deceit in securing or attempting to secure or renew a license  
47           under this Article or willfully concealing from the Board material information  
48           in connection with application for a license or for renewal of a license under  
49           this Article.  
50           (4) Using fraud, deceit, or misrepresentation upon the public, the Board, or any  
51           individual in connection with the practice of behavior analysis, the filing of

- 1 Medicare, Medicaid, or other claims to any third-party payor, or in any manner  
2 otherwise relevant to fitness for the practice of behavior analysis.
- 3 (5) Making fraudulent, misleading, or intentionally or materially false statements  
4 pertaining to education, licensure, license renewal, supervision, continuing  
5 education, any disciplinary actions or sanctions pending or occurring in any  
6 other jurisdiction, professional credentials, or qualifications or fitness for the  
7 practice of behavior analysis to the public, any individual, the Board, or any  
8 other organization.
- 9 (6) Revocation or suspension of a license for the practice of behavior analysis in  
10 any other jurisdiction or having been disciplined by the licensing board or  
11 certifying entity in any other jurisdiction for conduct which would subject the  
12 licensee to discipline under this Article.
- 13 (7) Violation of any provision of this Article or of the rules adopted by the Board.
- 14 (8) Aiding or abetting the unlawful practice of behavior analysis by any individual  
15 not licensed by the Board.
- 16 (9) Engaging in immoral, dishonorable, unprofessional, or unethical conduct as  
17 defined in this subsection, or the current ethics code of the certifying entity.
- 18 (10) Practicing behavior analysis in a manner that endangers the welfare of clients  
19 or patients.
- 20 (11) Demonstrating an inability to practice behavior analysis with reasonable skill  
21 and safety by reason of illness, inebriation, misuse of drugs, narcotics, alcohol,  
22 chemicals, or any other substance affecting mental or physical functioning, or  
23 as a result of any mental or physical condition.
- 24 (12) Practicing behavior analysis outside the boundaries of demonstrated  
25 competence or the limitations of education, training, or supervised experience.
- 26 (13) Failing to provide competent treatment, consultation, or supervision, in  
27 keeping with standards of usual and customary practice in this State.
- 28 (14) Failing to take all reasonable steps to ensure the competence of services.
- 29 (15) Failing to maintain a clear and accurate case record documenting the  
30 following for each patient or client:
- 31 a. Presenting problems, diagnosis, or purpose of the evaluation,  
32 treatment, or other services provided.
- 33 b. Fees, dates of services, and itemized charges.
- 34 c. Summary content of each session of evaluation, treatment, or other  
35 services, except summary content that may cause significant harm to  
36 any individual if the information were released.
- 37 d. Copies of all reports prepared.
- 38 (16) Failing to retain securely and confidentially the complete case record  
39 indefinitely if there are pending legal or ethical matters or if there is any other  
40 compelling circumstance, or failing to retain securely and confidentially the  
41 complete case record for at least seven years from the date of the last provision  
42 of services, except when under either circumstance, the behavior analyst was  
43 prevented from doing so by circumstances beyond the behavior analyst's  
44 control.
- 45 (17) Failing to cooperate with other behavior analysts or other professionals to the  
46 potential or actual detriment of clients, patients, or other recipients of service,  
47 or behaving in ways which substantially impede or impair other licensed  
48 behavior analysts, licensed assistant behavior analysts, or other professionals'  
49 abilities to perform professional duties.
- 50 (18) Exercising undue influence in a manner that exploits the client, patient,  
51 student, supervisee, or trainee for the financial or other personal advantage or

- 1                   gratification of the licensed behavior analyst, licensed assistant behavior  
2                   analyst, or a third party.
- 3           (19)   Harassing or abusing, sexually or otherwise, a client, patient, student,  
4                   supervisee, or trainee.
- 5           (20)   Failing to cooperate with or to respond promptly, completely, and honestly to  
6                   the Board, to credentialing committees, institutional review boards,  
7                   professional standards review organizations, or ethics committees of  
8                   professional behavior analyst associations, hospitals, or other health care  
9                   organizations or educational institutions, when those organizations or entities  
10                  have jurisdiction.
- 11           (21)   Refusing to appear before the Board after having been ordered to do so in  
12                  writing by the chair.
- 13           (b)   Upon proof that an applicant or licensee under this Article has engaged in any of the  
14                  prohibited actions specified in subsection (a) of this section, the Board may, in lieu of denial,  
15                  suspension, or revocation, do all of the following:
- 16                  (1)   Issue a formal reprimand or formally censure the applicant or licensee.
- 17                  (2)   Place the applicant or licensee on probation with appropriate conditions as the  
18                          Board may deem advisable.
- 19                  (3)   Require examination, remediation, or rehabilitation for the applicant or  
20                          licensee, including care, counseling, or treatment by a professional or  
21                          professionals designated or approved by the Board, the expense of which shall  
22                          be paid by the applicant or licensee.
- 23                  (4)   Require supervision for the services provided by the applicant or licensee by  
24                          a licensee designated or approved by the Board, the expense of which shall be  
25                          paid by the applicant or licensee.
- 26                  (5)   Limit or circumscribe the practice of behavior analysis provided by the  
27                          applicant or licensee with respect to the extent, nature, or location of the  
28                          services provided, as the Board deems advisable.
- 29                  (6)   Impose conditions of probation or restrictions upon continued practice at the  
30                          conclusion of a period of suspension or as requirements for the restoration of  
31                          a revoked or suspended license.
- 32           (c)   In lieu of or in connection with any disciplinary proceedings or investigation, the  
33                  Board may enter into a consent order relative to the discipline, supervision, probation,  
34                  remediation, rehabilitation, or practice limitation of a licensee or applicant for a license.
- 35           (d)   The Board may assess costs of disciplinary action against an applicant or licensee  
36                  found to be in violation of this Article.
- 37           (e)   When considering whether an applicant or licensee is physically or mentally capable  
38                  of practicing behavior analysis with reasonable skill and safety with patients or clients, the Board  
39                  may petition a court of competent jurisdiction to order the applicant or licensee to submit to a  
40                  psychological evaluation by a psychologist to determine psychological status or a physical  
41                  evaluation by a physician to determine physical condition, or both, upon a showing of probable  
42                  cause to the Board that the applicant or licensee is not capable of practicing behavior analysis  
43                  with reasonable skill and safety with patients or clients. The psychologist or physician that  
44                  conducts an evaluation of the applicant or licensee shall be designated by the court of competent  
45                  jurisdiction. The Board shall be responsible for the expenses of evaluations ordered under this  
46                  subsection. If the applicant or licensee raises the issue of mental or physical competence or  
47                  appeals a decision regarding mental or physical competence, the applicant or licensee shall be  
48                  permitted to obtain an evaluation at the applicant's or licensee's expense. If the Board suspects  
49                  the objectivity or adequacy of the evaluation, the Board may compel an evaluation by its  
50                  designated practitioners at its own expense.

1       (f)     Except as provided otherwise in this Article, the procedure for revocation, suspension,  
2 denial, limitations of the license, or other disciplinary, remedial, or rehabilitative actions shall be  
3 in accordance with the provisions of Chapter 150B of the General Statutes. The Board is required  
4 to provide the opportunity for a hearing under Chapter 150B of the General Statutes to any  
5 applicant whose license is denied or to whom licensure is offered subject to any restrictions,  
6 probation, disciplinary action, remediation, or other conditions or limitations or to any licensee  
7 before revoking, suspending, or restricting a license or imposing any other disciplinary action or  
8 remediation. If the applicant or licensee waives the opportunity for a hearing, the Board's denial,  
9 revocation, suspension, or other proposed action becomes final without a hearing having been  
10 conducted. Notwithstanding the foregoing, no applicant or licensee is entitled to a hearing for  
11 failure to pass an examination.

12       (g)     In any proceeding, record of hearing, complaint, notice of charges, or decision before  
13 the Board, the Board may withhold from public disclosure the identity of any clients or patients  
14 who have not consented to the public disclosure of behavior analysis services having been  
15 provided by the licensee or applicant. The Board may close a hearing to the public and receive  
16 in executive session evidence involving or concerning the treatment of or delivery of behavior  
17 analysis services to a client or a patient who has not consented to the public disclosure of  
18 treatment or services as may be necessary for the protection and rights of the patient or client of  
19 the accused applicant or licensee and the full presentation of relevant evidence. All records,  
20 papers, and other documents containing information collected and compiled by or on behalf of  
21 the Board, as a result of investigations, inquiries, or interviews conducted in connection with  
22 licensing or disciplinary matters, will not be considered public records as defined in G.S. 132-1.  
23 However, any notice or statement of charges, notice of hearing, or decision against or to any  
24 licensee or applicant shall be a public record notwithstanding that it may contain information  
25 collected and compiled as a result of an investigation, inquiry, or hearing except that identifying  
26 information concerning the treatment or delivery of services to a patient or client who has not  
27 consented to the public disclosure of treatment or services shall be deleted. If any record, paper,  
28 or other document containing information collected and compiled by or on behalf of the Board  
29 is received and admitted in evidence in any hearing before the Board, it shall be a public record,  
30 subject to any deletions of identifying information concerning the treatment or delivery of  
31 behavior analysis services to a patient or client who has not consented to the public disclosure of  
32 treatment or services.

33       (h)     A license issued under this Article is suspended automatically by operation of law  
34 after failure to renew a license for a period of more than 60 days after the renewal date. The  
35 Board may reinstate a license suspended under this subsection upon payment of a fee as specified  
36 in G.S. 90-726.13 and may require that the applicant file a new application, furnish references,  
37 update credentials, or submit to examination for reinstatement. Notwithstanding any provision to  
38 the contrary, the Board retains full jurisdiction to investigate alleged violations of this Article by  
39 any individual whose license is suspended under this subsection, and, upon proof of any violation  
40 of this Article by any individual, the Board may take disciplinary action as authorized by this  
41 section.

42       (i)     An individual whose license has been denied or revoked may reapply to the Board for  
43 licensure after the passage of one calendar year from the date of the denial or revocation.

44       (j)     A licensee may voluntarily relinquish a license at any time with the consent of the  
45 Board. The Board may delay or refuse granting consent as necessary in order to investigate any  
46 pending complaint, allegation, or issue regarding violation of any provision of this Article by the  
47 licensee. Notwithstanding any provision to the contrary, the Board retains full jurisdiction to  
48 investigate alleged violations of this Article by any individual whose license is relinquished under  
49 this subsection, and, upon proof of any violation of this Article by any individual, the Board may  
50 take disciplinary action as authorized by this section.

51       (k)     The Board may adopt rules to interpret and implement the provisions of this section.



1 **"§ 90-726.13. Fees.**

2 The Board may collect fees established by its rules, but those fees shall not exceed the  
3 amounts listed below:

- 4 (1) Application fee for licensure..... \$250.00.
- 5 (2) License renewal..... \$200.00.
- 6 (3) Late renewal fee..... \$50.00.
- 7 (4) Reciprocal license application..... \$250.00.
- 8 (5) Temporary license application..... \$100.00.

9 **"§ 90-726.14. Criminal history record checks of applicants for licensure.**

10 (a) All applicants for licensure shall consent to a criminal history record check. Refusal  
11 to consent to a criminal history record check may constitute grounds for the Board to deny  
12 licensure to an applicant. The Board shall be responsible for providing to the North Carolina  
13 Department of Justice the applicant's fingerprints to be checked, a form signed by the applicant  
14 consenting to the criminal history record check and the use of fingerprints and other identifying  
15 information required by the State or National Repositories, and any additional information  
16 required by the Department of Justice. The Board shall keep all information obtained in  
17 accordance with this section confidential.

18 (b) The cost of the criminal history record check and the fingerprinting shall be paid by  
19 the applicant. The Board shall collect any fees required by the Department of Justice and shall  
20 remit the fees to the Department of Justice for expenses associated with conducting the criminal  
21 history record check.

22 (c) If an applicant's criminal history record reveals one or more criminal convictions, the  
23 conviction shall not automatically bar licensure. The Board shall consider all of the following  
24 factors regarding the conviction:

- 25 (1) The level of seriousness of the crime.
- 26 (2) The date of the crime.
- 27 (3) The age of the individual at the time of conviction.
- 28 (4) The circumstances surrounding the commission of the crime, if known.
- 29 (5) The nexus between the criminal conduct of the individual and the job duties  
30 of the position to be filled.
- 31 (6) The applicant's prison, jail, probation, parole, rehabilitation, and employment  
32 records since the date the crime was committed.

33 (d) If, after reviewing the factors, the Board determines that any of the grounds to deny  
34 licensure exist, the Board may deny licensure of the applicant. The Board may disclose to the  
35 applicant information contained in the criminal history record that is relevant to the denial if  
36 disclosure of the information is permitted by applicable State and federal law. The Board shall  
37 not provide a copy of the criminal history to the applicant. The applicant shall have the right to  
38 appear before the Board to appeal the Board's decision. An appearance before the full Board shall  
39 constitute an exhaustion of administrative remedies in accordance with Chapter 150B of the  
40 General Statutes.

41 (e) The Board, its officers, and employees, acting in good faith and in compliance with  
42 this section, shall be immune from civil liability for denying licensure to an applicant based on  
43 information provided in the applicant's criminal history record.

44 **"§ 90-726.15. Exemptions from licensure.**

45 An individual is exempt from the requirements of this Article if any of the following  
46 conditions are met:

- 47 (1) The individual is a licensed psychologist or psychological associate in this  
48 State or provides ancillary services in accordance with G.S. 90-270.154.
- 49 (2) The individual is a behavior technician delivering applied behavior analysis  
50 services under the extended authority and direction of a licensed behavior  
51 analyst, licensed assistant behavior analyst, or other professional licensed

1 under this Chapter or Chapter 90B of the General Statutes, so long as the  
2 services of the licensed professional are within the scope of practice of the  
3 license possessed by that licensed professional, and the services performed are  
4 commensurate with the licensed professional's education, training, and  
5 experience. The behavior technician does not design assessment or  
6 intervention plans or procedures but delivers services as assigned by a  
7 supervisor who is responsible for the behavior technician's work.

8 (3) The individual is a family member, guardian, or other caretaker implementing  
9 a behavior analysis treatment plan under the direction of a licensed behavior  
10 analyst or a licensed assistant behavior analyst.

11 (4) The individual engages in the practice of behavior analysis with nonhuman  
12 subjects, including individuals who are animal behaviorists and animal  
13 trainers.

14 (5) The individual provides general behavior analysis services to organizations,  
15 so long as the services are for the benefit of the organizations and do not  
16 involve direct services to individuals.

17 (6) The individual is a professional licensed under this Chapter or Chapter 90B of  
18 the General Statutes, so long as the licensed professional does not represent  
19 that the licensed professional is a licensed behavior analyst or licensed  
20 assistant behavior analyst and the services of the licensed professional are  
21 within the scope of practice of the license possessed by that licensed  
22 professional and the services performed are commensurate with the licensed  
23 professional's education, training, and experience.

24 (7) The activities are part of a defined college or university course program of  
25 study, practicum, or intensive practicum, so long as that individual is under  
26 direct supervision of (i) a licensed behavior analyst, (ii) an instructor in a  
27 course sequence approved by the certifying entity, or (iii) a qualified faculty  
28 member.

29 (8) The individual is pursuing experience in behavior analysis consistent with the  
30 certifying entity's experience requirements, so long as the individual's  
31 activities are supervised by a licensed behavior analyst."

32 **SECTION 1.(b)** G.S. 90-270.138 is amended by adding a new subsection to read:

33 "(f1) Nothing in this Article shall be construed to prevent a behavior analyst or an assistant  
34 behavior analyst licensed under Article 43 of Chapter 90 of the General Statutes from offering  
35 services within the scope of practice authorized by the North Carolina Behavior Analysis Board."

36 **SECTION 1.(c)** The North Carolina Behavior Analysis Board shall adopt temporary  
37 rules to implement this section. The temporary rules shall remain in effect until permanent rules  
38 that replace the temporary rules become effective.

39 **SECTION 2.(a)** Article 43 of Chapter 90 of the General Statutes, as enacted by  
40 Section 1 of this act, is amended by adding new sections to read:

41 **"§ 90-726.16. Prohibited acts and penalties.**

42 (a) Except as permitted in G.S. 90-726.15, it shall be a violation of this Article for any  
43 individual not licensed under this Article to practice behavior analysis or to hold oneself out to  
44 the public as an individual practicing behavior analysis.

45 (b) Any individual not licensed in accordance with the provisions of this Article  
46 practicing behavior analysis or holding oneself out to the public as an individual practicing  
47 behavior analysis in violation of this Article is guilty of a Class 2 misdemeanor. Each violation  
48 shall count as a separate offense.

49 **"§ 90-726.17. Injunction.**

50 The Board may apply to the Superior Court of Wake County for an injunction to prevent  
51 violations of this Article or any rules enacted by the Board. The court is empowered to grant

1 injunctions regardless of whether criminal prosecution or other action has been or may be  
2 instituted as a result of the violation."

3 **SECTION 2.(b)** This section becomes effective January 1, 2022, and applies to acts  
4 committed on or after that date.

5 **SECTION 3.** Article 7 of Chapter 8 of the General Statutes is amended by adding a  
6 new section to read:

7 **"§ 8-53.14. Communications between behavior analyst and client or patient.**

8 No individual authorized as a licensed behavior analyst, or any of the individual's employees  
9 or associates, shall be required to disclose any information that the individual may have acquired  
10 in the practice of behavior analysis and which information was necessary to enable the individual  
11 to practice behavior analysis. Any resident or presiding judge in the district in which the action  
12 is pending may, subject to G.S. 8-53.6, compel disclosure, either at or before trial, if in the judge's  
13 opinion, disclosure is necessary to a proper administration of justice. If the case is in district  
14 court, the judge shall be a district court judge, and if the case is in superior court, the judge shall  
15 be a superior court judge.

16 Notwithstanding the provisions of this section, the behavior analyst–client or behavior  
17 analyst–patient privilege shall not be grounds for failure to report suspected child abuse or neglect  
18 to the appropriate county department of social services or for failure to report a disabled adult  
19 suspected to be in need of protective services to the appropriate county department of social  
20 services. Notwithstanding the provisions of this section, the behavior analyst–client or behavior  
21 analyst–patient privilege shall not be grounds for excluding any evidence of abuse, neglect,  
22 illness, or injuries of a child or for excluding any evidence regarding the abuse, neglect,  
23 exploitation, illness, or injuries of a disabled adult in any judicial proceeding related to a report  
24 pursuant to Article 3 of Chapter 7B of the General Statutes."

25 **SECTION 4.** Except where otherwise provided, this act is effective when it becomes  
26 law and applies to licenses granted or renewed on or after that date.
