Short Title: Remote Charter Academies. (Public) Sponsors: Referred to: February 21, 2023 1 A BILL TO BE ENTITLED 2 AN ACT TO PROVIDE FOR REMOTE CHARTER ACADEMIES AND TO PROVIDE A 3 ONE-YEAR EXTENSION OF THE VIRTUAL CHARTER SCHOOL PILOT PROGRAM. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1.(a)** Article 14A of Chapter 115C of the General Statutes is amended by 6 adding a new Part to read: 7 "Part 7. Remote Charter Academies. 8 "§ 115C-218.120. Remote charter academies. As part of an application or modification of a charter, a nonprofit may apply to the 9 (a) 10 State Board of Education for approval to include a remote charter academy that meets the 11 requirements of this Part as part of the nonprofit's charter. A charter that includes a remote charter academy may do any of the following: 12 13 Provide only remote instruction to enrolled students served by the charter in (1)14 accordance with this Part. 15 Provide remote instruction to students enrolled in the remote charter academy (2)and provide in-person instruction to other students served by the charter. 16 Provide enrolled students both remote instruction and in-person instruction. A 17 (3) student who receives more than half of the student's instruction through 18 remote instruction shall be classified as enrolled in the charter's remote charter 19 20 academy. 21 (b) As part of the application or modification of a charter, the nonprofit shall designate 22 which of the following enrollment areas the remote charter academy will use to enroll students: 23 A statewide remote charter academy that admits students in accordance with (1)24 G.S. 115C-218.45. 25 regional remote charter academy that, notwithstanding (2)Α G.S. 115C-218.45(a), admits students only from the county in which the 26 27 charter school facility is located and the counties of the State geographically 28 contiguous to that county. A remote charter academy provides instruction primarily online through a 29 (c) combination of synchronous and asynchronous instruction delivered to students in a remote 30 31 location outside of the charter school facility. A remote charter academy may include any 32 combination of grade levels. 33 (d) Notwithstanding G.S. 115C-84.3, an approved remote charter academy may satisfy the minimum required number of instructional days or hours for the school calendar through 34 35 remote instruction. 36 "§ 115C-218.121. The State 14 Board shall establish an application process to allow student enrollment in the selected virtual 15 charter schools beginning with the 2015-2016 school year. A virtual charter school participating 16 in the pilot may serve any grade span of students in kindergarten through twelfth grade. The pilot 17 program shall continue for a period of  $\frac{10}{10}$  11 school years and shall end with the  $\frac{2024-2025}{2024-2025}$ 18 2025-2026 school year. 19 "SECTION 8.35.(b) The virtual charter schools participating in the pilot program authorized 20 by this section shall be subject to the statutes and rules applicable to charter schools pursuant to 21 Article 14A of Chapter 115C of the General Statutes, except as follows: 22 The maximum student enrollment in any participating school shall be no (1)23 greater than 1,500 in its first year of operation and may increase by twenty 24 percent (20%) for each participating school up to a maximum student 25 enrollment of 2,592 in the fourth year of the pilot. The State Board of 26 Education may waive this maximum student enrollment threshold, beginning 27 in the fourth year of the school's operation, if the State Board determines that 28 doing so would be in the best interest of North Carolina students.for the 29 2023-2024 school year shall be the authorized student enrollment for that 30 participating school for the 2021-2022 school year plus enrollment growth of 31 up to twenty percent (20%) of that enrollment. For the remaining years of the 32 pilot, the participating schools may increase enrollment in accordance with 33 G.S. 115C-218.7(b). 34 . . . 35 "SECTION 8.35.(e) The State Board of Education shall provide State funding to a virtual 36 charter school participating in the pilot program as provided in G.S. 115C-218.105(a) and 37 G.S. 115C-218.105(b). The amount allocated pursuant to G.S. 115C-218.105(a)(1) shall not,

however, include the allocation for low-wealth counties supplemental funding and the allocation
for small county supplemental funding. Virtual charter schools participating in the pilot program
shall also be subject to the requirements in G.S. 115C-218.105(c) through G.S. 115C-218.105(e).
The amount of local funds provided to participating schools pursuant to G.S. 115C-218.105(c)
shall be the lesser of seven hundred ninety dollars (\$790.00) per pupil or the amount computed
in accordance with G.S. 115C-218.105(c).

45 **SECTION 3.(b)** A virtual charter school that participated in the pilot program 46 authorized by Section 8.35 of S.L. 2014-100, as amended by Section 8.13 of S.L. 2016-94, 47 Section 7.13 of S.L. 2018-5, Section 7.13 of S.L. 2022-74, and this section, shall be eligible to 48 apply to the State Board of Education for a charter renewal as a remote charter academy as 49 provided in Article 14A of Chapter 115C of the General Statutes.

50 **SECTION 3.(c)** This section is effective when it becomes law and applies beginning 51 with the 2023-2024 school year.
