2 AN ACT TO REORGANIZE CHAPTER 115D OF THE GENERAL STATUTES, TO MAKE  
3 VARIOUS CHANGES TO PROPRIETARY SCHOOL REQUIREMENTS, TO EXPAND  
4 THE CAREER AND COLLEGE READY GRADUATE PROGRAM, TO REQUIRE THE  
5 STATE BOARD OF COMMUNITY COLLEGES TO COMPETITIVELY SOLICIT FOR  
6 A LEARNING MANAGEMENT SYSTEM FOR ALL COMMUNITY COLLEGES, TO  
7 PROVIDE FLEXIBILITY TO FAYETTEVILLE TECHNICAL COMMUNITY COLLEGE  
8 IN ENTERING A PUBLIC/PRIVATE PARTNERSHIP TO CONSTRUCT OR  
9 RENOVATE AN EDUCATIONAL FACILITY, TO MAKE CHANGES TO THE AI  
10 SCHOOL SAFETY PILOT PROGRAM, TO MAKE CHANGES TO THE SPECIAL  
11 NEEDS PILOT PROGRAM, AND TO INCREASE THE CLASSROOM HOUR  
12 REQUIREMENT FOR MASSAGE THERAPY LICENSURE.

13 The General Assembly of North Carolina enacts:

15 **PART I. REORGANIZATION OF CHAPTER 115D**

16 **SECTION 1.(a)** Article 1 of Chapter 115D of the General Statutes reads as rewritten:

17 "Article 1.

18 "General Provisions for State Administration.

19 "Part 1. Establishment and Administration of the North Carolina Community Colleges System.

20 "**§ 115D-1. Statement of purpose.**

21 The purposes of this Chapter are to provide for the establishment, organization, and  
22 administration of a system of educational institutions throughout the State offering courses of  
23 instruction in one or more of the general areas of two-year college parallel, technical, vocational,  
24 and adult education programs, to serve as a legislative charter for such institutions, and to  
25 authorize the levying of local taxes and the issuing of local bonds for the support thereof. The  
26 major purpose of each and every institution operating under the provisions of this Chapter shall  
27 be and shall continue to be the offering of vocational and technical education and training, and  
28 of basic, high school level, academic education needed in order to profit from vocational and  
29 technical education, for students who are high school graduates or who are beyond the  
30 compulsory age limit of the public school system and who have left the public schools, provided,  
31 juveniles of any age committed to the Division of Juvenile Justice of the Department of Public  
32 Safety by a court of competent jurisdiction may, if approved by the director of the youth  
33 development center to which they are assigned, take courses offered by institutions of the system  
34 if they are otherwise qualified for admission.

2 delivering workforce development training, adult literacy training, and adult education programs  
3 in the State.

5 factor in admissions, loans, scholarships, or other educational policies.~~

6 (a) ~~For purposes of this section, the term "accreditation" shall include certification or any  
7 other similar approval process.~~

8 (b) ~~The State Board of Community Colleges shall adopt a policy that prohibits any  
9 community college from soliciting or using information regarding the accreditation of a  
10 secondary school located in North Carolina that a person attended as a factor affecting  
11 admissions, loans, scholarships, or other educational activity at the community college, unless  
12 the accreditation was conducted by a State agency.~~

15 reporting requirements.~~

17 (b) ~~The State Board of Community Colleges may approve the addition of the college  
18 transfer program to a community college. If addition of the college transfer program to an  
19 institution would require a substantial increase in funds, State Board approval shall be subject to  
20 appropriation of funds by the General Assembly for this purpose.~~

21 (c) ~~Addition of the college transfer program shall not decrease an institution's ability to  
22 provide programs within its basic mission of vocational and technical training and basic academic  
23 education.~~

24 (d) ~~The State Board of Community Colleges shall develop appropriate criteria and  
25 standards to regulate the addition of the college transfer program to institutions.~~

26 (e) ~~The State Board of Community Colleges shall develop appropriate criteria and  
27 standards to regulate the operation of college transfer programs.~~

28 (f) ~~The Board of Governors of The University of North Carolina shall report to each  
29 community college and to the State Board of Community Colleges in accordance with  
30 G.S. 116-11(10b) on the academic performance of that community college's transfer students. If  
31 the State Board of Community Colleges finds that college transfer students from a community  
32 college are not consistently performing adequately at a four-year college, the Board shall review  
33 the community college's program and determine what steps are necessary to remedy the problem.  
34 The Board shall report annually to the General Assembly on the reports it receives and on what  
35 steps it is taking to remedy problems that it finds.~~

36 (g) ~~The Community Colleges System Office shall report by April 15, 2011, and annually  
37 thereafter, to the Joint Legislative Education Oversight Committee, the State Board of Education,  
38 the Office of State Budget and Management, and the Fiscal Research Division of the General  
39 Assembly on the implementation of the UNC-NCCCS 2+2 E-Learning Initiative. This report  
40 shall include:~~

- 42 (2) ~~The total number of prospective teachers that have taken or are taking part in  
43 this initiative to date broken down by the current academic period and each of

46 school administrative unit, who have taken part in this initiative;~~
- 47 (4) ~~The change in the number of teachers available to schools since the program's  
48 inception;~~
- 49 (5) ~~The qualitative data from students, teachers, local school administrative unit  
50 personnel, university personnel, and community college personnel as to the  
51 impact of this initiative on our State's teaching pool; and~~

1           (6)     An explanation of the expenditures and collaborative programs between the  
2                 North Carolina Community College System and The University of North  
3                 Carolina, including recommendations for improvement.

4     ~~"§ 115D-5. Administration of institutions by State Board of Community Colleges;  
5             personnel exempt from North Carolina Human Resources Act; extension  
6             courses; tuition waiver; in-plant training; contracting, etc., for establishment  
7             and operation of extension units of the community college system; use of existing  
8             public school facilities.~~

9           (a)     The State Board of Community Colleges may adopt and execute such policies,  
10            regulations and standards concerning the establishment, administration, and operation of  
11            institutions as the State Board may deem necessary to insure the quality of educational programs,  
12            to promote the systematic meeting of educational needs of the State, and to provide for the  
13            equitable distribution of State and federal funds to the several institutions.

14           The State Board of Community Colleges shall establish standards and scales for salaries and  
15            allotments paid from funds administered by the State Board, and all employees of the institutions  
16            shall be exempt from the provisions of the North Carolina Human Resources Act. Any and all  
17            salary caps set by the State Board for community college presidents shall apply only to the  
18            State-paid portion of the salary. Except as otherwise provided by law, the employer contribution  
19            rate on the local-paid portion of the salary, to be paid from local funds, shall be set by the State  
20            Treasurer based on actuarial recommendations. The State Board shall have authority with respect  
21            to individual institutions: to approve sites, capital improvement projects, budgets; to approve the  
22            selection of the chief administrative officer; to establish and administer standards for professional  
23            personnel, curricula, admissions, and graduation; to regulate the awarding of degrees, diplomas,  
24            and certificates; to establish and regulate student tuition and fees within policies for tuition and  
25            fees established by the General Assembly; and to establish and regulate financial accounting  
26            procedures.

27           The State Board of Community Colleges shall require each community college to meet the  
28            faculty credential requirements of its accrediting agency for all community college programs.

29           (a1)    Notwithstanding G.S. 66-58(e)(3) or any other provisions of law, the State Board of  
30            Community Colleges may adopt rules governing the expenditure of funds derived from bookstore  
31            sales by community colleges. These expenditures shall be consistent with the mission and  
32            purpose of the Community College System. Profits may be used in the support and enhancement  
33            of the bookstores, for student aid or scholarships, for expenditures of direct benefit to students,  
34            and for other similar expenditures authorized by the board of trustees, subject to rules adopted  
35            by the State Board. These funds shall not be used to supplement salaries of any personnel.

36           (a2)    The State Board of Community Colleges shall comply with the provisions of  
37            G.S. 116-11(10a) to plan and implement an exchange of information between the public schools  
38            and the institutions of higher education in the State.

39           (a3)    The State Board of Community Colleges shall adopt the following rules to assist  
40            community colleges in their administration of procedures necessary to implement G.S. 20-11 and  
41            G.S. 20-13.2:

42           (1)     To establish the procedures a person who is or was enrolled in a community  
43                 college must follow and the requirements that person must meet to obtain a  
44                 driving eligibility certificate.

45           (2)     To require the person who is required under G.S. 20-11(n) to sign the driving  
46                 eligibility certificate to provide the certificate if he or she determines that one  
47                 of the following requirements is met:

48                 a.     The person seeking the certificate is eligible for the certificate under  
49                         G.S. 20-11(n)(1) and is not subject to G.S. 20-11(n1).

50                 b.     The person seeking the certificate is eligible for the certificate under  
51                         G.S. 20-11(n)(1) and G.S. 20-11(n1).

1           (3)    ~~To provide for an appeal through the grievance procedures established by the~~  
2           ~~board of trustees of each community college by a person who is denied a~~  
3           ~~driving eligibility certificate.~~

4           (4)    ~~To define exemplary student behavior and to define what constitutes the~~  
5           ~~successful completion of a drug or alcohol treatment counseling program.~~

6           ~~The State Board also shall develop policies as to when it is appropriate to~~  
7           ~~notify the Division of Motor Vehicles that a person who is or was enrolled in~~  
8           ~~a community college no longer meets the requirements for a driving eligibility~~  
9           ~~certificate. The State Board also shall adopt guidelines to assist the presidents~~  
10          ~~of community colleges in their designation of representatives to sign driving~~

13          ~~provide their written, irrevocable consent for a community college to disclose~~

18          ~~statutory subsection the student is no longer eligible, no other details or~~  
19          ~~information concerning the student's school record shall be released pursuant~~

21          (b)    ~~In order to make instruction as accessible as possible to all citizens, the teaching of~~  
22          ~~curricular courses and of noncurricular extension courses at convenient locations away from~~  
23          ~~institution campuses as well as on campuses is authorized and shall be encouraged. A pro rata~~  
24          ~~portion of the established regular tuition rate charged a full time student shall be charged a~~  
25          ~~part time student taking any curriculum course. In lieu of any tuition charge, the State Board of~~  
26          ~~Community Colleges shall establish a uniform registration fee, or a schedule of uniform~~  
27          ~~registration fees, to be charged students enrolling in extension courses for which instruction is~~  
28          ~~financed primarily from State funds. The State Board of Community Colleges may provide by~~  
29          ~~general and uniform regulations for waiver of tuition and registration fees for the following:~~

29 ~~The State Board shall work with the Division of Adult Correction and Juvenile Justice of the~~  
30 ~~Department of Public Safety on offering classes and programs that match the average length of~~  
31 ~~stay of an inmate in a prison facility.~~

32 ~~(c2) Courses in federal prisons shall not earn regular budget full-time equivalents, but may~~  
33 ~~be offered on a self-supporting basis.~~

34 ~~(c3) Funds appropriated for community college courses for prison inmates shall be used~~  
35 ~~only for inmates in State prisons. The first priority for the use of these funds shall be to restore~~  
36 ~~the FTE for basic skills courses to the FY 2008-2009 level. Funds not needed for this purpose~~  
37 ~~may be used for continuing education and curriculum courses related to job skills training.~~

23 school administrative unit, who have taken part in this initiative.
- 24           (4)    The change in the number of teachers available to schools since the program's  
25 inception.
- 26           (5)    The qualitative data from students, teachers, local school administrative unit  
27 personnel, university personnel, and community college personnel as to the  
28 impact of this initiative on our State's teaching pool.
- 29           (6)    An explanation of the expenditures and collaborative programs between the  
30 North Carolina Community College System and The University of North  
31 Carolina, including recommendations for improvement.

32 **"§ 115D-10.15. Workforce Development Programs.**

33       Community colleges shall assist in the preemployment and in-service training of employees  
34 in industry, business, agriculture, health occupation, and governmental agencies. Such training  
35 shall include instruction on worker safety and health standards and practices applicable to the  
36 field of employment. The State Board of Community Colleges shall make appropriate regulations  
37 including the establishment of maximum hours of instruction which may be offered at State  
38 expense in each in-plant training program. No instructor or other employee of a community  
39 college shall engage in the normal management, supervisory and operational functions of the  
40 establishment in which the instruction is offered during the hours in which the instructor or other  
41 employee is employed for instructional or educational purposes.

42 **"§ 115D-10.17. Customized Training Program.**

43       (a)    There is created within the North Carolina Community College System the  
44 Customized Training Program. The Customized Training Program shall offer programs and  
45 training services to assist new and existing business and industry to remain productive, profitable,  
46 and within the State. Before a business or industry qualifies to receive assistance under the  
47 Customized Training Program, the President of the North Carolina Community College System  
48 shall determine the following:

- 49           (1)    The business is making an appreciable capital investment.
- 50           (2)    The business is deploying new technology.

1           (3)    The business or individual is creating jobs, expanding an existing workforce,  
2                   or enhancing the productivity and profitability of the operations within the  
3                   State.

4           (4)    The skills of the workers will be enhanced by the assistance.

5       (b)    The Community Colleges System Office shall report no later than September 1 of  
6 each year to the Joint Legislative Education Oversight Committee on the following:

7           (1)    The total amount of funds received by a company under the Customized  
8                   Training Program.

9           (2)    The types of services sought by the company, whether for new, expanding, or  
10                   existing industry.

11          (3)    The amount of funds per trainee received by that company.

12          (4)    The amount of funds received per trainee by the community college delivering  
13                   the training.

14          (5)    The number of trainees trained by the company and community college.

15          (6)    The number of years that company has been funded.

16       (c)    Notwithstanding any other provision of law, the State Board of Community Colleges  
17 may adopt guidelines that allow the Customized Training Program to use funds appropriated for  
18 that program to support training projects for the various branches of the Armed Forces of the  
19 United States.

20       (d)    Funds available to the Customized Training Program shall not revert at the end of a  
21 fiscal year but shall remain available until expended. Up to ten percent (10%) of the  
22 college-delivered training expenditures and up to five percent (5%) of the contractor-delivered  
23 training expenditures for the prior fiscal year for Customized Training may be allotted to each  
24 college for capacity building at that college.

25       (e)    Of the funds appropriated in a fiscal year for the Customized Training Program, the  
26 State Board of Community Colleges may approve the use of up to eight percent (8%) for the  
27 training and support of regional community college personnel to deliver Customized Training  
28 Program services to business and industry.

29       (f)    The State Board shall adopt guidelines to implement this section. At least 20 days  
30 before the effective date of any criteria or nontechnical amendments to guidelines, the State  
31 Board must publish the proposed guidelines on the Community Colleges System Office's website  
32 and provide notice to persons who have requested notice of proposed guidelines. In addition, the  
33 State Board must accept oral and written comments on the proposed guidelines during the 15  
34 business days beginning on the first day that the State Board has completed these notifications.  
35 For the purpose of this subsection, a technical amendment is either of the following:

36           (1)    An amendment that corrects a spelling or grammatical error.

37           (2)    An amendment that makes a clarification based on public comment and could  
38                   have been anticipated by the public notice that immediately preceded the  
39                   public comment.

40    **"§ 115D-10.19. Short-Term Workforce Development Grant Program.**

41       (a)    Program Established. – There is established the North Carolina Community College  
42 Short-Term Workforce Development Grant Program (Program) to be administered by the State  
43 Board of Community Colleges. The State Board shall adopt rules for the disbursement of the  
44 grants pursuant to this section.

45       (b)    Programs of Study. – The State Board of Community Colleges, in collaboration with  
46 the Department of Commerce, shall determine the eligible programs of study for the Program,  
47 according to the occupations that are in the highest demand in the State. The eligible programs  
48 of study shall include programs such as architecture and construction, health sciences,  
49 information technology, electrical line worker, and manufacturing programs and may include  
50 other programs to meet local workforce needs.



1       (c) Award Amounts. – To the extent funds are made available for the Program, the State  
2 Board of Community Colleges shall award grants in an amount of up to seven hundred fifty  
3 dollars (\$750.00) to students pursuing short-term, noncredit State and industry workforce  
4 credentials. The State Board of Community Colleges shall establish criteria for initial and  
5 continuing eligibility for students. At a minimum, students shall be required to qualify as a  
6 resident for tuition purposes under the criteria set forth in G.S. 116-143.1 and in accordance with  
7 the coordinated and centralized residency determination process administered by the State  
8 Education Assistance Authority.

9       (d) Report. – The State Board shall submit a report by April 1 annually on the Program  
10 to the Joint Legislative Education Oversight Committee and the Fiscal Research Division. The  
11 report shall contain, for each academic year and by programs of study, the amount of grant funds  
12 disbursed and the number of eligible students receiving funds.

13 **"§ 115D-10.21. Training programs for students with intellectual and developmental**  
14 **disabilities.**

15       (a) The State Board of Community Colleges shall establish a community college training  
16 program for up to 15 community colleges. The program shall provide opportunities for  
17 micro-credentials or other credentials that lead to increased employment outcomes for  
18 individuals with intellectual and developmental disabilities (IDD). To the extent funds are  
19 appropriated for this purpose, the program shall improve the ability of participating community  
20 colleges to offer training and educational components that include improving employability skills  
21 and providing on-the-job training and apprenticeships with business and industry for individuals  
22 with IDD. The goal of the program shall be to inform community colleges and address  
23 cross-departmental supports within the individual community colleges on programs for  
24 individuals with IDD related to at least the following:

- 25           (1) Establishing best practices for providing vocational training for individuals  
26 with IDD.
- 27           (2) Providing financial and benefits counseling.
- 28           (3) Developing strategies on integrating assistive technology.
- 29           (4) Maximizing access, with supports, to credential and degree programs,  
30 including micro-credentials that are established by the State Board.
- 31           (5) Identifying methods to increase orientation and integration of individuals with  
32 IDD into the college community to the greatest extent possible.
- 33           (6) Determining a needs assessment, marketing, and evaluation to serve a broad  
34 array of individuals with developmental and other similar disabilities or  
35 learning challenges to assure adequate demand for new or existing programs.

36       (b) No later than May 1 of each year, the Community Colleges System Office shall report  
37 on the funds appropriated to the System Office for the purposes of this section to the Joint  
38 Legislative Education Oversight Committee and the Fiscal Research Division. At a minimum,  
39 the report shall address the impact of the program, the use of any additional positions created at  
40 community colleges, professional development training for staff, and funding sources identified  
41 for individuals with IDD to build programs at community colleges that support postsecondary  
42 trainings and certifications that enable individuals with IDD to engage in competitive, sustainable  
43 employment.

44 **"§ 115D-10.25. Commercial fishing and aquaculture classes.**

45       (a) The General Assembly urges all community colleges serving the coastal area of the  
46 State to offer classes on commercial fishing and aquaculture.

47       (b) The North Carolina Community Colleges System Office shall provide technical  
48 assistance to these colleges on offering such classes.

49       (c) The North Carolina Community Colleges System Office shall report to the Joint  
50 Legislative Education Oversight Committee on any fiscal and administrative issues it identifies  
51 that limit colleges' ability to offer such courses.

1 **"§ 115D-10.30. Correction education programs.**

2 (a) Approval. – No course of instruction shall be offered by any community college at  
3 State expense or partial State expense to any captive or co-opted group of students, as defined by  
4 the State Board of Community Colleges, without prior approval of the State Board. All course  
5 offerings approved for State prison inmates or prisoners in local jails must be tied to clearly  
6 identified job skills, transition needs, or both. Approval by the State Board shall be presumed to  
7 constitute approval of both the course and the group served by that institution. The State Board  
8 may delegate to the President the power to make an initial approval, with final approval to be  
9 made by the State Board. A course taught without such approval will not yield any full-time  
10 equivalent students, as defined by the State Board. Community colleges shall report full-time  
11 equivalent (FTE) student hours for correction education programs on the basis of student  
12 membership hours. Funds appropriated for community college courses for prison inmates shall  
13 be used only for inmates in State prisons. The first priority for the use of these funds shall be to  
14 restore the FTE for basic skills courses to the FY 2008-2009 level. Funds not needed for this  
15 purpose may be used for continuing education and curriculum courses related to job skills  
16 training. No community college shall operate a multi-entry/multi-exit class or program in a prison  
17 facility, except for a literacy class or program. The State Board shall work with the Division of  
18 Adult Correction and Juvenile Justice of the Department of Public Safety on offering classes and  
19 programs that match the average length of stay of an inmate in a prison facility.

20 (b) Courses in Federal Prisons. – Courses in federal prisons shall not earn regular budget  
21 full-time equivalents but may be offered on a self-supporting basis.

22 **"§ 115D-10.35. Teacher residency licensure courses.**

23 The North Carolina Community College System may offer courses, in accordance with  
24 Article 17D of Subchapter V of Chapter 115C of the General Statutes, to individuals who choose  
25 to enter the teaching profession through residency licensure.

26 **"§ 115D-10.40. American Sign Language courses.**

27 The State Board of Community Colleges shall develop curriculum and continuing education  
28 standards for courses of instruction in American Sign Language and shall encourage community  
29 colleges to offer courses in American Sign Language as a modern foreign language.

30 **"§ 115D-10.45. Adult high school equivalency diploma test.**

31 The State Board of Community Colleges may establish, retain, and budget fees charged to  
32 students taking an adult high school equivalency diploma test, including fees for retesting. Fees  
33 collected for this purpose shall be used only to (i) offset the costs of the test, including the cost  
34 of scoring the test, (ii) offset the costs of printing adult high school equivalency diplomas, and  
35 (iii) meet federal and State reporting requirements related to the test.

36 **"§ 115D-10.50. Motorcycle Safety Instruction Program.**

37 (a) There is created a Motorcycle Safety Instruction Program for the purpose of  
38 establishing statewide motorcycle safety instruction to be delivered through the Community  
39 Colleges System Office. The Program may be administered by a motorcycle safety coordinator  
40 who shall be responsible for the planning, curriculum, and completion requirements of the  
41 Program. The State Board of Community Colleges may elect a motorcycle safety coordinator  
42 upon nomination of the President of the Community College System, and the compensation of  
43 the motorcycle safety coordinator shall be fixed by the State Board upon recommendation of the  
44 President of the Community College System pursuant to G.S. 115D-3. The State Board of  
45 Community Colleges may contract with an appropriate public or private agency or person to  
46 carry out the duties of the motorcycle safety coordinator.

47 (b) The Motorcycle Safety Instruction Program shall be implemented through the  
48 Community Colleges System Office at institutions which choose to provide the Program. The  
49 motorcycle safety coordinator shall select and facilitate the training and certification of  
50 instructors who will implement the Program.

51 "Part 4. Students.

1 **"§ 115D-10.65. Accreditation of secondary school located in North Carolina shall not be a**  
2 **factor in admissions, loans, scholarships, or other educational policies.**

3 (a) For purposes of this section, the term "accreditation" shall include certification or any  
4 other similar approval process.

5 (b) The State Board of Community Colleges shall adopt a policy that prohibits any  
6 community college from soliciting or using information regarding the accreditation of a  
7 secondary school located in North Carolina that a person attended as a factor affecting  
8 admissions, loans, scholarships, or other educational activity at the community college, unless  
9 the accreditation was conducted by a State agency.

10 **"§ 115D-10.70. Driving eligibility certificates.**

11 (a) The State Board of Community Colleges shall adopt the following rules to assist  
12 community colleges in their administration of procedures necessary to implement G.S. 20-11 and  
13 G.S. 20-13.2:

14 (1) To establish the procedures a person who is or was enrolled in a community  
15 college must follow and the requirements that person must meet to obtain a  
16 driving eligibility certificate.

17 (2) To require the person who is required under G.S. 20-11(n) to sign the driving  
18 eligibility certificate to provide the certificate if he or she determines that one  
19 of the following requirements is met:

20 a. The person seeking the certificate is eligible for the certificate under  
21 G.S. 20-11(n)(1) and is not subject to G.S. 20-11(n1).

22 b. The person seeking the certificate is eligible for the certificate under  
23 G.S. 20-11(n)(1) and G.S. 20-11(n1).

24 (3) To provide for an appeal through the grievance procedures established by the  
25 board of trustees of each community college by a person who is denied a  
26 driving eligibility certificate.

27 (4) To define exemplary student behavior and to define what constitutes the  
28 successful completion of a drug or alcohol treatment counseling program.

29 (b) The State Board shall develop policies as to when it is appropriate to notify the  
30 Division of Motor Vehicles that a person who is or was enrolled in a community college no  
31 longer meets the requirements for a driving eligibility certificate. The State Board also shall adopt  
32 guidelines to assist the presidents of community colleges in their designation of representatives  
33 to sign driving eligibility certificates.

34 (c) The State Board shall develop a form for the appropriate individuals to provide their  
35 written, irrevocable consent for a community college to disclose to the Division of Motor  
36 Vehicles that the student no longer meets the conditions for a driving eligibility certificate under  
37 G.S. 20-11(n)(1) or G.S. 20-11(n1), if applicable, in the event that this disclosure is necessary to  
38 comply with G.S. 20-11 or G.S. 20-13.2. Other than identifying under which statutory subsection  
39 the student is no longer eligible, no other details or information concerning the student's school  
40 record shall be released pursuant to this consent.

41 **"§ 115D-10.75. Excused absences for religious observances.**

42 The State Board of Community Colleges shall direct each community college to adopt a  
43 policy that authorizes a minimum of two excused absences each academic year for religious  
44 observances required by the faith of a student. The policy may require that the student provide  
45 written notice of the request for an excused absence a reasonable time prior to the religious  
46 observance. The policy shall also provide that the student shall be given the opportunity to make  
47 up any tests or other work missed due to an excused absence for a religious observance.

48 **"§ 115D-10.76. Excused absences for National Guard service members.**

49 The State Board of Community Colleges shall adopt a policy to be applied uniformly  
50 throughout the Community College System to provide that any student enrolled in a community  
51 college who is a National Guard service member placed onto State active duty status during an

1 academic term shall be given an excused absence for the period of time the student is on active  
 2 duty. The policy shall further provide all of the following:

- 3       (1) The student shall be given the opportunity to make up any test or other work  
 4 missed during the excused absence.
- 5       (2) The student shall be given the option, when feasible, to continue classes and  
 6 coursework during the academic term through online participation for the  
 7 period of time the student is placed on active duty.
- 8       (3) The student shall be given the option of receiving a temporary grade of  
 9 "incomplete (IN)" or "absent from the final exam (AB)" for any course that  
 10 the student was unable to complete as a result of being placed on State active  
 11 duty status; however, the student must complete the course requirements  
 12 within the period of time specified by the community college to avoid  
 13 receiving a failing grade for the course.
- 14       (4) The student shall be permitted to drop, with no penalty, any course that the  
 15 student was unable to complete as a result of being placed on State active duty  
 16 status."

 22 youth 15 years and older may be permitted to enroll in courses,  
 23 including certification-eligible courses, in fire training pursuant to  
 24 G.S. 95-25.5(n) and on a specialized course list approved by the State  
 25 Board of Community Colleges in accordance with  
 26 G.S. 115D-5(b)(2)."

27 **SECTION 1.(c)** Article 2 of Chapter 115D of the General Statutes is amended by

47 (c) Accreditation Transfer Procedure. – A community college that pursues accreditation

25                   Colleges, in conjunction with the State Board of Education and the Board of Governors of The

40                   students enrolled in courses through cooperative innovative high schools, the  
41                   College Transfer pathway, and the Career and Technical Education pathway.  
42                   (3)     Any additional costs of a student attending courses on campus if a student is  
43                   not attending public school in a local school administrative unit for the  
44                   majority of the student's instructional time.

45                   (c)     Report. – The Boards shall jointly report by March 15 of each year to the Joint  
46                   Legislative Education Oversight Committee, the Senate Appropriations Committee on  
47                   Education/Higher Education, the House Appropriations Committee on Education, and the Fiscal  
48                   Research Division of the General Assembly. The report shall be combined with the evaluation  
49                   of cooperative innovative high schools required by G.S. 115C-238.55, and the Community  
50                   Colleges System Office shall be responsible for submitting the combined report.

51                   **"§ 115D-30.10. Cooperative innovative high schools.**

1 Subject to the approval of the State Board of Community Colleges, local community colleges  
2 may collaborate with local school administrative units to offer cooperative innovative high  
3 school programs, as provided by Part 9 of Article 16 of Chapter 115C of the General Statutes.

4 **"§ 115D-30.15. Noncredit courses.**

5 Subject to rules adopted by the State Board of Community Colleges, local community  
6 colleges may provide for the following:

- 7 (1) During the summer quarter, persons less than 16 years old may be permitted  
8 to take noncredit courses on a self-supporting basis.
- 9 (2) High school students may be permitted to take noncredit courses in safe  
10 driving on a self-supporting basis during the academic year or the summer.
- 11 (3) High school students 16 years and older may be permitted to take noncredit  
12 courses, except adult basic skills.
- 13 (4) Notwithstanding any other provision of this Article, qualified youth 15 years  
14 and older may be permitted to enroll in courses, including  
15 certification-eligible courses, in fire training pursuant to G.S. 95-25.5(n) and  
16 on a specialized course list approved by the State Board of Community  
17 Colleges in accordance with G.S. 115D-30.1.

18 **"§ 115D-30.20. Gateway to College Program.**

19 The purpose of the first semester of the Gateway to College Program is to address additional  
20 support to successfully complete the Program. Students may need to take developmental courses  
21 necessary for the transition to more challenging courses; therefore, the State Board of Community  
22 Colleges shall (i) permit high school students who are enrolled in Gateway to College Programs  
23 to enroll in developmental courses based on an assessment of their individual student needs by a  
24 high school and community college staff team and (ii) include this coursework in computing the  
25 budget FTE for the colleges.

26 **"§ 115D-30.25. NC Career Coach Program.**

27 (a) Purpose. – There is established the NC Career Coach Program to place community  
28 college career coaches in high schools to assist students with determining career goals and  
29 identifying community college programs that would enable students to achieve these goals.

30 (b) Memorandum of Understanding. – The board of trustees of a community college and  
31 a local board of education of a local school administrative unit within the service area of the  
32 community college shall enter into a memorandum of understanding for the placement of career  
33 coaches employed by the board of trustees of the community college in schools within the local  
34 school administrative unit. At a minimum, the memorandum of understanding shall include the  
35 following:

- 36 (1) Requirement that the community college provides the following:
  - 37 a. Hiring, training, and supervision of career coaches. The board of  
38 trustees may include a local board of education liaison on the hiring  
39 committee to participate in the decision making regarding hiring for  
40 the coach positions.
  - 41 b. Salary, benefits, and all other expenses related to the employment of  
42 the career coach. The coach will be an employee of the board of  
43 trustees and will not be an agent or employee of the local board of  
44 education.
  - 45 c. Development of pedagogical materials and technologies needed to  
46 enhance the advising process.
  - 47 d. Criminal background checks required by the local school  
48 administrative unit for employees working directly with students.
  - 49 e. Agreement that, while on any school campus, the career coach will  
50 obey all local board of education rules and will be subject to the  
51 authority of the school building administration.



- 1           (2)   Requirement that the local school administrative unit provides the following  
2           to career coaches:  
3           a.     Access to student records, as needed to carry out the coach's job  
4           responsibilities.  
5           b.     Office space on site appropriate for student advising.  
6           c.     Information technology resources, including, but not limited to,  
7           internet access, telephone, and copying.  
8           d.     Initial school orientation and ongoing integration into the faculty and  
9           staff community.  
10          e.     Promotion of school-wide awareness of coach duties.  
11          f.     Facilitation of the coach's access to individual classes and larger  
12          assemblies for the purposes of awareness-building.

13          (c)   Application for NC Career Coach Program Funding. – The board of trustees of a  
14          community college and a local board of education of a local school administrative unit within the  
15          service area of the community college jointly may apply for available funds for NC Career Coach  
16          Program funding from the State Board of Community Colleges. The State Board of Community  
17          Colleges shall establish a process for award of funds as follows:

- 18           (1)   Advisory committee. – Establishment of an advisory committee, which shall  
19           include representatives from the NC Community College System, the  
20           Department of Public Instruction, the Department of Commerce, and at least  
21           three representatives of the business community, to review applications and  
22           make recommendations for funding awards to the State Board.

- 23           (2)   Application submission requirements. – The State Board of Community  
24           Colleges shall require at least the following:

- 25           a.     Evidence of a signed memorandum of understanding that meets, at a  
26           minimum, the requirements of this section.  
27           b.     Evidence that the funding request will be matched with local funds in

- 29                   1.     Matching funds may come from public or private sources.  
30                   2.     The match amount shall be determined based on the  
31                   development tier designation of the county in which the local  
32                   school administrative unit is located where the career coach is  
33                   assigned on the date of the award of funds by the State Board  
34                   of Community Colleges according to the following:  
35                   I.     If located in a tier one county as defined in  
36                   G.S. 143B-437.08, no local match shall be required.  
37                   II.    If located in a tier two county as defined in  
38                   G.S. 143B-437.08, one dollar (\$1.00) of local funds for  
39                   every two dollars (\$2.00) in State funds shall be  
40                   required.  
41                   III.   If located in a tier three county as defined in  
42                   G.S. 143B-437.08, one dollar (\$1.00) of local funds for  
43                   every one dollar (\$1.00) in State funds shall be  
44                   required.

- 45           (3)   Awards criteria. – The State Board of Community Colleges shall develop  
46           criteria for consideration in determining the award of funds that shall include  
47           the following:

- 48           a.     Consideration of the workforce needs of business and industry in the  
49           region.  
50           b.     Targeting of resources to enhance ongoing economic activity within  
51           the community college service area and surrounding counties.

- 1                   c.     Geographic diversity of awards.
- 2     (d)     Annual Report. –
- 3             (1)     The board of trustees of a community college that employs one or more career
- 4                   coaches shall report annually to the State Board of Community Colleges on
- 5                   implementation and outcomes of the Program, including the following
- 6                   information:
- 7                   a.     Number of career coaches employed.
- 8                   b.     Number of local school administrative units served and names of
- 9                   schools in which career coaches are placed.
- 10                  c.     Number of students annually counselled by career coaches.
- 11                  d.     Impact of career coaches on student choices, as determined by a valid
- 12                   measure selected by the State Board of Community Colleges.
- 13             (2)     The State Board of Community Colleges shall report annually no later than
- 14                   October 1 to the Joint Legislative Education Oversight Committee on the
- 15                   following:
- 16                   a.     A compilation of the information reported by the board of trustees of
- 17                   community colleges, as provided in subdivision (1) of this subsection.
- 18                   b.     Number and names of partnership applicants for NC Career Coach
- 19                   Program funding.
- 20                   c.     Number, names, and amounts of those awarded NC Career Coach
- 21                   Program funding."

22             **SECTION 1.(g)** G.S. 115D-39, 115D-39.1, 115D-40.1, and 115D-40.5 are codified

23 into Part 2 of Article 3 of Chapter 115D of the General Statutes, which shall be entitled "Tuition

33 the established regular tuition rate charged a full-time student shall be charged a part-time student

34 taking any curriculum course. In lieu of any tuition charge, the State Board of Community

35 Colleges shall establish a uniform registration fee, or a schedule of uniform registration fees, to

36 be charged students enrolling in extension courses for which instruction is financed primarily

37 from State funds.

38 **"§ 115D-39.5. Tuition waivers.**

- 1           e.     Law enforcement, fire, or EMS or rescue and lifesaving entities  
2           servng a lake authority that was created by a county board of  
3           commissioners prior to July 1, 2012.
- 4           f.     Radio Emergency Associated Communications Teams (REACT)  
5           under contract to a county as an emergency response agency.
- 6           g.     Municipal, county, or State law enforcement agencies.
- 7           h.     Campus police agencies of private institutions of higher education  
8           certified by the Attorney General pursuant to Chapter 74G of the  
9           General Statutes.
- 10          i.     The Division of Prisons of the Department of Adult Correction and the  
11          Division of Juvenile Justice of the Department of Public Safety for the  
12          training of full-time custodial employees and employees of the  
13          Divisions required to be certified under Article 1 of Chapter 17C of  
14          the General Statutes and the rules of the Criminal Justice and Training  
15          Standards Commission.
- 16          j.     The Eastern Band of Cherokee Indians law enforcement, fire, or EMS  
17          or rescue and lifesaving tribal government departments or programs.
- 18          k.     The Criminal Justice Standards Division of the Department of Justice  
19          for the training of criminal justice professionals, as defined in  
20          G.S. 17C-20(6), who are required to be certified under (i) Article 1 of  
21          Chapter 17C of the General Statutes and the rules of the North  
22          Carolina Criminal Justice Education and Training Standards  
23          Commission or (ii) Chapter 17E of the General Statutes and the rules  
24          of the North Carolina Sheriffs' Education and Training Standards  
25          Commission. The waivers provided for in this sub-subdivision apply  
26          to participants and recent graduates of the North Carolina Criminal  
27          Justice Fellows Program to obtain certifications for eligible criminal  
28          justice professions as defined in G.S. 17C-20(6).
- 29          (3)    Firefighters, EMS personnel, and rescue and lifesaving personnel whose duty  
30          station is located on a military installation within North Carolina for courses  
31          that support their organizations' training needs and are approved for this  
32          purpose by the State Board.
- 33          (4)    Trainees enrolled in courses conducted under the Customized Training  
34          Program.
- 35          (5)    Elementary and secondary school employees enrolled in courses in first aid or  
36          cardiopulmonary resuscitation (CPR).
- 37          (6)    All courses taken by high school students at community colleges, in  
38          accordance with this section and Article 2B of this Chapter.
- 39          (7)    Human resources development courses for any individual who (i) is  
40          unemployed, (ii) has received notification of a pending layoff, (iii) is working  
41          and is eligible for the Federal Earned Income Tax Credit (FEITC), or (iv) is  
42          working and earning wages at or below two hundred percent (200%) of the  
43          federal poverty guidelines.
- 44          (8)    Courses providing employability skills, job-specific occupational or technical  
45          skills, or developmental education instruction to certain students who are  
46          concurrently enrolled in an eligible community college literacy course, in  
47          accordance with rules adopted by the State Board.
- 48          (9)    Courses provided to students who are participating in a pre-apprenticeship or  
49          apprenticeship program that meets all of the following criteria:
- 50           a.     Meets one of the following:

- 1                   1.     Is a registered apprenticeship program recognized by the  
 2                   United States Department of Labor.  
 3                   2.     Is a pre-apprenticeship program recognized and approved by  
 4                   the State agency administering the statewide apprenticeship  
 5                   program.  
 6                   b.     Has a documented plan of study with courses relating to a job-specific  
 7                   occupational or technical skill.  
 8                   c.     Requires the participants in the program to be North Carolina high  
 9                   school students when entering the program.  
 10                (b)    Faculty and Staff. – The State Board shall not waive tuition and registration fees for  
 11                community college faculty or staff members. Community colleges may, however, use State or  
 12                local funds to pay tuition and registration fees for one course per semester for full-time  
 13                community college faculty or staff members employed for a nine-, 10-, 11-, or 12-month term.  
 14                Community colleges may also use State and local funds to pay tuition and registration fees for  
 15                professional development courses and for other courses consistent with the academic assistance  
 16                program authorized by the State Human Resources Commission.  
 17                (c)    Annual Report. – Annually by February 1, the Community Colleges System Office  
 18                shall report to the Joint Legislative Education Oversight Committee on the number and type of  
 19                waivers granted pursuant to subsection (a) of this section."  
 20                **SECTION 1.(i)** G.S. 115D-41 is recodified as G.S. 115D-38.5.  
 21                **SECTION 1.(j)** G.S. 115D-43 is recodified as G.S. 115D-38.10.

26 Legislative Education Oversight Committee, the Senate Appropriations Committee on  
27 Education/Higher Education, the House Appropriations Committee on Education, and the Fiscal  
28 Research Division of the General Assembly on the evaluation of these schools. The report shall  
29 be combined with the evaluation of and analysis of cost of students participating in the Career  
30 and College Promise Program required by ~~G.S. 115D-5(x)~~ G.S. 115D-30.5, and the Community  
31 Colleges System Office shall be responsible for submitting the combined report."

32 **SECTION 2.(k)** G.S. 115D-2(2) reads as rewritten:

33 "(2) The term "community college" is defined as an educational institution  
34 operating under the provisions of this Chapter and dedicated primarily to the  
35 educational needs of the service area which it serves, and may offer any of the  
36 following:

- 37 a. The freshmen and sophomore courses of a college of arts and sciences,  
38 authorized by ~~G.S. 115D-4.1~~ G.S. 115D-10.10.
- 39 b. Organized credit curricula for the training of technicians; curricular  
40 courses may carry transfer credit to a senior college or university  
41 where the course is comparable in content and quality and is  
42 appropriate to a chosen course of ~~study~~ study.
- 43 c. Vocational, trade, and technical specialty courses and ~~programs,~~  
44 and programs.
- 45 d. Courses in general adult education."

46 **SECTION 2.(l)** G.S. 115D-39(a1) reads as rewritten:

47 "(a1) In addition, federal law enforcement officers, firefighters, EMS personnel, and rescue  
48 and lifesaving personnel whose permanent duty station is within North Carolina and who do not  
49 otherwise qualify for tuition waivers under ~~G.S. 115D-5(b)(2a)~~ G.S. 115D-39.5(a)(3) shall also  
50 be eligible for the State resident community college tuition rate for courses that support their

1 organizations' training needs and are approved for this purpose by the State Board of Community  
2 Colleges."

3 **SECTION 2.(m)** G.S. 115D-41(a) reads as rewritten:

4 "(a) Community college contracts with local school administrative units shall not be used  
5 by these agencies to supplant funding for a public school high school teacher providing courses  
6 offered pursuant to ~~G.S. 115D-20(4)~~ Article 2B of this Chapter who is already employed by the  
7 local school administrative unit. In no event shall a community college contract with a local  
8 school administrative unit to provide high school level courses."

9 **SECTION 2.(n)** Article 6A of Chapter 115D of the General Statutes is repealed.

10 **SECTION 2.(o)** G.S. 116-201(b)(8) reads as rewritten:

11 "(8) "Private institution" means an institution other than a seminary, Bible school,

14 combination thereof, that offers post-high school education and is accredited

16 and G.S. 116-11.4, or the Transnational Association of Christian Colleges and  
17 Schools, or, in the case of institutions that are not eligible to be considered for  
18 accreditation, accredited in those categories and by those nationally  
19 recognized accrediting agencies that the Authority may designate;"

20 **SECTION 2.(p)** G.S. 116-280(3) reads as rewritten:

21 "(3) Eligible private postsecondary institution. – A school that is any of the  
22 following:

23 a. A nonprofit postsecondary educational institution with a main  
24 permanent campus located in this State that is not owned or operated  
25 by the State of North Carolina or by an agency or political subdivision  
26 of the State or by any combination thereof that satisfies all of the  
27 following:

28 1. Is either (i) accredited by a regional accrediting agency, as  
29 defined in ~~G.S. 115D-6.2~~ G.S. 115D-21.2 and G.S. 116-11.4,  
30 or the Transnational Association of Christian Colleges and  
31 Schools or (ii) was accredited by ~~SACSCOC~~ the Southern  
32 Association of Colleges and Schools Commission on Colleges  
33 on January 1, 2021, and, beginning January 1, 2021, was a  
34 member of the Transnational Association of Christian Colleges  
35 and Schools.

36 2. Awards a postsecondary degree as defined in G.S. 116-15.

37 b. A postsecondary institution owned or operated by a hospital authority  
38 as defined in G.S. 131E-16(14) or school of nursing affiliated with a  
39 nonprofit postsecondary educational institution as defined in  
40 sub-subdivision a. of this subsection."

41 **SECTION 2.(q)** G.S. 126-5(c2)(3) reads as rewritten:

42 "(3) Employees of community colleges whose salaries are fixed in accordance with  
43 ~~G.S. 115D-5~~ G.S. 115D-6.1 and G.S. 115D-20 and employees of the  
44 Community Colleges System Office whose salaries are fixed by the State  
45 Board of Community Colleges in accordance with G.S. 115D-3."

46 **SECTION 2.(r)** Section 6.9(b) of S.L. 2023-134 reads as rewritten:

47 "**SECTION 6.9.(b)** Of the recurring funds appropriated in this act to the Community  
48 Colleges System Office for the 2023-2025 fiscal biennium to support increasing program  
49 offerings for individuals with IDD pursuant to ~~G.S. 115D-44~~, ~~as enacted by this section,~~  
50 G.S. 115D-10.21, the System Office shall establish at least two statewide positions for program  
51 support, provide professional development training for college advising staff to assist students



1 with IDD for career pathway exploration and the identification of credentials leading to

### 5 PART III. PROPRIETARY SCHOOLS CHANGES

6 **SECTION 3.(a)** G.S. 115D-89.1(b) reads as rewritten:

7 "(b) The State Board of Proprietary Schools shall consist of seven members as follows:

- 8 (1) The President of the North Carolina Community College System or the  
 9 President's designee.
- 10 (2) Two members appointed by the Governor.
- 11 (3) Two members appointed by the General Assembly upon the recommendation  
 12 of the President Pro Tempore of the Senate, one of whom shall be the owner  
 13 or director of a proprietary school licensed in the State with less than 100 total  
 14 annual enrollment of students and one the owner or director of a proprietary  
 15 school or group of proprietary schools licensed in the State with ~~more than~~  
 16 750-100 or more total annual enrollment of students.
- 17 (4) Two members appointed by the General Assembly upon the recommendation  
 18 of the Speaker of the House of Representatives, one of whom shall be the  
 19 owner or director of a proprietary school licensed in the State with ~~between~~  
 20 less than 100 and 750 total annual enrollment of students and one the owner  
 21 or director of a proprietary school or group of proprietary schools licensed in  
 22 the ~~State~~ State with 100 or more total annual enrollment of students.

23 The appointing authorities shall appoint members who have a demonstrated history of  
 24 experience in proprietary or public postsecondary education, an understanding of standards of  
 25 quality in postsecondary education, and leadership beyond a particular institution."

26 **SECTION 3.(b)** G.S. 115D-90(b) reads as rewritten:

27 "(b) Application for a license shall be filed in the manner and upon the forms prescribed  
 28 and furnished by the State Board of Proprietary Schools for that purpose. Such application shall  
 29 be signed by the applicant and properly verified and shall contain such of the following  
 30 information as may apply to the particular school for which a license is sought:

31 ...

- 32 (7) Such additional information as the State Board, acting by and through the  
 33 State Board of Proprietary Schools, may deem necessary to enable it to  
 34 determine the adequacy of the program of instruction and matters pertaining  
 35 thereto. Each application shall be accompanied by a copy of the current  
 36 bulletin or catalog of the school which shall be in published form and certified  
 37 by an authorized official of the school as being current, true, and correct in  
 38 content and policy. The school bulletin shall contain the following  
 39 information:

40 ...

- 41 i. Policy and regulations of the institution relative to the refund of the  
 42 unused portion of tuition, fees and other charges in the event the  
 43 student does not enter the course or withdraws or is discontinued  
 44 therefrom. The policy and regulations shall comply with federal law  
 45 and provide for, at a minimum, a full refund if a student withdraws  
 46 before the first day of class or the school cancels the class and a  
 47 seventy five percent (75%) refund if the student withdraws within the  
 48 first twenty five percent (25%) of the period of enrollment for which  
 49 the student was charged. the following provisions to the extent those  
 50 provisions are not inconsistent with federal law:

1. If any of the following occur prior to the first day of class, a student shall receive a one hundred percent (100%) refund, including nonrefundable fees already paid:
  - I. The student withdraws.
  - II. The student is caused to withdraw by the school.
  - III. The school cancels the class.
2. If the student withdraws or is caused to withdraw by the school on or before completing twenty-five percent (25%) of the period of enrollment for which the student was charged, the student shall receive a refund of seventy-five percent (75%), excluding any disclosed nonrefundable fees.

...."

**SECTION 3.(c)** G.S. 115D-95(b) reads as rewritten:

"(b) Amount. – An applicant for a license must file a bond with the North Carolina State Board of Community Colleges executed by the applicant as a principal and by a bonding company authorized to do business in this State. The bond must be payable to the State Board of Community Colleges, must be conditioned on fulfillment of the school's obligations, and must remain in effect until cancelled by the bonding company. The bonding company may cancel the bond upon 30 days' notice to the State Board of Community Colleges.

The application must set out calculations made by the applicant to determine the amount of bond required with the application. The required amount is determined as follows:

- (1) Initial licensure. – For an applicant for initial licensure of a school, the bond amount is the amount determined by the State Board that is adequate to provide indemnification to any student, or the student's parent or guardian who has suffered a loss of tuition, fees, or any other instructional-related expenses paid to the school. A bond amount shall be at least twenty-five thousand dollars (\$25,000).
- (2) ~~First four renewals.~~ Renewal of licensure. – ~~For a school that has been licensed for one year but less than six years, For an applicant for renewal of licensure of a school, the bond shall be in an amount equal to the greatest amount of unearned paid tuition in the school's possession at anytime any time during the prior fiscal year.~~
- (2a) Evaluations. – Bond amounts shall be evaluated as follows:
  - a. ~~The~~ For a school that has been licensed for one year, but less than six years, the bond amount shall be evaluated by the school quarterly and reported to the State Board or its representative. For a school that has been licensed for six years or more, if the State Board deems an evaluation necessary, the State Board may require the bond amount to be evaluated by the school quarterly and reported to the State Board or its representative.
  - b. A quarterly evaluation requiring an increase of five percent (5%) or more in the amount of the bond held by the school shall require an immediate increase in the bond amount.
  - c. Bond amounts ~~also~~ shall be evaluated pursuant to this subdivision and the rules of the State Board of Community Colleges and State Board of Proprietary Schools at the time of the school's annual license renewal and increased if necessary regardless of the amount of the change.
- (3) ~~Schools in operation more than five years. — A guaranty bond shall be required for license renewal for a school that has been continuously licensed to operate for more than five years in the State, as follows:~~

- a. ~~If the balance of the Student Protection Fund in G.S. 115D-95.1 is below the catastrophic loss amount, the school shall file a guaranty bond in an amount equal to the maximum amount of prepaid tuition held by the school during the prior fiscal year multiplied by the percentage amount the fund is deficient.~~
- b. ~~If the school held prepaid tuition in excess of the Student Protection Fund catastrophic loss amount during the prior fiscal year, in addition to any bond amount required by sub-subdivision a. of this subdivision, the school shall file a guaranty bond for the difference between the prepaid tuition amount held in the previous fiscal year and the Fund catastrophic loss amount."~~

**SECTION 3.(d)** G.S. 115D-95.1 reads as rewritten:

**"§ 115D-95.1. Student Protection Fund.**

(a) Definitions. – As used in this section:

- (1) "Catastrophic loss amount" means the amount of funds required to protect prepaid student tuition in case of a large-scale event that would draw against the Student Protection Fund. The amount is ~~one million dollars (\$1,000,000)~~one million five hundred thousand dollars (\$1,500,000).
- (2) "Fund cap amount" means the catastrophic loss amount plus a reserve amount. The amount is ~~one million five hundred thousand dollars (\$1,500,000)~~two million dollars (\$2,000,000).

...

(f) Suspension of Payments. – ~~If the Student Protection Fund balance is equal to or exceeds the Fund cap amount, the State Board of Proprietary Schools shall suspend payments into the Fund for schools that have been continuously licensed in the State for more than eight years. The State Board of Proprietary Schools shall require schools to resume payments into the Fund if the balance of the Fund is less than the catastrophic loss amount. The State Board of Proprietary Schools shall suspend payments into the Fund, as follows:~~

- (1) For schools that are currently licensed in this State, if the Student Protection Fund balance is equal to or exceeds the catastrophic loss amount.
- (2) For schools applying for initial licensure with the State, if the Student Protection Fund balance is equal to or exceeds the fund cap amount.
- (3) If the Student Protection Fund balance decreases below the catastrophic loss amount, the State Board shall reinstate the requirement for schools to make payments into the Fund.

...."

**SECTION 3.(e)** Subsection (a) of this section applies beginning with appointments made on or after the date this act becomes law. Subsection (b) of this section becomes effective July 1, 2024, and applies to licenses issued or renewed on or after that date. Subsections (c) and (d) of this section become effective July 1, 2025, and apply to licenses issued or renewed on or after that date. Except as otherwise provided, this section becomes effective July 1, 2024.

**PART IV. EXPAND CAREER AND COLLEGE READY GRADUATE PROGRAM**

**SECTION 4.** Section 10.13(a) of S.L. 2015-241, as amended by Section 10.5 of S.L. 2016-94 and Section 9.4 of S.L. 2018-5, reads as rewritten:

**"SECTION 10.13.(a)** The State Board of Community Colleges, in consultation with the State Board of Education, shall develop a program for implementation beginning with model programs in the 2016-2017 school year that introduces the college developmental mathematics and developmental reading and English curriculums in the high school senior ~~year-year, including the immediately preceding summer,~~ and provides opportunities for college remediation for students prior to high school graduation through cooperation with community college partners.

1 Professional development for high school faculty shall begin with the 2018-2019 school year.  
2 The program shall be phased in by cohorts developed by the Department of Public Instruction  
3 beginning with the 2019-2020 school year. The program shall be fully implemented in all high  
4 schools statewide beginning with the 2020-2021 school year."  
5

#### 6 **PART V. LEARNING MANAGEMENT SYSTEM**

7 **SECTION 5.(a)** The State Board of Community Colleges shall conduct a  
8 competitive solicitation, including a request for information or a request for proposals, to provide  
9 a learning management system to all community colleges. The competitive solicitation shall be  
10 completed by April 1, 2025. Answers to the competitive solicitation shall include information on  
11 how the learning management system would align with the learning management systems (i)  
12 offered by the Department of Public Instruction to local school administrative units and (ii) used  
13 by the constituent institutions of The University of North Carolina.

14 **SECTION 5.(b)** By April 1, 2025, the State Board shall report to the Senate  
15 Appropriations Committee on Education/Higher Education, the House Appropriations  
16 Committee on Education, and the Fiscal Research Division on the information received.  
17

#### 18 **PART VI. FAYETTEVILLE TECHNICAL COMMUNITY COLLEGE** 19 **PUBLIC/PRIVATE PARTNERSHIP**

20 **SECTION 6.** Notwithstanding G.S. 115D-15(a), 115D-20(13)a. through c. and g.,  
21 143-129, and 143-341, the Board of Trustees of Fayetteville Technical Community College  
22 (Board of Trustees) may enter into a public/private partnership with an automotive services  
23 company (Company) to provide for construction on or renovations to real property located at  
24 3211 Fort Bragg Road in Fayetteville, North Carolina (Facility). The following terms shall apply  
25 to the public/private partnership:

- 26 (1) Title to the real property remains with the Board of Trustees.
- 27 (2) The Company shall incur at least eighty percent (80%) of the cost of  
28 constructing or renovating the Facility. State funds shall not be used for the  
29 construction or renovation of the Facility.
- 30 (3) The Company is authorized to select its own designer, architect, and general  
31 contractor to perform the construction or renovations. All construction or  
32 renovations shall be done in accordance with the relevant building codes.
- 33 (4) The Board of Trustees is authorized to lease the Facility to the Company for  
34 a term of 10 years without a monthly rental rate.
- 35 (5) The Company may use up to twenty-five percent (25%) of the Facility to  
36 operate a retail establishment while leasing the Facility.
- 37 (6) Fayetteville Technical Community College and the Company shall jointly use  
38 seventy-five percent (75%) of the Facility during the lease to expand  
39 employment pathways that prepare students for high demand employment  
40 positions in the automotive technology repair and maintenance sector.  
41

#### 42 **PART VI.1. CHANGES TO THE AI SCHOOL SAFETY PILOT PROGRAM**

43 **SECTION 6.1.** Section 7.36(h) of S.L. 2023-134 reads as rewritten:

44 **"SECTION 7.36.(h)** Artificial Intelligence (AI) Pilot. – Of the funds appropriated to the  
45 Department of Public Instruction by this act for the grants provided in this section for the  
46 2023-2024 fiscal year, the Department shall allocate (i) three million two hundred thousand  
47 dollars (\$3,200,000) as a directed grant to New Hanover County Schools and (ii) two million  
48 dollars (\$2,000,000) as a directed grant to Davidson County Schools ~~for to contract with Vyze~~  
49 by Eviden to conduct an AI School Safety Pilot Program. In conducting the Pilot Program,  
50 participating public school units shall comply with the following:

- 1 (1) Funds allocated for the Pilot Program shall be used for the implementation of  
 2 a school safety system that integrates AI technology into existing ~~access~~  
 3 ~~controls, alerting protocols, and intercom systems.~~ cameras, video  
 4 management systems, and alerting protocols.
- 5 (1a) The proposed school safety solution must offer the following performance  
 6 capabilities:
- 7 a. Threatening Objection Detection.  
 8 b. Intruder Detection.  
 9 c. Person Down Detection.  
 10 d. Door Open Detection.  
 11 e. Tag and Track.  
 12 f. Facial Recognition.  
 13 g. Forensic Face Search.  
 14 h. License Plate Reader.
- 15 (2) No later than January 15, 2025, the participating public school units, in  
 16 coordination with the Department of Public Instruction, shall report to the  
 17 Joint Legislative Education Oversight Committee the following information:
- 18 a. The schools that participated in the Pilot Program.  
 19 b. How grant funds were spent.  
 20 c. The impact the Pilot Program had on school safety outcomes.  
 21 d. Any noted capabilities of the AI system that could not be accomplished  
 22 by more traditional safety measures.  
 23 e. Any other information the participating public school units or the  
 24 Department deem relevant to the report."  
 25

## 26 PART VI.2. CHANGES TO THE SPECIAL NEEDS PILOT PROGRAM

27 **SECTION 6.2.** Section 7.53 of S.L. 2023-134 reads as rewritten:

28 "**SECTION 7.53.** Of the funds appropriated to the Department of Public Instruction, the sum  
 29 of nine hundred seventy-five thousand dollars (\$975,000) in nonrecurring funds for each year of  
 30 the 2023-2025 fiscal biennium shall be used to contract with Amplio Learning Technologies,  
 31 Inc., to create a new pilot program (Program) for a special education digital intervention software  
 32 platform in ~~Alamance County Schools, Catawba County Schools, and Nash County Schools~~  
 33 Cabarrus County Schools, Union County Schools, and Vance County Schools to increase  
 34 opportunities for students with special needs. The Program shall focus primarily on students  
 35 receiving interventions for speech language and reading development, including English  
 36 language learners, to provide more optimized progress for the interventions. To provide more  
 37 effective and efficient opportunities for Medicaid billing for speech language pathologists (SLP)  
 38 services and dyslexia-related services, the platform chosen should include digital evidence-based  
 39 curricula specifically aligned to speech, language, and literacy intervention goals. The chosen  
 40 solution should include real-time automatic measurements, data collection, and documentation,  
 41 as well as goal tracking and administrative dashboards. The platform chosen should be a  
 42 web-based application accessible on multiple devices allowing flexible application across  
 43 classroom-based, small group, and individual intervention models and utilized by a variety of  
 44 intervention team members, including special educators, SLPs, Reading Interventionists, SLP  
 45 assistants, and educational aides. The Department of Public Instruction shall provide an interim  
 46 report on the results of the Program to the Joint Legislative Education Oversight Committee and  
 47 the Fiscal Research Division by June 30, 2025. The Department of Public Instruction shall report  
 48 on the final results of the Program to the Joint Legislative Education Oversight Committee and  
 49 the Fiscal Research Division by October 15, ~~2025-2027.~~ The report shall include at least (i) a  
 50 comparison of Medicaid reimbursements paid out to participating public school units compared  
 51 against public school units that did not participate in the Program and (ii) a comparison of

1 Medicaid reimbursements paid out to public school units after participating in the Program  
2 compared against Medicaid reimbursements paid out to participating public school units prior to  
3 their participation in the Program."  
4

5 **PART VI.3. HOUR REQUIREMENT FOR MASSAGE THERAPY LICENSURE**

6 **SECTION 6.3.(a)** G.S. 90-629 reads as rewritten:

7 **"§ 90-629. Requirements for licensure to practice.**

8 Upon application to the Board and the payment of the required fees, an applicant may be  
9 licensed as a massage and bodywork therapist if the applicant meets all of the following  
10 qualifications:

- 11 (1) Has obtained a high school diploma or equivalent.
- 12 (2) Is 18 years of age or older.
- 13 (3) Is of good moral character as determined by the Board.
- 14 (4) Has successfully completed a training program consisting of a minimum of  
15 500-650 in-class hours of supervised instruction at a Board-approved school.
- 16 (5) Has passed a competency assessment examination that meets generally  
17 accepted psychometric principles and standards and is approved by the Board.
- 18 (6) Has submitted fingerprint cards in a form acceptable to the Board at the time  
19 the license application is filed and consented to a criminal history record check  
20 by the State Bureau of Investigation.
- 21 (7) Demonstrates satisfactory proof of proficiency in the English language."

22 **SECTION 6.3.(b)** This section becomes effective July 1, 2024, and applies to  
23 licenses issued on or after that date.
