1 moves to amend the bill on page 114, lines 39-40, by inserting between those lines a new section
2 to read:

4 **"FUNDS FOR MECKLENBURG COUNTY FAMILY JUSTICE CENTER**

5 **SECTION 9C.1.** Notwithstanding the Committee Report referenced in Section 43.2
6 of this act or any other provision of law to the contrary, funds appropriated in this act from the
7 General Fund to the Department of Health and Human Services, Division of Child and Family
8 Well-Being, for the 2024-2025 fiscal year are increased by the sum of one million seven hundred
9 fifty thousand dollars (\$1,750,000) in nonrecurring funds. Of the funds appropriated to the
10 Department of Health and Human Services, Division of Child and Family Well-Being, for the
11 2024-2025 fiscal year, the sum of one million seven hundred fifty thousand dollars (\$1,750,000)
12 in nonrecurring funds shall be allocated as a directed grant to Mecklenburg County for costs
13 associated with (i) the purchase of additional land to establish a family justice center known as
14 The Umbrella Center, which will offer comprehensive services for victims of interpersonal
15 violence such as domestic violence, sexual assault, child abuse, elder abuse, and human
16 trafficking; and (ii) the construction of a deceleration lane for ingress to the family justice
17 center."; and

19 on page 138, lines 31-32, by inserting between those lines a new section to read:

21 **"CAROLINA PREGNANCY CARE FELLOWSHIP**

22 **SECTION 9H.5A.(a)** Notwithstanding S.L. 2023-134, the Committee Report
23 referenced in Section 43.2 of that act, or any other provision of law to the contrary, funds
24 appropriated from the General Fund to the Department of Health and Human Services, Division
25 of Public Health, for the 2024-2025 fiscal year for Carolina Pregnancy Care Fellowship are
26 decreased by the sum of one million seven hundred fifty thousand dollars (\$1,750,000) in
27 recurring funds.

28 **SECTION 9H.5A.(b)** Section 9H.11(a) of S.L. 2023-134 reads as rewritten:

29 **"SECTION 9H.11.(a)** Of the funds appropriated in this act to the Department of Health and
30 Human Services, Division of Public Health, the sum of six million two hundred fifty thousand
31 dollars (\$6,250,000) in recurring funds for the 2023-2024 fiscal year and the sum of ~~six million~~

14 b. Grants to pay for pregnancy care training and training on the use of
15 durable medical equipment.
16 (3) The sum of two hundred fifty thousand dollars (\$250,000) in recurring funds
17 for the 2023-2024 fiscal year and the sum of ~~two hundred fifty thousand~~
18 ~~dollars (\$250,000)~~ one hundred eighty thousand dollars (\$180,000) in
19 recurring funds for the 2024-2025 fiscal year shall be used to provide grants
20 to pregnancy centers located in this State to cover the cost of nonreligious,
21 nonsectarian educational training and resources regarding pregnancy.
22 (4) The sum of two million one hundred thousand dollars (\$2,100,000) in
23 recurring funds for the 2023-2024 fiscal year and the sum of ~~two million one~~
24 ~~hundred thousand dollars (\$2,100,000)~~ one million five hundred twelve
25 thousand dollars (\$1,512,000) in recurring funds for the 2024-2025 fiscal year
26 shall be allocated to fund operation of the CPCF Circle of Care Program."";
