SECTION 18.1.(a) G.S. 117-3 reads as rewritten:

"§ 117-3. Authority not granted power to fix rates or order line extensions; right of suggestion and petition.

9 The Except as provided in G.S. 117-3.1(b), the Authority itself shall not be a rate-making body, and shall have no power to fix the rates or service charges, or to order the extension of 10 lines by the power companies. The Except as provided in G.S. 117-3.1(b), the function of making 11 12 rates and service charges and orders for the extension of lines shall remain in the Utilities Commission of North Carolina, and the Authority shall only have the right of suggestion and 13 14 petition to the Utilities Commission of its opinion as to the proper rates and service charges and line extensions, and no rate recommended or suggested by the Authority shall be effective until 15 approved by the Utilities Commission: Provided, that if the Utilities Commission of North 16 Carolina does not have the right under the existing law to fix service charges in addition to the 17 rates prescribed for electrical energy, and the power to order line extensions, such power and 18 19 authority is hereby granted the Utilities Commission of North Carolina to fix and promulgate 20 service charges in addition to rates in any community which avails itself of this Article, and form a corporation authorized hereunder to be known as electric membership corporation, and to order 21 22 line extensions when it shall determine that the same is proper and feasible."

SECTION 18.1.(b) G.S. 117-3.1 reads as rewritten:

24 "§ 117-3.1. Regulatory fee.

26 Rate. - For each fiscal year, year in which the General Assembly does not establish a (b) rate, the regulatory fee shall be the greater of the following: 27

(1)The rate established by the General Assembly for that year for each electric 28 29 membership corporation's North Carolina meter connected for service and 30 each telephone membership corporation's North Carolina access line 31 connected for service for each quarter of the year.

Four cents (4ϕ) rate proposed by the Authority in accordance with this (2)2 subsection, which shall not be more than six cents (6e) for each electric 3 membership corporation's North Carolina meter connected for service and for 4 each telephone membership corporation's North Carolina access line 5 connected for service for each quarter of the year.

6 When the Authority prepares its budget request for the upcoming fiscal year, the Authority shall propose a rate for the regulatory fee. For fiscal years beginning in an odd-numbered year, 7 8 that proposed rate shall be included in the budget message the Governor submits to the General 9 Assembly pursuant to G.S. 143C-3-5. For fiscal years beginning in an even-numbered year, that 10 proposed rate shall be included in a special budget message the Governor shall submit to the General Assembly. If the General Assembly decides to set the regulatory fee at a rate higher than 11 12 the rate in subdivision (2) of this subsection, it shall set the regulatory fee by law.

13 The regulatory fee may not exceed the amount necessary to generate funds sufficient to defray 14 the estimated cost of the operations of the Authority for the upcoming fiscal year, including a 15 reasonable margin for a reserve fund. The amount of the reserve may not exceed the estimated cost of operating the Authority for the upcoming fiscal year. In calculating the amount of the 16 reserve, the General Assembly shall consider all relevant factors that may affect the cost of 17 18 operating the Authority or a possible unanticipated increase or decrease in North Carolina electric 19 meters and North Carolina telephone access lines.
