## February 18, 2025 1 A BILL TO BE ENTITLED 2 AN ACT TO PROHIBIT THE MISBRANDING OF CERTAIN FOOD PRODUCTS. 3 The General Assembly of North Carolina enacts: 4 SECTION 1.(a) G.S. 106-549.15 reads as rewritten: 5 "§ 106-549.15. Definitions. 6 As used in this Article, except as otherwise specified, the following terms shall have the 7 meanings stated below: 8 . . . 9 "Agricultural food animal" means a domesticated animal belonging to the (1a)bovine, caprine, ovine, or porcine species. 10 11 12 "Cell-cultured food product" means a food product having one or more (5a) sensory attributes that resemble a type of tissue originating from an 13 14 agricultural food animal but that, in lieu of being derived from meat 15 processing, is derived from manufacturing cells, in which one or more stem cells are initially isolated from an agricultural food animal, are grown in vitro, 16 and may be manipulated, as part of a manufacturing operation. 17 18 "Close proximity" means any of the following: (5b) 19 Immediately before or after the name of the product. a. 20 In the line of the label immediately before or after the line containing b. 21 the name of the product. 22 Within the same phrase or sentence containing the name of the <u>c.</u> 23 product. 24 . . . 25 "Identifying meat term" means any word or phrase that states, indicates, (9a) suggests, or describes a meat product, regardless of whether the word or 26 27 phrase is used individually, as a portmanteau, or as a compound word. This 28 term includes all of the following: 29 A common name for the species of the agricultural food animal subject a. to slaughter and processing, including a calf or cow, goat or kid, hog 30 31 or pig, lamb, or sheep. 32 A common name for a characteristic of a species of the agricultural <u>b.</u> 33 food animal subject to slaughter and processing based on age, breed, 34 or sex. 35 Meat; beef or veal; cabrito or chevon; lamb or mutton; or pork. <u>c.</u>

1 2 3	(26) "Poultry product" means any poultry carcass, or part thereof; or any product which is made wholly or in part from any poultry carcass or part thereof, <u>or</u> any cell-cultured food product made from cells of poultry, excepting products
4	which contain poultry ingredients only in a relatively small proportion or
5	historically have not been considered by consumers as products of the poultry
6	food industry, and which are exempted by the Board from definition as a
7	poultry product under such conditions as the Board may prescribe to assure
8	that the poultry ingredients in such products are not adulterated and that such
9	products are not represented as poultry products.

11	(28a) "Qualifying term" means a word, compound word, or phrase that would
12	clearly disclose to a reasonable purchaser of poultry products that a food
13	product is a cell-cultured food product. This includes the following terms:
14	"cell-cultured," "fake," "lab-grown," or "grown in a lab."

16	SECTION 2.(b) G.S. 106-549.55 reads as rewritten:
17	"§ 106-549.55. Labeling standards; false and misleading labels. labelis; labeling of
18	cell-cultured food products.

20	(e) The label of any cell-cultured food product that contains an identifying poultry term
21	shall also contain in at least 20-point font or the size of the surrounding type, whichever is greater,
22	and in close proximity to the name of the product, an appropriate qualifying term."
23	<b>SECTION 3.</b> This act becomes effective October 1, 2025, and applies to products
24	sold or offered for sale on or after that date.
