**Short Title:** Social Media Literacy in Schools. (Public) Sponsors: Referred to: April 14, 2025 A BILL TO BE ENTITLED AN ACT TO PROMOTE INTERNET SAFETY AND TO PROVIDE SOCIAL MEDIA LITERACY INSTRUCTION IN SCHOOLS. The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 115C-47 is amended by adding a new subdivision to read: "(70) To Adopt an Internet Safety Policy. – Local boards of education shall adopt policies for student access to the internet provided by the local school administrative unit. The policies shall do at least the following: Limit access by students to only age-appropriate subject matter and materials. Protect the safety and security of students when accessing email, chat <u>b.</u> rooms, and other forms of electronic communication. Prohibit access by students to data or information maintained by the <u>c.</u> local school administrative unit, including by "hacking" and other unlawful online activities. Prevent access to websites, web applications, or software that does not <u>d.</u> protect against the disclosure, use, or dissemination of a student's personal information. Prohibit and prevent students from accessing social media platforms <u>e.</u> through the use of internet access provided by the local school administrative unit, except when expressly directed by a teacher solely for educational purposes. Prohibit the use of the TikTok platform or any successor platform in <u>f.</u> the following instances: On devices owned or provided by the local school 1. administrative unit. 2. Through internet access provided by the local school administrative unit. As a platform to communicate or promote any unit or school 3. sponsored club, extracurricular organization, or athletic team." **SECTION 2.** Part 1 of Article 8 of Chapter 115C of the General Statutes is amended by adding a new section to read:

"§ 115C-81.26. Social media and mental health.
