- 4 **SECTION 9H.5.(a)** Funds appropriated in this act to the Department of Health and 5 Human Services, Division of Public Health, for each year of the 2025-2027 fiscal biennium for 6 Carolina Pregnancy Care Fellowship (CPCF), a nonprofit corporation, shall be allocated and used 7 as follows:
- 8 (1)The sum of three million eight hundred fifty-six thousand dollars (\$3,856,000) 9 in recurring funds for the 2025-2026 fiscal year and the sum of three million 10 nine hundred fifty thousand dollars (\$3,950,000) in recurring funds for the 2026-2027 fiscal year shall be used to provide grants for services to pregnancy 11 centers located in this State. 12 13 The sum of nine hundred seventy-one thousand dollars (\$971,000) in (2)14 recurring funds for the 2025-2026 fiscal year and the sum of one million dollars (\$1,000,000) in recurring funds for the 2026-2027 fiscal year shall be 15 used to provide the following grants to pregnancy centers located in this State: 16 17 Grants to purchase durable medical equipment. a. Grants to pay for pregnancy care training and training on the use of 18 b. 19 durable medical equipment. 20 The sum of one million twenty-three thousand dollars (\$1,023,000) in (3)recurring funds for the 2025-2026 fiscal year and the sum of one million fifty 21 thousand dollars (\$1,050,000) in recurring funds for the 2026-2027 fiscal year 22 23 shall be allocated to fund operation of the CPCF Circle of Care Program.";

- for Carolina Pregnancy Care Fellowship, a nonprofit corporation, are decreased by the sum of

one hundred fifty thousand dollars (\$150,000) in nonrecurring funds for the 2025-2026 fiscal 1 2 year."; and 3 4 on page 277, lines 6-7, by inserting between those lines, a new section to read: 5 **"THE BULB GALLERY FUNDS** 6 SECTION 9J.11. Notwithstanding any provision of law or the Committee Report 7 described in Section 45.2 of this act to the contrary, funds provided to the Department of Health 8 and Human Services, Division of Social Services, shall be increased by the sum of one hundred 9 fifty thousand dollars (\$150,000) in nonrecurring funds for the 2025-2026 fiscal year to provide a directed grant to The Bulb Gallery, a nonprofit located in Mecklenburg County that operates as 10 a mobile farmers market and provides fresh produce and nutrition education to food insecure 11 12 neighborhoods."; and 13 14 by adjusting the appropriate totals accordingly.
