4 **SECTION 9H.5.(a)** Funds appropriated in this act to the Department of Health and 5 Human Services, Division of Public Health, for each year of the 2025-2027 fiscal biennium for 6 Carolina Pregnancy Care Fellowship (CPCF), a nonprofit corporation, shall be allocated and used 7 as follows:

- 8 (1) The sum of three million six hundred twenty-five thousand dollars 9 (\$3,625,000) in recurring funds for the 2025-2026 fiscal year and the sum of 10 three million six hundred twenty-five thousand dollars (\$3,625,000) in 11 recurring funds for the 2026-2027 fiscal year shall be used to provide grants 12 for services to pregnancy centers located in this State.
- 13(2)The sum of nine hundred thirteen thousand dollars (\$913,000) in recurring14funds for the 2025-2026 fiscal year and the sum of nine hundred thirteen15thousand dollars (\$913,000) in recurring funds for the 2026-2027 fiscal year16shall be used to provide the following grants to pregnancy centers located in17this State:
 - a. Grants to purchase durable medical equipment.
 - b. Grants to pay for pregnancy care training and training on the use of durable medical equipment.
 - (3) The sum of nine hundred sixty-two thousand dollars (\$962,000) in recurring funds for the 2025-2026 fiscal year and the sum of nine hundred sixty-two thousand dollars (\$962,000) in recurring funds for the 2026-2027 fiscal year shall be allocated to fund operation of the CPCF Circle of Care Program."; and
