1 moves to amend the bill on page 268, lines 10-30,  
2 by deleting those lines and substituting the following:

3 **"CAROLINA PREGNANCY CARE FELLOWSHIP**

4 **SECTION 9H.5.(a)** Funds appropriated in this act to the Department of Health and  
5 Human Services, Division of Public Health, for each year of the 2025-2027 fiscal biennium for  
6 Carolina Pregnancy Care Fellowship (CPCF), a nonprofit corporation, shall be allocated and used  
7 as follows:

8 (1) The sum of three million six hundred twenty-five thousand dollars  
9 (\$3,625,000) in recurring funds for the 2025-2026 fiscal year and the sum of  
10 three million six hundred twenty-five thousand dollars (\$3,625,000) in  
11 recurring funds for the 2026-2027 fiscal year shall be used to provide grants  
12 for services to pregnancy centers located in this State.

13 (2) The sum of nine hundred thirteen thousand dollars (\$913,000) in recurring  
14 funds for the 2025-2026 fiscal year and the sum of nine hundred thirteen  
15 thousand dollars (\$913,000) in recurring funds for the 2026-2027 fiscal year  
16 shall be used to provide the following grants to pregnancy centers located in  
17 this State:

18 a. Grants to purchase durable medical equipment.

19 b. Grants to pay for pregnancy care training and training on the use of  
20 durable medical equipment.

21 (3) The sum of nine hundred sixty-two thousand dollars (\$962,000) in recurring  
22 funds for the 2025-2026 fiscal year and the sum of nine hundred sixty-two  
23 thousand dollars (\$962,000) in recurring funds for the 2026-2027 fiscal year  
24 shall be allocated to fund operation of the CPCF Circle of Care Program.";

27 moves to further amend the bill on page 268, lines 48-49,  
28 by inserting between those lines, a new subsection to read:

29 **"SECTION 9E.5.(f)** Notwithstanding any provision of law or the Committee Report  
30 described in Section 45.2 of this act to the contrary, funds provided to the Department of Health  
31 and Human Services, Division of Public Health, in Budget Code 14430, Budget Fund 133000,  
32 for Carolina Pregnancy Care Fellowship, a nonprofit corporation, are decreased by the sum of

5 by inserting between those lines, a new section to read:

6 **"NOURISH UP FOUNDATION FUNDS**

7 **SECTION 9J.11.** Notwithstanding any provision of law or the Committee Report  
8 described in Section 45.2 of this act to the contrary, funds provided to the Department of Health  
9 and Human Services, Division of Social Services, shall be increased by the sum of five hundred  
10 thousand dollars (\$500,000) in nonrecurring funds for each year of the 2025-2027 fiscal biennium  
11 to provide a directed grant to Nourish Up Foundation, a nonprofit located in Mecklenburg County  
12 that provides goods and assistance to address food insecurity."; and

14 by adjusting the appropriate totals accordingly.
