11 **"SECTION 16.3A.(b)** Notwithstanding any provision of law or the Committee
12 Report described in Section 45.2 of this act to the contrary, funds appropriated to the
13 Administrative Office of the Courts, District Attorneys Budget Fund 100072, are increased by
14 the sum of four hundred eighty-seven thousand fifty three dollars (\$487,053) in recurring funds
15 for each year of the 2025-2027 fiscal biennium and eleven thousand two hundred fifty-six dollars
16 (\$11,256) in nonrecurring funds for the 2025-2026 fiscal year, to be used to hire three full-time
17 assistant district attorney positions in Prosecutorial District 40, Buncombe County.

18 **SECTION 16.3A.(c)** Notwithstanding any provision of law or the Committee Report
19 described in Section 45.2 of this act to the contrary, funds appropriated to the Department of
20 Adult Correction, Administration Budget Fund 108001, for the motor fleet management rate
21 increase are decreased by the sum of four hundred ninety-eight thousand three hundred nine
22 dollars (\$498,309) in recurring funds in the 2025-2026 fiscal year and four hundred eighty-seven
23 thousand fifty three dollars (\$487,053) in recurring funds for the 2026-2027 fiscal year."; and
