24 **"SECTION 5.4.** The initial appointments to the governing board of the Lake Norman  
25 Marine Commission will become effective on the date that is seven calendar days following the  
26 adoption by three or more eligible local governments of a joint resolution reconstituting the Lake  
27 Norman Marine Commission.

28 **SECTION 5.5.** All rules, regulations, and decisions made by the predecessor Lake  
29 Norman Marine Commission, reconstituted in accordance with this Part, shall remain in full force  
30 and effect until and unless duly modified by the successor entity."
