SECTION 8G.(a) Notwithstanding any other provision of law to the contrary, the funds appropriated to the Opportunity Scholarship Grant Fund Reserve for the award of opportunity scholarship grants pursuant to Part 2A of Article 39 of Chapter 115C of the General Statutes for each year of the 2025-2027 fiscal biennium are reduced by the sum of forty-five million dollars (\$45,000,000) in recurring funds.
