A BILL TO BE ENTITLED

AN ACT TO MAKE VARIOUS CHANGES TO THE REVENUE LAWS; TO SHIFT ENFORCEMENT OF VAPOR DIRECTORY VIOLATIONS TO THE ALE DIVISION; TO ENHANCE TAX FORECLOSURE AND SPECIAL ASSESSMENT COLLECTION EFFORTS; TO UPDATE LAWS RELATED TO CREDIT UNIONS; TO UPDATE THE REFERENCE TO THE INTERNAL REVENUE CODE; TO PROTECT DISABLED AND OLDER ADULTS FROM FINANCIAL EXPLOITATION AND TO UPDATE THE SAVINGS BANK LAWS TO INCREASE ALIGNMENT WITH THE COMMERCIAL BANKING LAWS; TO PROVIDE A METHODOLOGY FOR RETAILERS TO ROUND CASH TRANSACTIONS DUE TO THE ELIMINATION OF THE PENNY; AND TO INCREASE COMPENSATION FOR MEMBERS OF THE BOARD OF TRUSTEES OF THE PIEDMONT AUTHORITY FOR REGIONAL TRANSPORTATION.

The General Assembly of North Carolina enacts:

**PART I. PERSONAL INCOME TAX CHANGES**

**SECTION 1.1.(a)** G.S. 105-153.5(c1) reads as rewritten:

"(c1) Other ~~Additions.~~ ~~Adjustments.~~ – The following other adjustments shall be made in determining North Carolina taxable income:

- (1) S Corporations subject to the provisions of Part 1A of this Article, partnerships subject to the provisions of this Part, and estates and trusts subject to the provisions of Part 3 of this Article must add any amount deducted under section 164 of the Code as state, local, or foreign income tax.
- (2) A shareholder of an S Corporation subject to the provisions of Part 1A of this Article may deduct the aggregate amount of losses or deductions of an S Corporation pursuant to the provisions of G.S. 105-131.4.
- (3) A shareholder of an S Corporation subject to the provisions of Part 1A of this Article must add the aggregate amount of losses or deductions of an S Corporation included in the shareholder's adjusted gross income to the extent the losses or deductions exceed the shareholder's combined adjusted bases, determined in accordance with G.S. 105-131.3, in the stock and indebtedness of the S Corporation."

**SECTION 1.1.(b)** This section is effective for taxable years beginning on or after January 1, 2026.

**SECTION 1.2.(a)** G.S. 105-153.5A reads as rewritten:

1 **"§ 105-153.5A. Net operating loss provisions.**

2 ...  
3 (g) Limitation. – The provisions of this section apply only to individuals, estates, and  
4 trusts."

5 **SECTION 1.2.(b)** G.S. 105-153.5A(a) reads as rewritten:

6 "(a) State Net Operating Loss. – A taxpayer's State net operating loss for a taxable year is  
7 the amount by which business deductions for the year exceed gross income for the year as  
8 determined under the Code adjusted as provided in G.S. 105-153.5 and G.S. 105-153.6. The  
9 amount of a taxpayer's State net operating loss must also be determined in accordance with the  
10 following modifications:

- 11 (1) No State net operating loss deduction shall be allowed.
- 12 (2) The amount deductible on account of losses from sales or exchanges of capital  
13 assets shall not exceed the amount includable on account of gains from sales  
14 or exchanges of capital assets.
- 15 (3) The exclusion provided by Code section 1202 shall not be allowed.
- 16 (4) No deduction shall be allowed under G.S. 105-153.5(a1) for the child  
17 deduction.
- 18 (5) The deductions which are not attributable to a taxpayer's trade or business  
19 shall be allowed only to the extent of the amount of the gross income not  
20 derived from such trade or business.
- 21 (6) Any deduction under Code section 199A shall not be allowed.
- 22 (7) The amount of the taxpayer's excess business loss, as defined under the  
23 provisions of section 461(l) of the Code, shall be fully allowed as a State net  
24 operating loss."

25 **SECTION 1.2.(c)** Subsection (a) of this section is effective when this Part becomes  
26 law and applies retroactively to taxable years beginning on or after January 1, 2022. Subsection  
27 (b) of this section is effective for taxable years beginning on or after January 1, 2026. The  
28 remainder of this section is effective when it becomes law.

29 **SECTION 1.3.(a)** G.S. 105-160.2 reads as rewritten:

30 **"§ 105-160.2. Imposition of tax.**

31 (a) Scope. – The tax imposed by this Part applies to the taxable income of estates and  
32 trusts as determined under the provisions of the Code except as otherwise provided in this Part.  
33 The taxable income of an estate or trust is the same as taxable income for such an estate or trust  
34 under the provisions of the Code, adjusted as provided in G.S. 105-153.5 and ~~G.S. 105-153.6;~~  
35 ~~except that the adjustments provided in G.S. 105-153.5 and G.S. 105-153.6 are apportioned~~  
36 ~~between the estate or trust and the beneficiaries based on the distributions made during the~~  
37 ~~taxable year. G.S. 105-153.6.~~

38 (b) Tax Base. – The tax is computed on the amount of the taxable income of the estate or  
39 trust that is for the benefit of a resident of this State, or for the benefit of a nonresident to the  
40 extent that the income (i) is derived from North Carolina sources and is attributable to the  
41 ownership of any interest in real or tangible personal property in this State or (ii) is derived from  
42 a business, trade, profession, or occupation carried on in this State. For purposes of the preceding  
43 sentence, taxable income and gross income is computed subject to the adjustments provided in  
44 G.S. 105-153.5 and ~~G.S. 105-153.6.~~ G.S. 105-153.6 and is apportioned and allocated to this State  
45 under G.S. 105-130.4.

46 (c) Tax Rate. – The tax on the amount computed above is at the rate levied in  
47 G.S. 105-153.7. The fiduciary responsible for administering the estate or trust shall pay the tax  
48 computed under the provisions of this Part.

49 (d) Adjustments. – For the purposes of this section, the adjustments provided in  
50 G.S. 105-153.5 and G.S. 105-153.6 are apportioned between the estate or trust and the  
51 beneficiaries based on the distributions made during the taxable year."

1           **SECTION 1.3.(b)** This section is effective for taxable years beginning on or after  
2 January 1, 2026.

3           **SECTION 1.4.** G.S. 105-163.6 reads as rewritten:

4       "**§ 105-163.6. When employer must file returns and pay withheld taxes.**

5       ...

6       (c)   Monthly. – An employer who withholds an average of at least two hundred fifty  
7 dollars (\$250.00) but less than two thousand dollars (\$2,000) of State income taxes from wages  
8 each month must file a return and pay the withheld taxes on a monthly basis. A return for the  
9 months of January through November is due by the 15th day of the month following the end of  
10 the month covered by the return. A return for the month of December is due the following January  
11 31.

12       (d)   Semiweekly. – An employer who withholds an average of at least two thousand  
13 dollars (\$2,000) of State income taxes from wages each month ~~shall~~must file a return ~~by the date~~  
14 ~~set under the Code for filing a return for federal employment taxes attributable to the same wages~~  
15 ~~and shall~~ on a quarterly basis. A quarterly return covers a calendar quarter and is due by the last  
16 day of the month following the end of the quarter. The employer also must pay the withheld State  
17 taxes by the date set under the Code for depositing or paying federal employment taxes  
18 attributable to the same wages. The date set by the Code for depositing or paying federal  
19 employment taxes shall be determined without regard to § 6302(g) of the Code.

20       ~~An extension of time granted to file a return for federal employment taxes attributable to~~  
21 ~~wages is an automatic extension of time for filing a return for State income taxes withheld from~~  
22 ~~the same wages, and an extension of time granted to pay federal employment taxes attributable~~  
23 ~~to wages is an automatic extension of time for paying State income taxes withheld from the same~~  
24 ~~wages. An employer who pays withheld State income taxes under this subsection is not subject~~  
25 ~~to interest on or penalties for a shortfall in the amount due if the employer would not be subject~~  
26 ~~to a failure to deposit penalty had the shortfall occurred in a deposit of federal employment taxes~~  
27 ~~attributable to the same wages and the employer pays the shortfall by the date the employer would~~  
28 ~~have to deposit a shortfall in the federal employment taxes.~~ forth below:

29       (1)   If an employer's payday falls on a Wednesday, Thursday, or Friday, the  
30 withheld taxes must be paid on or before the following Wednesday.

31       (2)   If an employer's payday falls on a Saturday, Sunday, Monday, or Tuesday, the  
32 withheld taxes must be paid on or before the following Friday.

33       (3)   If any of the three weekdays following the close of a semiweekly period is a  
34 legal holiday, the employer has an additional business day for each day that is  
35 a legal holiday by which to pay the withheld taxes.

36       ...

37       (f)   The Secretary may close a taxpayer's withholding account if the taxpayer files no  
38 withholding returns or files returns showing no State income taxes withheld for a period of 18  
39 months."

40       **SECTION 1.5.(a)** G.S. 105-130.34A, as recodified and amended by Section 9.1(a)  
41 of S.L. 2025-4, reads as rewritten:

42       "**§ 105-130.34A. Credit for certain real property donations.**

44       (b)   Definitions. – The following definitions apply in this section:

45       (1)   Allocated credit. – A requested credit minus the reduction required under  
46 subsection ~~(h)~~(i) of this section.

47       ...

48       (9)   Total allocated credits. – Total requested credits less any reduction required  
49 under subsection ~~(h)~~(i) of this section and  
50 ~~G.S. 105-153.11(I).~~G.S. 105-153.11(I).

1 (h) Ceiling; Use; Allocation. – The amount of total allocated credits to taxpayers under  
 2 this section and G.S. 105-153.11 for a taxable year may not exceed five million dollars  
 3 (\$5,000,000), of which three million two hundred fifty thousand dollars (\$3,250,000) is a  
 4 prioritized amount. If the total requested credits are equal to or less than the maximum amount,  
 5 the Secretary shall allow the total requested credits. If the total requested credits are greater than  
 6 the maximum amount, the Secretary shall allocate the total requested credits in accordance with  
 7 ~~this subsection~~ subsection (i) of this section.

8 ...."

9 **SECTION 1.5.(b)** G.S. 105-153.11, as amended by Section 9.1(c) of S.L. 2025-4,  
 10 reads as rewritten:

13 (b) Definitions. – The following definitions apply in this section:

15 (11) Total allocated credits. – Total requested credits less any reduction required  
 16 under subsection (l) of this section and

19 (h) Cap. – The allocated credit may not exceed the amount of the tax against which it is  
 20 claimed for the taxable year reduced by the sum of all credits allowed, except payments of tax

23 (k) Ceiling; Use; Allocation. – The amount of total allocated credits under this section  
 24 and G.S. 105-130.34A for a taxable year may not exceed five million dollars (\$5,000,000), of  
 25 which three million two hundred fifty thousand dollars (\$3,250,000) is a prioritized amount. If  
 26 the total requested credits are equal to or less than the maximum amount, the Secretary shall  
 27 allow the total requested credits. If the total requested credits are greater than the maximum  
 28 amount, the Secretary shall allocate the total requested credits in accordance with ~~this~~  
 29 ~~subsection~~ subsection (l) of this section.

31 **SECTION 1.6.** G.S. 105-153.5(b) reads as rewritten:

32 "(b) Other Deductions. – In calculating North Carolina taxable income, a taxpayer may  
 33 deduct from the taxpayer's adjusted gross income any of the following items that are included in  
 34 the taxpayer's adjusted gross income:

35 ...

36 (17) For taxable year 2024, the amount of an eligible timber casualty loss that is  
 37 equal to the fair market value of the timberland after the casualty loss  
 38 subtracted from the fair market value of the timberland before the loss, less  
 39 any amount received, directly or indirectly, related to the eligible timber  
 40 casualty loss, including insurance payments, tax credits, tax deductions,  
 41 disaster payments, grants, or relief funding. The eligible timber casualty loss  
 42 must be determined by reference to a single, identifiable property that has been  
 43 damaged or destroyed in accordance with section 165 of the Code. The  
 44 taxpayer may elect to take the deduction in the taxable year 2023 by filing an  
 45 amended return within the statute of limitations for obtaining a refund. No  
 46 deduction is allowed under this subdivision if another person claimed the  
 47 eligible timber casualty loss for the same timberland, or if the eligible timber  
 48 casualty loss was excluded from the taxpayer's adjusted gross income. For  
 49 purposes of this subdivision, an "eligible timber casualty loss" is a timber  
 50 casualty loss that meets all of the following conditions:

- 1                   a.     It occurred between September 24, 2024, and October 31, 2024, as the  
 2                             result of damage or destruction caused by Hurricane Helene in a  
 3                             county that qualified for individual and public assistance under FEMA  
 4                             4827 DR federal major disaster declaration as of September 28, 2024.  
 5                   b.     It is attributable to at least 20 but no more than 2,000 acres of  
 6                             timberland in this State that are owned by the taxpayer."

7                   **SECTION 1.7.(a)** Section 13.1(a) of S.L. 2024-51 reads as rewritten:

8                   **"SECTION 13.1.(a)** Interest Waiver for Certain State Taxes. – Notwithstanding  
 9                   G.S. 105-241.21(b), the Secretary of Revenue shall waive the accrual of interest from September  
 10                   25, 2024, through ~~May 1, 2025,~~ September 25, 2025, on an underpayment of tax imposed on a  
 11                   franchise, corporate income, or individual income tax return, including a partnership and estate  
 12                   and trust tax return, due on September 25, 2024, through ~~May 1, 2025,~~ September 25, 2025, for  
 13                   a taxpayer that resides or is located in a county identified in Section 4.1(b) of this act. The relief  
 14                   from accrual of interest includes interest imposed pursuant to G.S. 105-163.15 and  
 15                   G.S. 105-163.41 for underpayment of estimated income tax."

16                   **SECTION 1.7.(b)** Section 13.1(c) of S.L. 2024-51 reads as rewritten:

17                   **"SECTION 13.1.(c)** Withholding Taxes Interest Waiver. – Notwithstanding  
 18                   G.S. 105-241.21(b) and excluding taxpayers under G.S. 105-163.6(d), the Secretary of Revenue  
 19                   shall waive the accrual of interest as described in this subsection for an underpayment of withheld  
 20                   taxes by a taxpayer located in a county described in Section 4.1(b) of this act:

21                   (1) For an underpayment of tax due on a quarterly return ~~for~~ as follows:

- 22                   a.     For the third calendar quarter of 2024, the amount of interest accrued  
 23                             from October 31, 2024, through ~~November 30, 2024,~~ September 25,  
 24                             2025, so long as the payment is made on or before ~~November 30,~~

 26                   b.     For the fourth calendar quarter of 2024, the amount of interest accrued

38                   (a) Deduction Amount. – In calculating North Carolina taxable income, a taxpayer may  
 39                   deduct from adjusted gross income either the standard deduction amount provided in subdivision  
 40                   (1) of this subsection or the itemized deduction amount provided in subdivision (2) of this  
 41                   subsection. The deduction amounts are as follows:

43                   (2) Itemized deduction amount. – An amount equal to the sum of the items listed  
 44                   in this subdivision. The amounts allowed under this subdivision are not  
 45                   subject to the overall limitation on itemized deductions under section 68 of  
 46                   the Code:

- 48                   d.     Repayment in the current taxable year of an amount included in  
 49                             adjusted gross ~~income~~ income, as modified in G.S. 105-153.5 and  
 50                             G.S. 105-153.6, in an earlier taxable year because it appeared that the  
 51                             taxpayer had an unrestricted right to such item, to the extent the

1 repayment is not deducted in arriving at adjusted gross income in the  
 2 current taxable year. If the repayment is three thousand dollars  
 3 (\$3,000) or less, the deduction is the amount of repayment less (i) the  
 4 limitation provided under section 67(a) of the Code minus (ii) all other  
 5 items deductible under section 67(b) of the Code, not to exceed the  
 6 limitation provided under section 67(a) of the Code. If the repayment  
 7 is more than three thousand dollars (\$3,000), the deduction is the  
 8 amount of repayment. No deduction is allowed if the taxpayer  
 9 calculates the federal income tax for the year of repayment under  
 10 section 1341(a)(5) of the Code.

 12 (b) Other Deductions. – In calculating North Carolina taxable income, a taxpayer may  
 13 deduct from the taxpayer's adjusted gross income any of the following items that are included in  
 14 the taxpayer's adjusted gross income:

 16 (14a) The amount received by a taxpayer for ~~one or more of the following:~~  
 17 a. ~~The Business Recovery Grant Program.~~  
 18 b. ~~The ReTOOLNC grant program for recovery from the economic~~  
 19 ~~impacts of the COVID-19 pandemic.~~  
 20 c. ~~Rent~~ rent and utility assistance pursuant to Section 3.3 of S.L. 2020-4,  
 21 as amended by Section 1.2 of S.L. 2020-97.

23 **SECTION 1.8.(b)** This section is effective for taxable years beginning on or after  
 24 January 1, 2026.

25 **SECTION 1.9.(a)** G.S. 105-154.1(c) reads as rewritten:

26 "(c) Tax Credit. – A taxed partnership that qualifies for a credit may apply each partner's  
 27 distributive share of the taxed partnership's credits against the partner's distributive share of the  
 28 taxed partnership's income tax imposed by subsection (b) of this section. A partnership must pass  
 29 through to its partners any credit required to be taken in installments by this Chapter if the first  
 30 installment was taken in a taxable period that the election under subsection (a) of this section was  
 31 not in effect. A partnership shall not pass through to its partners described in G.S. 105-154.1(a)(1)  
 32 through (4) any of the following:

- 33 (1) Any credit allowed under this Chapter for any taxable period the partnership  
 34 makes the election under subsection (a) of this section and the carryforward  
 35 of the unused portion of such credit.  
 36 (2) Any subsequent installment of such credit required to be taken in installments  
 37 by this Chapter after the partnership makes an election under subsection (a) of  
 38 this section and the carryforward of any unused portion of such installment."

39 **SECTION 1.9.(b)** This section is effective for taxable years beginning on or after  
 40 January 1, 2026.

41 **SECTION 1.10.** G.S. 105-157 reads as rewritten:

42 **"§ 105-157. When tax must be paid.**

43 (a) Except as otherwise provided in ~~this section and in~~ Article 4A of this Chapter, the full  
 44 amount of the tax payable as shown on the return must be paid to the Secretary within the time  
 45 allowed for filing the ~~return.~~ return determined without regard to the extension allowed under  
 46 G.S. 105-263. If the amount shown to be due is less than one dollar (\$1.00), no payment need be  
 47 made.

48 ...."

49 **SECTION 1.11.** G.S. 105-163.15 reads as rewritten:

50 **"§ 105-163.15. Failure by individual to pay estimated income tax; interest.**

1 (f) No interest shall be imposed under subsection (a) if the tax shown on the return for  
2 the taxable year reduced by the tax withheld under this Article is less than ~~the amount set in~~  
3 ~~section 6654(e) of the Code~~ one thousand dollars (\$1,000) or if the individual did not have any  
4 liability for tax under Part 2 of Article 4 for the preceding taxable year.

6 **SECTION 1.12.** Except as otherwise provided, this Part is effective when it becomes  
7 law.

## 8 **PART II. CONFORM TO FEDERAL SYSTEM FOR AUDITING PARTNERSHIPS**

9 **SECTION 2.(a)** Part 2 of Article 4 of Chapter 105 of the General Statutes is amended  
10 by adding a new section to read:

### 11 **"§ 105-154.2. Federal partnership adjustments.**

12 (a) Definitions. – The following definitions apply in this Part:

- 13 (1) Administrative adjustment request. – An administrative adjustment request  
14 filed by a partnership under section 6227 of the Code.
- 15 (2) Audited partnership. – A partnership subject to a partnership level audit  
16 resulting in a federal partnership adjustment.
- 17 (3) Corporate partner. – A partner that is subject to tax under Part 1 of this Article.
- 18 (4) Direct partner. – A partner that holds a direct interest in a partnership subject  
19 to a federal partnership adjustment.
- 20 (5) Exempt partner. – A partner that is not subject to State income tax under this  
21 Article that holds a direct interest in a partnership subject to a federal  
22 partnership adjustment.
- 23 (6) Federal partnership adjustment. – A change or correction arising from a  
24 partnership level audit or an administrative adjustment request that affects the  
25 calculation of a taxpayer's State tax.
- 26 (7) Federal partnership representative. – The person the partnership designates for  
27 the taxable year as the partnership's representative, or the person the Internal  
28 Revenue Service has appointed to act as the federal partnership representative,  
29 pursuant to section 6223(a) of the Code.
- 30 (8) Final federal partnership adjustment. – A federal partnership adjustment that  
31 is final. A federal partnership adjustment is final when the federal partnership  
32 adjustment is not subject to administrative or judicial review. If the federal  
33 partnership adjustment results from filing an administrative adjustment  
34 request, the federal partnership adjustment is final when the administrative  
35 adjustment request is filed. Additionally, a federal partnership adjustment  
36 relating to a partnership level audit is deemed final in the following  
37 circumstances:
  - 38 a. The taxpayer has received a partnership level audit from the Internal  
39 Revenue Service for the tax period and the taxpayer does not timely  
40 file an administrative appeal with the Internal Revenue Service.
  - 41 b. The taxpayer consented to any of the partnership level audit findings  
42 for the tax period and through a final decision or other written  
43 agreement with the Internal Revenue Service all rights of appeal have  
44 been waived or exhausted.
- 45 (9) Indirect partner. – A beneficiary of an estate or nongrantor trust or an owner  
46 in a partnership or pass-through entity, where the estate, partnership,  
47 pass-through entity, or nongrantor trust holds, either itself or through another  
48 indirect partner, a direct interest in a partnership or pass-through entity subject  
49 to a final federal partnership adjustment.  
50

- 1           (10) Partnership level audit. – An audit of a partnership by the Internal Revenue  
2           Service pursuant to Subchapter C of Title 26, Subtitle F, Chapter 63 of the  
3           Code, as enacted by the Bipartisan Budget Act of 2015, Public Law 114-74,  
4           which results in federal partnership adjustments.
- 5           (11) Reviewed year. – The taxable year of a partnership that is subject to a  
6           partnership level audit from which federal partnership adjustments arise.
- 7           (12) State partnership representative. – The federal partnership representative  
8           unless the partnership designates another person as its State partnership  
9           representative. The Secretary is authorized to establish procedures for  
10           designating a person, other than the federal partnership representative, to be a  
11           State partnership representative.
- 12           (13) Tiered partner. – An estate, partnership, S Corporation, or nongrantor trust  
13           that is a partner in a partnership subject to a federal partnership adjustment.
- 14           (b) General Rule. – Except in the case of a final federal partnership adjustment that is  
15           required to be reported to the Secretary using the procedures in subsection (c) of this section, a  
16           partner must report and pay any State income tax due in accordance with the provisions of  
17           G.S. 105-130.20 or G.S. 105-159.
- 18           (c) Reporting a Final Federal Partnership Adjustment. – Except for the distributive share  
19           of adjustments that have been reported as required by subsection (b) of this section and an audited  
20           partnership that has made a timely election under subsection (d) of this section, a partnership and  
21           a partner must report a final federal partnership adjustment as follows:
- 22           (1) No later than 90 days after the final federal partnership adjustment, a

22 distributive share of the tax debt by sending the partners a notice of proposed assessment in

A retailer that solely meets this condition, or both this condition and the condition in subdivision (9) of this subsection, is engaged in business on the first day of the first calendar month occurring at least 60 days after the retailer's gross sales exceed the threshold."

45 (1) Administrator. – Administrator of Credit Unions.

46 (2) Commission. – Credit Union Commission.

47 (3) Credit union. – A credit union is a cooperative, nonprofit association,  
 48 incorporated under Articles 14A to ~~14L~~ 14N of this Chapter, for the purposes  
 49 of encouraging thrift among its members, creating a source of credit at a fair  
 50 and reasonable rate of interest, and providing an opportunity for its members  
 51

1 to use and control their own money in order to improve their economic and  
2 social condition.

3 (4) Division. – Credit Union Division of the Department of Commerce."

4 **SECTION 11.(b)** Article 14B of Chapter 54 of the General Statutes reads as

9 **"§ 54-109.14. Fees.~~Fees and penalties.~~**

10 (a) Each credit union subject to supervision and examination by the ~~Administrator of~~

12 pay into the office of the Administrator ~~of Credit Unions~~ twice each year, in the months of  
13 January and July, supervision fees, ~~except those credit unions which liquidate or convert fees. A~~  
14 ~~credit union that liquidates or converts its charter shall pay into the office of the Administrator~~  
15 ~~of Credit Unions, Administrator,~~ to the date of dissolution, pro rata supervision fees. Examination  
16 fees shall be paid promptly upon receipt of the examination report and invoice.

22 (b) The Administrator may charge other fees for service and supervision as approved by  
23 the Commission. Moneys collected under this section shall be deposited with the State Treasurer  
24 of North Carolina and expended, under the terms of the Executive Budget Act, to defray expenses  
25 incurred by the office of the Administrator ~~of Credit Unions~~ in carrying out its supervisory and  
26 auditing functions.

27 (c) All revenue derived from fees will be placed into a special account to be administered  
28 solely for the operation of the ~~Credit Union~~ Division.

29 (d) The Administrator may waive any fee, in whole or in part, for any credit union or  
30 group of credit unions at the Administrator's discretion.

31 (e) The Administrator may assess a civil penalty not to exceed five hundred dollars  
32 (\$500.00) for the violation of any section of Articles 14A to 15A of this Chapter or any rule  
33 adopted by the Administrator. The clear proceeds of any civil penalty assessed under this  
34 subsection or pursuant to any other authority in Articles 14A to 15A of this Chapter shall be  
35 remitted to the Civil Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2.

36 **"§ 54-109.15. Reports.**

37 (a) ~~Credit~~ The Administrator shall cause credit unions organized under Articles 14A to  
38 14L-15A of this Chapter shall, in January and in July of each year, make to make a report of  
39 condition to the Administrator of Credit Unions on forms supplied for that purpose. Additional  
40 reports may be required in a manner and on a schedule as adopted by the Administrator. The  
41 Administrator may also require that additional reports be filed.

42 (b) ~~Any~~ The Administrator may cause any credit union that neglects to make semiannual  
43 reports as provided in subsection (a) of this section, or any of the other reports required by the

48 possession of the assets and business of any credit union failing to pay a penalty imposed under

1 Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2. The Administrator shall  
2 publish the late penalty amount annually by rule.

7 The examiners appointed by the Administrator shall be given free access to all books, papers,

9 the credit union; for the purpose of the examination, the Administrator may subpoena and  
10 examine personally, or by one of the Administrator's deputies or examiners, witnesses on oath  
11 and documents, whether the witnesses are members of the credit union or not, and whether the  
12 documents are documents of the credit union or not. The Administrator may designate an  
13 independent auditing firm to ~~do the work~~ conduct the examinations under the Administrator's  
14 direction and supervision, with the cost to be paid by the credit union involved.

25 electronic, or digital process or method, or by any other records retention technology approved  
26 by rule or order of the Administrator, of a kind that is capable of accurately converting the records  
27 into tangible form within a reasonable time. Each converted tangible form of record also is  
28 deemed a record.

30 ~~The Administrator of Credit Unions shall establish rules and regulations relating to selection~~

32 **"§ 54-109.18A. Hearings and appeals.**

33 (a) Unless otherwise stated in this Chapter, administrative hearings required or permitted  
34 to be held by the Administrator shall be conducted in accordance with Article 3A of Chapter  
35 150B of the General Statutes.

36 (b) After a hearing under subsection (a) of this section, a party aggrieved may appeal the  
37 decision or order of the Administrator or designee of the Administrator to the Commission for  
38 appellate review by filing with the Administrator a written notice of appeal no later than 30 days  
39 after the day that the Administrator's decision or order is served. Upon receipt of a notice of  
40 appeal, the Administrator shall, within 30 days of the notice, certify to the Commission the record  
41 on appeal. The notice of appeal shall state the grounds for the appeal and set forth in numbered  
42 order the assignments of error for review by the Commission. Failure to state the grounds for the  
43 appeal and assignments of error constitutes grounds to dismiss the appeal. Failure to comply with  
44 the briefing schedule provided by the Commission also constitutes grounds to dismiss the appeal.  
45 The Commission shall review the record on appeal, hear oral arguments by the parties, and make  
46 a written final decision or order no later than 60 days after the date of oral arguments.

47 (c) A party to a proceeding before the Commission under subsection (b) of this section is  
48 entitled to judicial review of the decision or order in accordance with Article 4 of Chapter 150B  
49 of the General Statutes.

1        (d) Notwithstanding any other provision of law, the hearing officer at administrative  
2 hearings conducted under subsection (a) of this section may be the Administrator or a designee  
3 of the Administrator.

4 **"§ 54-109.19. Removal of officers.**

5        (a) The Administrator of Credit Unions shall have the right and is hereby empowered to  
6 serve a written notice of his intention to remove from office any ~~If the Administrator finds that~~  
7 an officer, director, committeeman-committee member, or employee of any credit union doing  
8 business under Articles 14A through to 15A of this Chapter who shall be found to be dishonest,  
9 incompetent, is deceitful, incompetent, grossly negligent, or reckless in the management of the  
10 affairs of the credit union, has been convicted of a felony, has been convicted of a misdemeanor  
11 involving fraud or dishonesty, has breached the trust of the members, or who has persistently  
12 violates-violated the laws of this State or the lawful orders, instructions and regulations issued  
13 orders issued or rules adopted by the Administrator and/or the State Credit Union Commission or  
14 the Commission, the Administrator may take one or both of the following actions:

15            (1) Remove the director, officer, committee member, or employee from office.

16            (2) Prohibit the director, officer, committee member, or employee from  
17 participating in the conduct of the affairs of a credit union or credit union  
18 service organization.

19        (b) A notice of intention to remove-removal of a director, officer, committee member or  
20 employee from office shall contain a statement of the alleged facts constituting the grounds  
21 therefor-for it and shall fix a time and place at which a hearing before the Credit Union  
22 Commission will be held thereon. Such hearing shall be fixed for a date not earlier than 30 days  
23 nor later than 60 days after the date of service of such notice unless an earlier or a later date is  
24 set by the Commission at the request of such director, officer, committee member or employee  
25 and for good cause shown. Pending this hearing, the Administrator may remove the alleged  
26 violation if he finds that it is essential to the continued well-being of the credit union or the public  
27 to do so. Unless, of course, such director, officer, committee member or employee shall appear  
28 at the hearing in person or by a duly authorized representative, he shall be deemed to have  
29 consented to the issuance of an order of such removal. In the event of such consent, or if upon  
30 the record made at any such hearing the Credit Union Commission shall find that any of the  
31 grounds specified in such notice has been determined by the greater weight of the evidence, the  
32 Commission may issue such orders of removal from office as it may deem appropriate. Any such  
33 order shall become effective at the expiration of 30 days after service upon such credit union and  
34 the director, officer, committee member or employee concerned (except in the case of an order  
35 issued upon consent, which shall become effective at the time specified therein). Such order shall  
36 remain effective and enforceable except to such extent as it is stayed, modified, terminated or set  
37 aside by action of the Credit Union Commission or a reviewing court. information on how the  
38 removed party may appeal the removal to the Commission, including contact information to  
39 initiate an appeal. The removal is effective immediately upon service of the notice of removal.

40        (c) A director, officer, committee member, or employee served written notice of removal  
41 has the right to a hearing before the Commission and shall request a hearing within 30 days of  
42 the service of the notice of removal.

43        (d) The hearing shall be fixed for a date no later than 30 days after service of the notice  
44 for request for hearing unless a later date is set by the Commission at the request of the removed  
45 party and for good cause shown. If the removed party does not seek a hearing within the 30-day  
46 time frame, the removed party is deemed to have consented to the removal and the removal is  
47 deemed final.

48        (e) Upon a request for hearing, or upon scheduling a discretionary hearing on its own  
49 initiative, the Commission shall review the facts of the case and hear from the Administrator and  
50 the removed party. The Commission shall determine whether the preponderance of the evidence

1 supports removal. Upon completion of the hearing, the Commission shall issue an order that does  
2 one of the following:

- 3 (1) Overturns the removal and reinstates the removed party.
- 4 (2) Upholds the removal in full.
- 5 (3) Modifies the removal into a suspension of a defined period. The order remains  
6 effective and enforceable except to the extent that it is stayed, modified,  
7 terminated, or set aside by a later action of the Commission or a reviewing  
8 court.

10 (a) In the event of a natural disaster or other national, regional, State, or local emergency,

14 (b) The Administrator may issue and serve upon a credit union an order to cease and  
15 desist from one or more unsafe or unsound practices or violations if, in the opinion of the

17 a credit union is about to engage, in an unsafe or unsound practice, or is violating or has violated,  
18 or there is reasonable cause to believe a credit union is about to violate, this Chapter or any other  
19 applicable statute, rule, regulation, or order. An order to cease and desist shall contain a statement  
20 of the facts constituting the alleged violations or unsafe or unsound practices, and the order may  
21 require, in terms that may be mandatory or otherwise, a credit union, its officers, directors,  
22 employees, or agents to cease and desist from the practices or violations. The order shall specify  
23 its effective date and shall contain a notice to the credit union of its right to a hearing on the order  
24 in accordance with rules adopted by the Administrator.

25 (c) The Administrator may conduct an investigation, including conducting background  
26 checks, of any credit union employee, officer, director, or committee member when considering  
27 applications for new charters, changes to those positions in credit unions in a troubled condition,  
28 a managing agent or manager in a conserved credit union, or when the Administrator has reason  
29 to believe the credit union employee, director, or committee member affected or is likely to affect  
30 the safety or soundness of the credit union."

No agreement, compromise or settlement of any claim or claims filed by a credit union with any surety or any surety company for less than the full amount of said claim or claims shall be entered into or made by the board of directors of any credit union unless and until the said claim or claims shall have been submitted to the Administrator of Credit Unions and his advice thereon given or transmitted to the board of directors of said credit union. The following schedule shall be deemed as the minimum fidelity and faithful performance bond requirements only: North Carolina. Any such bond or bonds shall be in a form approved by the Administrator and subject to the rules adopted by the Administrator.~~

It shall be the duty of the board of directors of each credit union to ~~provide proper protection to meet any circumstances by obtaining adequate bond (an insurance) coverage in excess of the above minimum schedule.~~ obtain bond (and insurance) coverage in excess of the minimum required by the Administrator if the board determines additional coverage is appropriate in relation to potential risks facing the credit union. The treasurer and all other persons handling credit union funds or records before entering upon his or their duties shall give a proper bond with good and sufficient surety, in an amount and character to be determined by the board in compliance with regulations conditioned upon the faithful performance of his or their trust.

The Administrator may require additional coverage for any credit union when, ~~in his in the Administrator's~~ in his or her opinion, the surety bonds in force are insufficient to provide adequate surety coverage, and it shall be the duty of the board of directors of any credit union to obtain such additional coverage within 60 days after the date of written notice by the Administrator to such board of directors. For good cause shown, the Administrator may extend the time to obtain additional coverage."

(a) A credit union may issue and operate a share or deposit account in the name of ~~(i) a minor or (ii) a minor~~ or the names of two or more individuals, one or more of which-whom are minors. minors, and receive payments, pay withdrawals, accept a pledge of the account, issue automated teller machine (ATM) and debit cards, and act in any other matter with respect to the account on the order of the minor with like effect as if the minor were of full age and legal capacity. Any payment to or at the direction of a minor is a discharge of the credit union to the extent thereof. The account shall be held for the exclusive right and benefit of the minor and any joint owners, free from the control of all other persons except creditors. A minor who obtains a share or deposit account from a credit union under this subsection, whether individually or together with others, is bound by the terms of the ~~account agreement~~ agreements governing or permitting electronic access to the share or deposit account to the same extent as if the minor were of full age and legal capacity.

(a1) Any credit union may lease a safe deposit box to a minor or to two or more individuals, one or more of whom are minors. With respect to any such lease, a credit union may deal with the minor in all regards as if the minor were of full age and legal capacity. A minor entering a lease agreement with a credit union under this subsection, whether individually or together with others, is bound by the terms of the safe deposit box agreement to the same extent as if the minor were of full age and legal capacity.

(b) If a minor with a share account, other than a joint account with right of survivorship or a payable on death account, dies, a parent or legal guardian of the minor may access and withdraw the funds on deposit, and the credit union is discharged to the extent of any withdrawal. If a minor with a safe deposit box dies, the provisions of G.S. 28A-15-13 shall control the opening, inventory, and release of contents of the safe deposit box.

(c) This section shall not affect the law governing transactions with minors in cases outside the scope of this section, including transactions that constitute an extension of credit to a minor."

**SECTION 11.(j)** Report on Parity. – The Administrator of Credit Unions shall submit a report to the Joint Legislative Commission on Governmental Operations by December 1, 2027, which shall include the following information:

- 1 (1) The number of credit unions that made parity requests pursuant to

### 36 PART XIII. PROTECTION OF DISABLED AND OLDER ADULTS FROM FINANCIAL 37 EXPLOITATION AND SAVINGS BANK UPDATES

38 SECTION 13.1.(a) G.S. 108A-112 reads as rewritten:

39 "**§ 108A-112. Legislative intent and purpose.**

40 (a) Determined to fight the growing problem of fraud and financial exploitation targeting  
41 disabled adults and older adults in North Carolina, the General Assembly enacts this Article to  
42 facilitate the collection of records needed to investigate and prosecute such these incidents.

43 (b) The General Assembly finds that older adults in this State are at a statistically higher  
44 risk of being targeted for financial exploitation, regardless of diminished capacity or other  
45 disability, because of their accumulation of substantial assets and wealth compared to younger  
46 age groups.

47 (c) The General Assembly recognizes that financial institutions have duties imposed by  
48 law and by contract to conduct customer-directed transactions in a timely manner and in  
49 accordance with their customers' instructions.

50 (d) The General Assembly intends to provide financial institutions with the tools and  
51 protections to take action based upon the reasonable belief that older adults or disabled adults

1 who have accounts with the financial institutions have been or are the subject of financial  
2 exploitation and to provide financial institutions and their employees immunity from liability for  
3 taking actions as authorized in this Article.

4 (e) The General Assembly intends to balance the rights of older adults and disabled adults  
5 to direct and control their assets, funds, and investments and to exercise their constitutional rights  
6 consistent with due process with the need to provide financial institutions the ability to place  
7 narrow, 30-day limited restrictions on these rights in an effort to decrease older adults' or disabled  
8 adults' risk of loss due to abuse, neglect, or financial exploitation."

9 SECTION 13.1.(b) G.S. 108A-113 reads as rewritten:

10 "§ 108A-113. Definitions.

11 As used in this Article, the following definitions apply:

- 12 (1) Customer. – A person ~~who~~ that is a present or former holder of an account  
13 with a financial institution.

16 who is physically or mentally incapacitated as defined in G.S. 108A-101(d).
- 17 (3) Financial exploitation. – The illegal or improper use of a disabled adult's or  
18 older adult's money, assets, property, or other financial resources for another's  
19 profit or pecuniary ~~advantage~~ advantage, or any act or omission by a person,  
20 including through the use of power of attorney, guardianship, or  
21 conservatorship, to do either of the following:
- 22 a. Obtain control over the older adult's or disabled adult's money, assets,  
23 or property through deception, intimidation, or undue influence to  
24 deprive him or her of the ownership, use, benefit, or possession of the  
25 money, assets, or property.
- 26 b. Divert the older adult's or disabled adult's money, assets, or property  
27 to deprive him or her of the ownership, use, benefit, or possession of  
28 the money, assets, or property.
- 29 (4) Financial institution. – A banking corporation, trust company, savings and  
30 loan association, credit union, or other entity principally engaged in lending  
31 money or receiving or soliciting money on deposit.
- 32 (5) Financial record. – An original of, a copy of, or information derived from a  
33 record held by a financial institution pertaining to a customer's relationship  
34 with the financial institution and identified with or identifiable with the  
35 customer.
- 36 (6) Investigating entity. – A law enforcement agency investigating alleged  
37 financial exploitation of a disabled adult or an older adult, or a county  
38 department of social services investigating alleged financial exploitation of a  
39 disabled adult.
- 40 (7) Law enforcement agency. – Any ~~duly accredited~~ State or local government  
41 agency possessing authority to enforce the criminal statutes of North Carolina.
- 42 (8) Older adult. – An individual 65 years of age or older.
- 43 (9) Promptly. – As soon as practicable, with reasonable allowance to be made for  
44 the time required to retrieve older data or records that are not readily or  
45 immediately retrievable due to their current storage media.
- 46 (10) Trusted contact. – Includes any of the following:
- 47 a. A natural person 18 years of age or older whom the customer has  
48 expressly identified pursuant to G.S. 108A-114 in a financial  
49 institution's records as the person who may be contacted (i) about  
50 either the account or the account owner to address possible financial  
51 exploitation or to confirm the specifics of the account owner's current

1 contact information or health status; (ii) to determine the identity of  
 2 any conservator, executor, trustee, or agent; or (iii) to address any  
 3 other concern reasonably related to the administration of the account.

4 b. A joint account owner, additional authorized signatory, beneficiary of  
 5 the customer's account, or an agent under a power of attorney.

6 c. An attorney, trustee, conservator, guardian, or other fiduciary whom a  
 7 court or government agency has selected to manage some or all of the  
 8 financial affairs of the older adult or disabled adult.

9 d. A parent, spouse, adult child, sibling, or other family member of an  
 10 older adult or disabled adult whom a financial institution believes is  
 11 closely associated with the older adult or disabled adult."

12 **SECTION 13.1.(c)** G.S. 108A-115 reads as rewritten:

13 **"§ 108A-115. Duty to report suspected fraud; content of report; immunity for reporting.**

14 (a) Any financial institution, or officer or employee thereof, having reasonable cause to

17 (1) ~~Persons on the list provided by the customer under G.S. 108A-114, if such a~~  
 18 ~~list has been provided by the customer.~~ provided. The financial institution may  
 19 choose not to contact persons on the provided list if the financial institution  
 20 suspects that those persons are financially exploiting the disabled adult or  
 21 older adult.

22 (2) The appropriate local law enforcement agency.

23 (3) The appropriate county department of social services, if the customer is a  
 24 disabled adult.

25 (b) The report may be made orally or in writing. The report shall include the name and  
 26 address of the disabled adult or older adult, the nature of the suspected financial exploitation, and  
 27 any other pertinent information.

28 (c) ~~No financial institution, or officer or employee thereof, who officer, employee, or~~  
 29 ~~agent, that acts in good faith in making a report under this section may be held liable in any action~~  
 30 ~~for doing so. Furthermore, a financial institution, and its officers, employees, and agents, shall~~  
 31 ~~not be compelled in any action to identify the existence of or the contents of a suspicious activity~~  
 32 ~~report related to suspected financial abuse activity that may have been filed with the U.S.~~  
 33 ~~Department of the Treasury's Financial Crimes Enforcement Network pursuant to requirements~~  
 34 ~~of the Bank Secrecy Act, 31 U.S.C. § 5318(g)(2), and its implementing regulations."~~

- 1           (1)   Delay or refuse one or more transactions with or involving the older adult or

- 3           (2)   Delay or refuse to permit the withdrawal or disbursement of funds contained  
4           in the older adult's or disabled adult's account.
- 5           (3)   Prevent a change in ownership of the older adult's or disabled adult's account.
- 6           (4)   Prevent a transfer of funds from the older adult's or disabled adult's account  
7           to an account owned wholly or partially by another person.
- 8           (5)   Refuse to comply with instructions given by an agent or a person acting for or  
9           with an agent under a power of attorney signed or purported to have been  
10          signed by the older adult or disabled adult.
- 11          (6)   Prevent the designation or change the designation of beneficiaries to receive  
12          any property, benefit, or contract rights for an older adult or disabled adult at  
13          death.

14          (c)   A financial institution shall use discretion to determine whether or not to act under  
15          subsections (a) and (b) of this section based on the information available to its staff at the time.  
16          The authority to delay a transaction expires upon the earlier of the following:

- 17           (1)   Thirty business days after the date on which the depository institution first  
18           acted under the authority in this section.
- 19           (2)   When the depository institution is satisfied in its discretion that the transaction  
20           or act will not likely result in financial exploitation of the older adult or

- 22           (3)   Upon an order of a court directing the release of funds.

23          (d)   Unless otherwise directed by order of a court, a financial institution may extend the  
24          duration of a delay up to an additional 30 business days based on a reasonable belief that the  
25          financial exploitation of an older adult or disabled adult may continue to occur or continues to  
26          be attempted.

27          (e)   A financial institution shall create and maintain for at least five years from the date  
28          of the delayed or refused disbursement or transaction a written or electronic record that includes,  
29          at a minimum, the following information:

- 30           (1)   The date on which the delay or refusal was first placed.
- 31           (2)   The name and address of the older adult or disabled adult.
- 32           (3)   The business location of the financial institution.
- 33           (4)   The name and title of the employee who reported suspected financial  
34           exploitation of the older adult or disabled adult pursuant to G.S. 108A-115.
- 35           (5)   The facts and circumstances that caused the employee to report suspected  
36           financial exploitation.

37          (f)   A financial institution that acts in good faith and exercises reasonable care to comply  
38          with this section is immune from any civil, criminal, or administrative liability that might  
39          otherwise arise from the financial institution's action, inaction, or delay in a disbursement or  
40          transaction in accordance with this section. This protection from liability also extends to  
41          employees of a financial institution. This subsection does not supersede or diminish any  
42          immunity granted elsewhere in this Chapter. If a financial institution or its employees make, or  
43          choose not to make, a disclosure to a trusted contact or participate in a judicial proceeding,  
44          administrative proceeding, or investigation arising from a notification or report, the financial  
45          institution and its employees are immune from any civil, criminal, or administrative liability  
46          arising from the disclosure, nondisclosure, notification, or participation, unless the financial  
47          institution or its employees had actual knowledge of financial exploitation and acted with a  
48          malicious purpose. For purposes of this section, a financial institution and its employees are  
49          deemed to be acting with reasonable care if the financial institution has established training  
50          policies, programs, and procedures for its employees consistent with the requirements of  
51          subsection (g) of this section.

1 (g) Before placing a delay on a disbursement or transaction pursuant to this section, a  
2 financial institution shall do all of the following:

3 (1) Develop training policies or programs reasonably designed to educate  
4 employees who perform or approve transactions on behalf of customers on  
5 issues pertaining to financial exploitation of older adults or disabled adults.

6 (2) With respect to an individual who begins employment with a financial  
7 institution, the training shall be conducted within one year after the date on  
8 which the individual becomes employed by or affiliated or associated with the  
9 financial institution.

10 (3) Develop, maintain, and enforce written procedures regarding the manner in  
11 which suspected financial exploitation is reviewed internally, including, if  
12 applicable, the manner in which suspected financial exploitation is required to  
13 be reported to supervisory personnel.

14 (h) Absent a reasonable belief of financial exploitation as provided in this section, this  
15 section does not otherwise alter a financial institution's obligations to all parties authorized to  
16 transact business on an account and any trusted contact named on the account. This section does  
17 not create new rights for or impose new obligations or new duties on a financial institution under  
18 other applicable law.

19 (i) Notwithstanding any other law to the contrary, the following provisions apply:

20 (1) The refusal to engage in a transaction as authorized under this section does  
21 not constitute the wrongful dishonor of an item under G.S. 25-4-402.

22 (2) A reasonable belief that payment of a check will facilitate the financial  
23 exploitation of an older adult or disabled adult constitutes reasonable grounds  
24 to doubt the collectability of the item for purposes of the federal Check  
25 Clearing for the 21st Century Act, 12 U.S.C. § 5001 et seq., the federal  
26 Expedited Funds Availability Act, 12 U.S.C. § 4001 et seq., and 12 C.F.R.  
27 Part 229. Nothing in this subdivision, however, requires financial institutions  
28 and their employees to review the checks of older adults or disabled adults.

29 (j) A delay or refusal to complete a funds transfer request as authorized under this section  
30 does not violate Article 4A of Chapter 25 of the General Statutes. Furthermore, if a transaction  
31 is delayed under this section, the payment order is not deemed as received until the hold is  
32 removed and the financial institution submits the payment order for processing. "Funds transfer"  
33 and "payment order" have the meaning provided in Article 4A of Chapter 25 of the General

48               (3)   No rounding. – If the final digit of the total transaction amount of a cash

 7 the exact amount of sales tax shown on an invoice or receipt. Nothing in this section authorizes  
 8 the rounding of the amount of sales tax due.

9       (e) No Civil Cause of Action. – There is no civil cause of action against an ABC store  
 10 based on a rounding adjustment done in accordance with this section."

11       **SECTION 14.(c)** Effective July 1, 2027, G.S. 18B-804A(b), as enacted by  
 12 subsection (b) of this section, reads as rewritten:

13       "(b) Application. – If the one-cent piece is no longer in production, an ABC store may  
 14 shall, in accordance with this section, round the total transaction amount to the nearest five-cent  
 15 interval in lieu of calculating the total transaction amount to the nearest one-cent interval. An  
 16 ABC store that rounds transactions must do so in accordance with this section. The following  
 17 principles apply under this section:

- 18       (1) The hundredths place is used to determine the cents in which the final digit of  
 19 the total transaction amount ends.
- 20       (2) Rounding to the nearest five-cent interval does not apply to a transaction for  
 21 which payment is made by a noncash method, including electronic funds  
 22 transfer, check, gift card, money order, credit card, debit card, electronic  
 23 payment, or other noncash payment method. In a mixed tender transaction,  
 24 rounding applies only to the portion of the transaction paid in cash.
- 25       (3) Funds derived from rounding up transactions by an ABC store are treated as  
 26 gross receipts and shall be distributed in accordance with G.S. 18B-805."

27       **SECTION 14.(d)** G.S. 18B-804(b)(7) reads as rewritten:

28       "(b) Sale Price of Spirituous Liquor. – The sale of spirituous liquor, including antique  
 29 spirituous liquor, sold at the uniform State price shall consist of the following components:

30       ...

- 31       (7) A rounding adjustment, the formula of which may be determined by the  
 32 Commission, so that the sale price will be divisible by five. The rounding  
 33 adjustment to the total transaction amount under G.S. 18B-804A has no effect  
 34 on the uniform State price calculated in accordance with this section.

35       ...."

36       **SECTION 14.(e)** G.S. 18B-805(a) reads as rewritten:

37       "(a) Gross Receipts. – As used in this section, "gross receipts" means all revenue of a local  
 38 board, including proceeds from the sale of alcoholic beverages, investments, interest on deposits,  
 39 rounding adjustments made under G.S. 18B-804A, and any other source. Rounding adjustments  
 40 made pursuant to G.S. 18B-804A are disregarded for purposes of calculating distributions under  
 41 subsections (b) and (c) of this section."

42       **SECTION 14.(f)** G.S. 105-164.10 reads as rewritten:

43       "**§ 105-164.10. Retail tax calculation.**

44       (a) For the convenience of the retailer in collecting the tax due under this Article, the  
 45 Secretary must prescribe tables that compute the tax due on sales. The Secretary must issue a  
 46 separate table for each rate of tax that may apply to a sale. A retailer is not required to collect tax  
 47 due under this Article based on a bracket system.

48       (b) In computing tax due under this Article, the tax computation must be carried to the  
 49 third decimal place and must round up to the next cent whenever the third decimal place is greater  
 50 than four. A person liable for tax under this Article may elect to compute the tax due on a  
 51 transaction on an item or invoice basis and the rounding rule is applied to the aggregate tax due.

1 (c) The sales price of a cash transaction does not change due to any rounding of the total  
2 transaction amount to the nearest dollar or cent amount still in production by the United States  
3 Mint."

4 SECTION 14.(g) G.S. 105-164.11 reads as rewritten:

5 "**§ 105-164.11. Excessive and erroneous collections.**

6 ...

7 (d) Presumption of Reasonable Business Practice. – In connection with a purchaser's  
8 request from the seller of over-collected sales or use taxes, a seller ~~shall be~~ is presumed to have  
9 a reasonable business practice if, in the collection of sales and use taxes, any of the following  
10 apply:

11 (1) ~~the~~ The seller uses either a provider or a system, including a proprietary  
12 system, that is certified by the State and the seller has remitted to the State all  
13 taxes collected less any deductions, credits, or collection allowances.

14 (2) The seller rounds a sale to the nearest five-cent interval in accordance with  
15 G.S. 66-515 or G.S. 18B-804A if the one-cent piece is no longer in  
16 production.

17 ...."

18 SECTION 14.(h) Article 1 of Chapter 75 of the General Statutes is amended by  
19 adding a new section to read:

20 "**§ 75-45. Rounding of a cash transaction not a violation.**

21 The rounding of a consumer sale by a business to the nearest five-cent interval in accordance  
22 with G.S. 66-515 or G.S. 18B-804A if the one-cent piece is no longer in production is not a  
23 violation of this Chapter."

24 SECTION 14.(i) Article 3 of Chapter 81A of the General Statutes is amended by  
25 adding a new section to read:

26 "**§ 81A-32. Rounding of a cash transaction not a violation.**

27 The rounding of a consumer sale by a business to the nearest five-cent interval in accordance  
28 with G.S. 66-515 or G.S. 18B-804A if the one-cent piece is no longer in production is not a  
29 violation of this Chapter."

30 SECTION 14.(j) G.S. 105-357 reads as rewritten:

31 "**§ 105-357. Payment of taxes.**

32 (a) Medium of Payment. – Taxes ~~shall be~~ are payable in existing national currency. ~~Deeds~~  
33 A taxing unit may not accept deeds to real property, notes of the taxpayer or others, bonds or  
34 notes of the taxing unit, and payments in kind ~~shall not be accepted~~ in payment of taxes. A taxing  
35 unit may not permit the payment of taxes by offset of any bill, claim, judgment, or other  
36 obligation owed to the taxpayer by the taxing unit. The prohibition against payment of taxes by  
37 offset does not apply to offset of an obligation arising from a lease or another contract entered  
38 into between the taxpayer and the taxing unit before July 1 of the fiscal year for which the unpaid  
39 taxes were levied.

40 (a1) Rounding of Tax Payments in Cash. – If one-cent pieces are no longer in production  
41 and not available for an in-person tax payment made in cash, the taxing unit must round the final  
42 digit of the amount owed downward to the nearest five-cent interval. For an amount owed that is  
43 less than five cents, the taxing unit must round the amount owed down to zero cents. A tax  
44 collector shall treat taxes as fully paid if the payment is rounded downward in accordance with  
45 this section.

46 (b) Acceptance of Checks and Electronic Payment. – The tax collector may accept checks  
47 and electronic payments, as defined in G.S. 147-86.20, in payment of taxes, as authorized by  
48 G.S. 159-32.1. Acceptance of a check or electronic payment is at the tax collector's own risk. A  
49 tax collector who accepts electronic payment of taxes may add a fee to each electronic payment  
50 transaction to offset the service charge the taxing unit pays for electronic payment service. A tax  
51 collector who accepts electronic payment or check in payment of taxes may issue the tax receipt

1 immediately or withhold the receipt until the check has been collected or the electronic payment  
2 invoice has been honored by the issuer.

3 If a tax collector accepts a check or an electronic payment and issues a tax receipt and the  
4 check is returned unpaid (without negligence on the part of the tax collector in presenting the  
5 check for payment) or the electronic payment invoice is not honored by the issuer, the taxes for  
6 which the check or electronic payment was given ~~shall be~~ are deemed unpaid; the tax collector  
7 shall immediately correct the copy of the tax receipt and other appropriate records to show the  
8 fact of nonpayment, and shall give written notice by certified or registered mail to the person to  
9 whom the tax receipt was issued to return it to the tax collector. After correcting the records to  
10 show the fact of nonpayment, the tax collector shall proceed to collect the taxes by the use of any  
11 remedies allowed for the collection of taxes or by bringing a civil action on the check or electronic  
12 payment.

13 A financial institution with which a taxing unit has contracted for receipt of payment of taxes  
14 may accept a check in payment of taxes. If the check is honored, the financial institution shall so  
15 notify the tax collector, who shall, upon request of the taxpayer, issue a receipt for payment of  
16 the taxes. If the check is returned unpaid, the financial institution shall so notify the tax collector,  
17 who shall proceed to collect the taxes by use of any remedy allowed for collection of taxes or by  
18 bringing a civil action on the check.

19 ...

20 (c) Small Underpayments and Overpayments. – The governing body of a taxing unit may,  
21 by resolution, permit its tax collector to treat small underpayments of taxes as fully paid and to  
22 not refund small overpayments of taxes unless the taxpayer requests a refund before the end of  
23 the fiscal year in which the small overpayment is made. A "small underpayment" is a payment  
24 made, other than in person, that is no more than one dollar (\$1.00) less than the taxes due on a  
25 tax receipt. A "small overpayment" is a payment made, other than in person, that is no more than  
26 one dollar (\$1.00) greater than the taxes due on a tax receipt.

27 The tax collector shall keep records of all underpayments and overpayments of taxes by  
28 receipt number and amount and shall report these payments to the governing body as part of his  
29 settlement.

30 A resolution authorizing adjustments of underpayments and overpayments as provided in this  
31 subsection ~~shall~~ shall meet all of the following requirements:

- 32 (1) Be adopted on or before June 15 of the year to which it is to ~~apply~~ apply.
- 33 (2) Apply to taxes levied for all previous fiscal ~~years~~ and years.
- 34 (3) Continue in effect until repealed or amended by resolution of the taxing unit."

35 **SECTION 14.(k)** Except as otherwise provided, this Part is effective when it  
36 becomes law.

42 "**§ 160A-635. Membership; officers; compensation.**

44 (f) Members of the Board of Trustees shall receive the sum of ~~fifty dollars (\$50.00)~~ one  
45 hundred dollars (\$100.00) as compensation for attendance at each duly conducted meeting of the  
46 Authority."

47 **SECTION 15.(b)** This Part is effective when it becomes law and applies to  
48 attendance at meetings conducted on or after that date.

50 **PART XVI. REQUIRE GAMING OPERATORS TO WITHHOLD TAXES ON CERTAIN**  
51 **WINNINGS**

1           **SECTION 16.(a)** Article 4A of Chapter 105 of the General Statutes is amended by  
2 adding a new section to read:

3 **"§ 105-163.2C. Gaming operators must withhold taxes.**

4           The gaming operators listed in this section must deduct and withhold State income taxes from  
5 the payment of winnings in an amount of six hundred dollars (\$600.00) or more. The amount of  
6 taxes to be withheld is a percentage of the winnings. The percentage is the individual income tax  
7 rate in G.S. 105-153.7. The gaming operator must file a return, pay the withheld taxes, and report  
8 the amount withheld in the time and manner required under G.S. 105-163.6 and G.S. 105-163.7  
9 as if the winnings were wages. The taxes the gaming operator withholds are held in trust for the  
10 Secretary. The gaming operators are:

11           (1) Interactive sports wagering operators licensed under Article 9 of Chapter 18C  
12 of the General Statutes.

13           (2) ADW licensees licensed under Article 10 of Chapter 18C of the General  
14 Statutes."

15           **SECTION 16.(b)** This section becomes effective July 1, 2026, and applies to  
16 winnings paid on or after that date.
