

## HOUSE BILL 73: Temporarily Defer ABC Permit Renewal Fees.

OVERVIEW: The Proposed Committee Substitute (PCS) to House Bill 73 would (i) delay the payment of renewal and registration fees for certain ABC permits that are active as of April 30, 2021 for the period of May 1, 2021 through until September 1, 2021; (ii) allow someone who has prepaid those fees to request a refund, which must be repaid by September 1, 2021; and (iii) delay the requirement to pay or repay deferred ABC permit fees for the 2020-21 permit year for permittees who were subject to an order of closure pursuant to Executive Order No. 141 until September 1, 2021.

The amendment differs from the Second Edition by deferring payment of the permit fees covered in the bill until September 1, 2021, rather than fully waiving payment of the fees.

**BACKGROUND:** On February 25, 2021, the Governor signed House Bill 4 (S.L. 2020-2), which clarified that certain ABC permittees who were subject to an order of closure in the Governor's Executive Order 141 would not have to pay any permit fees until 90 days after the Governor signed an executive order rescinding limitations on those permittees' operation, could seek refunds for any fees already paid, and would retain active permits without payment of the fee.

**CURRENT LAW:** Generally, ABC permits are valid after the payment of an annual renewal or registration fee for one year from the period of May 1 to April 30. (G.S. 18B-903)

**BILL ANALYSIS:** Sections 1 and 2 of the PCS would delay the payment of certain ABC permits that are active as of April 30, 2021 for the period of May 1, 2021 until September 1, 2021, and would also allow anyone who has already paid a fee for a listed permit to request a refund from the ABC Commission, which must be repaid by September 1, 2021. The amendment would apply to the following ABC permits:

- On-premises malt beverage permit
- On-premises unfortified wine permit
- On-premises fortified wine permit
- Mixed beverages permit
- Culinary permit
- Mixed beverages catering permit
- Guest room cabinet permit
- Wine tasting permit
- Wine shop permit
- Malt beverage tasting permit

- Spirituous liquor tasting permit
- Antique spirituous liquor permit
- Common area entertainment permit

Sections 3 and 4 of the PCS would provide that a permittee who is entitled to an ABC permit fee deferment or refund of an ABC permit fee already paid for the 2020-21 permit year pursuant to House Bill 4 is not required to pay or repay the permit fee until September 1, 2021.

**EFFECTIVE DATE:** This act would be effective when it becomes law.
