



# SENATE BILL 194: Re-Stagger Terms/Aldermen/N.Topsail Beach.

**OVERVIEW:** *Senate Bill 194 would reestablish the staggered terms for members serving on the Board of Aldermen in the Town of North Topsail Beach.*

**CURRENT LAW:** The Town of North Topsail Beach, located in Onslow County, was incorporated in 1989 by S.L. 1989-100 and after a referendum. The Town utilizes the council-manager form of government and the Town council consists of six members – five members of the Board of Aldermen and a mayor. The mayor serves a two-year term and the Aldermen serve staggered four-year terms.

To establish the staggering of the five members of the Board of Aldermen, at the first regular municipal election held in 1989, the three candidates who received the highest number of votes were elected to serve four-year terms and the two candidates who received the next highest number of votes were elected to serve two-year terms. Since that time, the Aldermen have been elected to serve staggered four-year terms.

In the 2017 municipal election, three Aldermen and the mayor were elected to serve four and two-year terms, respectively. In the 2019 municipal election, two Aldermen and the mayor were elected to serve four and two-year terms, respectively. Since the 2019 municipal election, the two Aldermen elected in that election have resigned, with one to take the mayorship.

In North Topsail Beach, G.S. 160A-63 governs the filling of vacancies in elected office. The individuals appointed to fill those two vacancies created by resignations would serve until the 2021 election, at which time an election would be held to fill the vacancy for the unexpired term (i.e. until 2023). Due to the vacancy election, all five members of the Board of Aldermen would be up for election in 2021, with three running for a four-year term and two running for a two-year term.

**BILL ANALYSIS:** Senate Bill 194 would amend the Charter for the Town of North Topsail Beach to stagger terms of the members of the Board of Aldermen. Under the terms of the bill, for the regular municipal election occurring in 2021, the three candidates who receive the highest number of votes will be elected to serve four-year terms and the two candidates who receive the next highest number of votes will be elected to serve two-year terms. Then, in 2023 and every four years after, two members will be elected to serve four-year terms. Then, in 2025, and every four years after, three members will be elected to serve four-year terms.

**EFFECTIVE DATE:** Effective when it becomes law.
